Public Act 103-0542 establishes a five-year training cycle for most mandated trainings required by the School Code beginning with the 2024-25 school year. This is a major change from prior year training requirements and districts have asked for the guidance to be released as early as possible for their planning purposes. This draft guidance document outlines the training requirements for the 2024-25 school year as of June 2024.


