



January 10, 2025 Update No. 1

The first week of legislative session has flown by quickly. We kicked off with Governor Armstrong's inaugural State of the State address on Tuesday afternoon. Clocking in at 35 minutes, the Governor's speech was brief compared to those of his predecessor but included plenty of policy. Most significantly, the governor unveiled his property tax proposal, which would increase the primary residence tax credit from \$500 per year to up to \$1,550 per year for the 2025-27 biennium, putting most homeowners on a path toward zero property taxes within a decade. Overtime, the credits would be paid for entirely by Legacy Fund earnings. The proposal also sets a 3% annual cap on local property tax budgets. The proposal is contained in **HB 1176**, filed yesterday by prime sponsor Rep. Mike Nathe and includes both Majority Leaders and Finance and Taxation committee chairs as co-sponsors. The bill will be heard next week.

Bills are finally starting to roll in at a steady pace. While there are plenty of interesting ideas to go around, most of the bills on our tracking list aren't too terrifying just yet. Buckle in, though, because we have a long way to go. A few of the more 'exciting' (you'll find I use that term pretty loosely) pieces of legislation to hit the hopper this week include reinstating the state's Blue Laws and a resolution to put sports betting on the ballot in November 2026. My current favorite is a bill designating Knife River flint as the North Dakota state rock.

While we've somehow only knocked off two of the allowable 80 constitutional legislative days, we're hearing that legislative leadership has 'done the math,' and expects to be able to move crossover (the deadline for bills to leave their house of origin and a brief two-day recess) up a week on the calendar. It's currently scheduled for February 28, but the new date would be somewhere around February 21. They've applied the same theory to the second period, compounded the interest, and have a goal of adjourning Sine Die sometime in mid-April. Limiting floor sessions and a new rule allowing bills with unanimous committee recommendations to pass or die on the floor via a single consent voice vote (bypassing debate and individual votes) may give them the speed they need to accomplish such a feat. I'm not an odds maker, but I'm not booking a vacation for the last week of April.

UPDATES FROM ICBND'S PRIORITY TRACKING LIST

The first week didn't have too many hearings of interest to ICBND, and we spent most of our time reviewing recently introduced bills. Our work will pick up next week as a few of the bills on our tracking list start to have hearings scheduled. Notably, the Universal Commercial Code update bills, **SB 2123**,

SB 2127, and **SB 2122** have all been scheduled for next week. In addition, legislators seem to be taking a shine to precious metals and digital assets this session: two bills on that topic – **HB 1184** and HCR **3001** have hearings scheduled for Tuesday. Finally, a bill that would allow DFI to create a data security program (**HB 1127**) will be heard Tuesday afternoon. Here's what we were up to this week:

HB 1080

HB 1080 updates the appraisal management company section of Century Code to better align with federal statutes. Most notably, it defines federally regulated appraisal management companies in order to clarify their exemption from state regulation. We're comfortable with the changes contained within the bill, but tracking it to ensure it doesn't become something else. It was brought at the request of the ND Real Estate Appraiser Qualifications and Ethics Board, and a representative of the board was the only person to testify on the bill (in favor). It received a unanimous do pass recommendation immediately following the hearing and was placed on the House consent calendar.

SB 2028

SB 2028 would shift DFI's budget to a continuing appropriation process. This means rather than go through the legislative budget process each session, the state banking and credit union boards would approve annual or biennial budgets on an ongoing basis. DFI would be required to document revenues and expenditures as required by the Office of Management and Budget and provide biennial reports to the Legislature. Commission Kruse, the North Dakota Bankers Association, and the Dakota Credit Union Association testified in support of the bill. ICBND attended the hearing but did not take a position. We'll continue to track it for now.
