**Penelope "Penny" Proctor Ziegler, M.D.** is a semi-retired addiction psychiatrist who is Medical Director Emerita of Florida's

Professionals Resource Network (PRN). She is also the former executive director of IDAA. She has been medical director of three state physician health programs, and medical director of several addiction treatment programs. She is certified by the American Board of Psychiatry and Neurology in general and addiction psychiatry, and in addiction medicine by the American Board of Addiction Medicine. She is a Distinguished Life Fellow of the American Psychiatric Association.

Dr. Malini Madanahalli, originally from Bangalore, India, graduated from

Medical College Bellary before moving to the U.S. in 1993 to pursue a medical career as a Foreign Medical Graduate. After completing her Internal Medicine residency in Youngstown, Ohio, she developed a strong interest in caring for older adults. She moved to the Bay Area, California, in 1999 and began working at the Veterans Administration in Menlo Park, which inspired her to complete a Geriatrics fellowship through the Stanford-VA program. Since then, she has served the elderly in various roles, including at Santa Clara Valley Medical Center and, since 2020, at PAMF Geriatrics, where she focuses on consultative care and skilled nursing facility transitions. Dr. Madanahalli is Board Certified in both Internal Medicine and Geriatrics and is a member of the American Geriatrics Society.


