RESTAURANT MANAGER OF THE YEAR: (5 UNITS OR MORE)

This award recognizes a top-of-class restaurant management employee in all areas of the role, including a stellar report with guests, staff, and the community. Nominate a manager that has exemplary operational performance, terrific customer service, and a person that goes beyond typical job duties.

NOMINEE MUST WORK FOR A RESTAURANT GROUP THAT HAS FIVE (5) UNITS OR MORE.

RESTAURANT MANAGER OF THE YEAR: (4 UNITS OR LESS)

This award recognizes a top-of-class restaurant management employee in all areas of the role, including a stellar report with guests, staff, and the community. Nominate a manager that has exemplary operational performance, terrific customer service, and a person that goes beyond typical job duties.

NOMINEE MUST WORK FOR A RESTAURANT GROUP THAT HAS FOUR (4) UNITS OR LESS.

RESTAURANT HEART OF THE HOUSE AWARD

This award recognizes chefs, sous chefs, or line cooks who apply creativity and innovative techniques to their exploration of regional, national, and international cuisine to the delight of guests. It recognizes exemplary performance and exceptional service by an employee in a non-management position who does not have regular customer contact. Nominate a member of the kitchen team that goes beyond the call of duty.

RESTAURANT FRONT OF THE HOUSE AWARD

This award recognizes exemplary performance and exceptional service by an employee in a non-management position who has regular customer contact. For example: hosts, servers, bartenders, and positions who are guest facing. Nominate a member of the front of the house that goes beyond the call of duty.

LODGING MANAGER OF THE YEAR (MORE THAN 100 ROOMS)

The finest hoteliers see the big picture while also looking after all the small details that make their vision a reality. These individuals have risen through the ranks and come to exemplify all the best attributes of our industry. LODGING HEART OF THE HOUSE AWARD

For example: front desk agents, housekeeping, maintenance technicians, and guest relations employees. Nominate an employee in a non-management position who leads by example and is always willing to go above and beyond.

LODGING FRONT OF HOUSE AWARD

This award recognizes exemplary performance and exceptional service by an employee in a non-management position who has regular customer contact. For example, front desk agents, bellmen, guest relations and positions who are guest facing. Nominate a member of the front of the house that goes beyond the call of duty.

CATEGORIES:

EVENT PLANNER OF THE YEAR

This award recognizes an exemplary event planner in either the restaurant or lodging industry. Nominate an event planner that goes above and beyond their job description to ensure the client has the best experience possible.

RISING STAR AWARD

Show your appreciation for an emerging leader in the hospitality industry; one who demonstrates ongoing exceptional growth in the culinary or hospitality industry fields; this person displays notable industry involvement and strong leadership potential.

NOMINEE MUST BE WORKING IN THE INDUSTRY FOR LESS THAN 3 YEARS.

HOSPITALITY SUPPORTING ROLE OF THE YEAR

This award recognizes the employees behind the scenes who go above and beyond to support the restaurants. Such as HR, IT, Accounting, Facilities, Marketing, etc.

STARS OF THE INDUSTRY FREQUENTLY ASKED QUESTIONS

WHAT IS STARS OF THE INDUSTRY?

Stars of the Industry is an annual Indiana Restaurant and Lodging Association (INRLA) event to celebrate our members throughout Indiana and recognize the people who are going above and beyond in their role.

IS THIS JUST FOR CENTRAL INDIANA MEMBERS?

No! We recognize all of our members throughout the state. Please nominate any team members working in Indiana that you feel are deserving and join us in Indy for the event!

HOW MANY PEOPLE CAN I NOMINATE?

There is no limit on the number of employees you can nominate from your business or a limit on number of categories you can nominate for. Please recognize any staff you feel is deserving. You can also nominate multiple employees for the same category.

WHY ARE SOME CATEGORIES SEPARATED BY SIZE OR INDUSTRY?

Qur goal is to make sure that businesses aren't self-limiting their nominations and that there is an even playing field for smaller business versus larger ownership groups. Some awards are specific to industry so that we can allow more recognition.

WHAT TIME IS THE EVENT? WILL THERE BE FOOD AND DRINKS?

We will have a cocktail hour at 5:30, with the program starting at 6:30pm. Dinner is included with your ticket, as well as access to our open bar.

WHAT IS THE DRESS CODE FOR STARS OF THE INDUSTRY?

The dress code is business/cocktail attire. We know some attendees will be coming from work, and others want to take the chance to dress up. The most important thing to us is that you are comfortable and enjoy the night.

HOW DOES JUDGING WORK?

Nominations are reviewed by a committee made up of INRLA Board Members, sponsors, and allied partners. Each committee member selects who they think is the winner of the category. We use a blind judging process, so we take out any distinguishing information about the person and the company from the nominations before they are reviewed.
