Teaching Statement:

I have made a number of significant teaching contributions in my career to date. (While my appointment is now 100% in Sociology/Arts, for a long period of time I had a joint appointment between Arts and Forestry. Thus I will also mention some of my teaching contributions in Forestry.) Besides successfully teaching an unusually wide diversity of undergraduate and graduate classes, and supervising graduate students, I have made significant contributions to teaching in four ways: 1) through work with graduate programs, 2) through work on sustainability issues, 3) through the development of pedagogical materials and 4) through the development of new courses.

In the Faculty of Arts, I have served as the Chair of the Environment and Society Minor since 2016. In Sociology I served for three years as the Chair of the Graduate Studies program, where I worked on improving the quality of our program especially through strategies to improve recruitment of new high quality graduate students, strengthening evaluation procedures, and improving funding arrangements. In my work as Grad Chair, I helped to coordinate various activities such as awards, evaluations, admissions, chair/organize exams, and various daily tasks such as responding to student inquiries, corresponding with the Faculty of Graduate Studies, etc. For several years the Faculty of Forestry ran a pilot grad program in "Forests and Society" which I coordinated. (The faculty has since decided to develop a couple of professional Masters programs, which in part, draw upon this earlier experience.) I have been a very successful in graduate supervision. For example, two of my recent Ph.D. students (Joanna Robinson, and Mark Stoddart) have completed dissertations on sustainability issues, and successfully obtained significant academic positions. Joanna Robinson's dissertation was nominated for several awards, and a revised version has been recently published with MIT Press, Contested Water: The Struggle Against Water Privatization in the United States and Canada. Dr. Robinson is now a Full Professor at Glendon College, York University. Previously, Joanna was a SSHRC postdoctoral fellow at the University of California, Berkeley. Mark Stoddart's dissertation, on ecological and sustainability issues related to the ski industry, was published as a book by UBC Press, entitled: Making Meaning out of Mountains: The Political Ecology of Skiing. Dr. Stoddart is now a Full Professor at Memorial University of Newfoundland. Previously he was a Killam Postdoctoral fellow at Dalhousie University.

I have done substantial work in the sustainability area. I have twice been named a UBC University Sustainability Initiative Teaching Fellow. I have taught a variety of courses in the area of sustainability including in Arts, and in Forestry. In 2015, a proposal I wrote was accepted (from a very competitive pool), and I was given the opportunity to teach a newly developed course entitled "ASTU 204A: An Introduction to the Sociology of Climate Change" at the Reims campus of Sciences Po, in France. This course was taught to students (at the end of their first year) who are part of the dual degree program between UBC and Sciences Po. I have since taught a 4th year sociology version of this course several times. I have developed a number of other new courses related to sustainability, including: "FRST 470: Forests and Society", "CONS 370: Perspectives on First Nations and Forests Lands", "FRST 528:Social Research Methods for Forests and Society", and "WMST 425M: 425M:Gender, Technology, and the Natural Environment". I also teach: "SOCI 360: Sociology and Natural Resources". Additionally I taught a module in the Conservation Program's field school, and contributed to another graduate course that had a field component. Further, I have been involved in a great number of graduate committees, for students working on sustainability topics. And I have also served on a number of administrative committees for programs related to sustainability.

I have also been quite involved editing and developing pedagogical materials. In 2008 I produced a refereed edited volume published by the American Sociological Association: Tindall, D.B. and Todd E. Malinick. 2008. Editors. *Teaching about Social Networks. A Collection of Syllabi, Assignments, and Other Resources*. Washington, D.C.: American Sociological Association. 251 pages. As a separate project, I developed a website that provided examples of social network survey instruments: http://socialnetworks.soci.ubc.ca/SocNets/Home/Home.html Also for the past several years, I have been the Digital library Area Editor for teaching and learning materials related to 'Social Networks' and 'Microcomputing' for the American Sociological Association.

Above, I have mentioned some of the new courses I have developed in the area of sustainability. I have also developed some new courses (new to UBC) in methods, in particular, I semi-regularly teach a graduate course in Social Networks (under the number SOCI 599a), and I previously taught a new graduate course in Social Statistics (under the number of SOCI 508 at the time).

In terms of other contributions, I have served on over twenty graduate student committees. On interdisciplinary committees, in particular, I normally serve the role of the "methodology specialist", or the "social science specialist". I have published with the following students: Mark Stoddart, Joanna, Robinson, Todd Malinick, Céline Mauboulès, Aaron Doyle, Kerri Lynn Bates, and Noreen Begoray, Gabriela Pechlaner, Erin Seldat, Pamela Perreault, Holly Spiro, Howie Harshaw, Georgia Piggot, Tracy Groenewegen. I have served on a dozen comprehensive exam committees. I have also supervised or co-supervised over twenty graduating theses/essays in the Faculty of Forestry.

Programs of Research:

While at U.B.C. I have developed 2 main, partly interrelated, programs of research which fall under the following headings:

- 1. Social Networks and Micro-mobilization for Collective Action.
- 2. Climate Change Policy and Discourse Networks.

These research programs have been funded by numerous Social Science and Humanities Research Council of Canada research grants, by a Forest Renewal British Columbia research grant, several Hampton Grants, and by a Sustainable Forest Management Network Research Grant.

RESEARCH STATEMENT:

My research program focuses on contention over environmental issues, crosscutting the areas of environmental sociology, social movements, and social network analysis. I have authored/co-authored six articles (including an essay) that have been published in *Social Networks*, which is the top journal in the field of social network research. (A Q1 journal in both Sociology and in Anthropology; see ISI Web of Knowledge Journal Citation Reports.) I have also published in top environmental, social movement journals, and general sociology journals.

My scholarly contributions have centered on investigating the links between social networks and social movement processes with regard to environmental movements, and environmentalism. I have examined a number of different aspects of this scholarly topic. My recent research has focused on the sociology of climate change. I have conducted over a dozen surveys, as well as a number of other types of empirical investigations. By Canadian sociology standards I have been extremely successful in terms of obtaining competitive peer reviewed research grants (primarily through SSHRC), which I have utilized to support my empirical research program and support graduate students.

A central line of research has examined ongoing participation in the environmental movement, and the role that networks play in shaping identification with the movement, and participation in the movement (Tindall 2003, 2005; Tindall, Robinson, and Stoddart 2014; Tindall and Robinson 2015, Tindall and Robinson 2017). This work has also looked at intervening processes, such as the role that networks play in communication about movement issues, and the targeting of individuals for recruitment in movement events. A book chapter explores the empirical consequences of using social networks to theoretically define who in a member of a social movement (Tindall and Robinson 2015). I am one of the few scholars who has examined the relationship of networks to social movement participation by collecting, and analyzing longitudinal panel data (Tindall 2005). (I have collected three wave of panel data on participants in the wilderness preservation movement). I am continuing work with these data using SIENA, and mixed methods analyses.

I am one of the few scholars who has examined network ties as an outcome of social movement activities. In one study (Tindall, Cormier and Diani 2012) we found that people who are more active, develop greater network social capital (diversity of ties to people in different occupations) outside of the movement. I have also examined the relationship of network ties, and outcomes in terms of environmental attitudes and opinions. In one study (Tindall, Harshaw, and Taylor 2011) we found that members of the general public were less satisfied with forest management in B.C. if they have ties with a member of an ENGO (controlling for ego's ENGO membership status). In another (Tindall, Sheppard, and Harshaw 2010) we found that members of the general public were more supportive of decision making in forestry if they had ties to alters who work in forestry, controlling for ego's occupation. We (Tindall and Piggot 2015) published an article in *Nature Climate Change* (the top article in Environmental Studies, and ranked second in Environmental Sciences) which draws upon data I collected through two national wide surveys. It shows that members of the general public who have a tie to a member of an ENGO (but who do not themselves belong to an ENGO) are more likely to have a plan for dealing with climate change. I have also examined the role that social network centrality plays in affecting the likelihood that one will be cited in media coverage of environmental issues (Malinick, Tindall, and Diani 2013).

The core of my research program on networks and environmentalism has been quantitative, but in recent years, I have collaborated on qualitative and mixed methods research. We have connected network analysis to qualitative analysis in two distinct ways: 1) we have qualitatively analyzed social network data, and 2) we have used network analysis as a research tool to analyze discourse. In these veins, I have collaborated with my former PhD student Mark Stoddart on a number of qualitative analysis publications, examining data from my projects on the environmental movement (Stoddart and Tindall 2010a, 2010b, Stoddart and Tindall 2011). Several papers examine feminism and environmentalism. We have also used discourse network analysis to examine the views of environmental organization members concerning climate change policy options (Stoddart, Tindall and Greenfield 2012). A further piece examines the relationship between networks and environmental movement participation from a qualitative perspective (Stoddart and Tindall 2010a). We have a number of publications from our joint projects on climate change policy (Stoddart and Tindall 2015, Stoddart, Haluza-Delay and Tindall 2016; Stoddart, Smith, and Tindall 2017). Additionally, we have a piece from Stoddart's empirical research (Stoddart, Ramos and Tindall 2014) on ecotourism.

I have also made a number of significant contributions on other related topics. I have written several articles on gender and environmentalism, and related issues such as social capital (Tindall and Cormier 2008) including a well cited article in *Society and Natural Resources* (Tindall et al. 2003; 366 cites). I have co-authored several articles on personal networks, including one that is very well cited (Wellman, Yuk-lin, Tindall, and Nazer 1997; 430 cites) that I conducted the initial analysis for, wrote for the first draft of, and presented at several conferences prior to publication. Another line of my investigation has involved media coverage of environmental topics, including environmental protest about forestry, and about climate change issues (see Cormier and Tindall 2005, Malinick, Tindall and Diani 2013, as well as Stoddart et al. 2015, 2016, 2017).

I have also done significant work in the area of Aboriginal peoples and environmental issues. I am the lead and principal editor (contributing about 85% of the editorial work) for a book on Aboriginals and forestry issues in Canada (Tindall, Trosper, and Perreault 2013). As part of this book I co-authored four chapters, including one chapter exploring co-management, and another examining joint-ventures. I have co-authored an article in *Local Environment* on the potential for an environmental justice movements based on Aboriginal rights (Robinson, Tindall, Seldat, and Pechlaner 2007), and have made other writing contributions in the area.

I have also written a number of review pieces in high profiles journals (e.g. Tindall and Wellman 2001; 190 cites), books (e.g., Tindall, Robinson, and Stoddart 2015), handbooks (e.g., Tindall 2015), and encyclopedias (e.g., Tindall and Malinick 2007).

Statement Regarding Service to the University and Community:

I will briefly describe my service work at UBC, and to the community. My major service contribution to the university has been through my work in graduate studies (I was the Chair of the Sociology Graduate Studies Committee for three years.), and my service to the Environment and Society Minor in the Faculty of Arts (I have been Chair since 2016). I described some of the activities this entailed earlier in my teaching statement. On the research service side, I have also led the UBC Big Data and Computational Social Science Research Cluster.

During my time at U.B.C. I have been involved in a number of different programs at the undergraduate level. I have taught in the Natural Resources Conservation, Forest Resources Management (BSF), Sociology, and Women's Studies programs. In addition to teaching in these programs, I have provided service contributions of various kinds for these programs. I was involved in the First Nations program in the Faculty of Forestry (in various capacities), the Advisory Committee for the Natural Resources Conservation Program, and have been on the Advisory Committee for the Environmental Studies Program. During my earlier joint appointment with the Faculty of Forestry, another notable contribution is that I was a member of the BSF Program Review Committee. As described earlier, I conducted survey research and wrote a report as part of my activities on this committee. (I also published an article on based on this work, Tindall 2001.) In addition to work related to revising the BSF curriculum, I was very active on the Committee that revised the Natural Resources Conservation Program. I have also been on several hiring committees, including in the role of chair.

In terms of the wider community I have provided contribution in a variety of different ways. I am a "Climate Leader" for the Climate Reality Project Canada. I was one of 115 Canadians were nominated to take part in a formal training offered by the Al Gore, former Vice-President of the United States, and Nobel Prize Laureate. This training took place in San Francisco, California, in August 2012. I have been giving talks to the public about climate change, and what individuals and organizations can do to respond to it. I regularly give between 6 and 12 talks a year to various public groups, including high schools, voluntary organizations, businesses, and other institutions (such as retirement homes). While I am not a climate (natural) scientist, this work complements my knowledge as an environmental sociologist, some of the skills I have as a professor, and my work on social aspects of climate change.

I have been interested for some while in "public sociology" and "public scholarship" more generally. In this regard, I have I have written for more general audiences on issues related to my expertise. I have published a number of op-eds in the *Vancouver Sun, the Globe and Mail, the National Post,* and elsewhere (including a number of pieces in *The Conversation*) on topics such as social and political aspects of climate change, the Truth and Reconciliation Commission, the 20th Anniversary of the Clayoquot Sound protests, the Fairy Creek protests, and Greta Thunberg. I have also written several published letters to the editor regarding social, political, and environmental issues. I wrote a number of pieces in various outlets for the UNFCCC COP meetings on climate change in Paris in December 2015. Based on social media indicators (tweets, shares, likes), and upon direct feedback (e.g., via e-mail) several of the pieces I have written have received wide-spread attention (e.g., one piece had over 3,000 shares).

In terms of outreach and community liaison endeavours, I have been a very active member of the UBC-CCPA SSHRC CURA research project on Climate Justice, and have been involved in a variety of activities interacting with community partners. (CCPA is the Canadian Centre for Policy Alternatives.) This work also links to my interests in public sociology, and my expertise on the sociology of climate change.

In terms of editorial work, I have also been quite involved editing pedagogical materials. (I described some of these in my teaching statement.) For several years, I was the Digital library Area Editor for teaching and learning materials related to 'Social Networks' and 'Microcomputing' for the American Sociological Association.

I have done quite a lot of reviewing for journals, and routinely receive (and complete) requests from the top general journals in my discipline, in specialty journals related to my expertise, and for journals outside my discipline where I have expertise. Many of these are listed on my CV. have also been a reviewer for a variety of granting agencies, and book publishers.

In terms of professional service, I have been also been active in organizing conference sessions, and also in serving as a discussant at conferences. I have been most active in terms of organizing sessions for the Annual Meetings of the International Network for Social Network Analysis (on "Collective Action and Social Movements" with Mario Diani), but I have also done organizing for the Canadian Sociology Association (with Mark Stoddart on "the Sociology of Climate Change"), the American Sociological Association, and the International Sociology Association.

One of the most important service activities I have been engaged in, has been closely related to my research -- namely, the writing of a number of extension reports. I have written and distributed a variety of reports for the NGOs and individuals who participate in my research. I have produced over twenty of these reports, for both individual participants in my research, and for ENGOs who have been involved in the research. Details and examples are available upon request.
