Statement of Scientific Interest:

I am a dedicated researcher and teacher with a passion for unravelling processes at the intersection of networks, diversity, and inequality. My work delves into understanding how social networks contribute to the formation of (in)equality and cohesion within various contexts. I study how groups with different social identities have access to, and benefit from the networks they are part of. I am particularly intrigued by the impact of networks on societal structures and the implications for communities, by studying cohesion and segregation at the macro level. Furthermore, I study the development of negative ties in networks and aim to further our theoretical and empirical understandings of these negative relationships. Additionally, I have a secondary agenda in explaining more generally attitudes towards, and inequalities based on, ethnicity/race, sexuality and gender through a wide variety of methods and data. I mostly use observational (network) data and statistical methods, but I also make use of experiments, register data, and qualitative data.
