

Her SAIS role followed 19 years at NAIS, as assistant director of regulatory affairs and later as general counsel. She has served on several independent school and educational nonprofit boards and co-authored the NAIS Trustee Handbook (10th & 11th editions). Wilson received a BA from Sewanee: The University of the South and a JD from the University of South Carolina.

An educator, administrator, and advancement professional, Weston has directed transformative fundraising initiatives—from \$5 million to over \$100 million—and advised on strategic planning, endowment growth, and donor engagement. His expertise and understanding of independent school values have elevated philanthropic outcomes and advanced institutional missions nationwide.
