Entry Fees: No charge to schools, churches, or non profit organizations.

Personal vehicles; group entries with 5 or less people: **\$30 per vehicle**

Businesses or oversized vehicles; group entries with 6 or more people: **\$40 per vehicle**

Tractor trailers or large trucks over 50,000 pounds: **\$50 (Limit 1 per business) Truck must be parked in designated area by 11 AM or it will not be allowed in the parade.**
