## **Tariffs: Practical Considerations | Gerald Wuetcher**

Water and Sewer utility tariffs offer a unique opportunity for those utilities to structure their relationship with their customers. This presentation highlights various provisions that a water or sewer utility should include as part of a tariff to protect against financial and legal liability as well as avoid common customer disputes. In the first portion of his presentation, the presenter will discuss the statutory and regulatory framework for water and sewer utility tariffs and the process by which a tariff may be revised. The presentation will conclude with some practical suggestions for improving the tariff of a water or sewer utility. Recent PSC decisions on tariff matters will also be discussed.
