SUMMARY OF VACCINE PREVENTABLE DISEASES IN LEE COUNTY, 2015

Jennifer Roth, MSPH, Biological Administrator, Department of Epidemiology, Florida Department of Health – Lee County

1 case of pertussis reported in Lee County in a fully immunized 15 year old.

3 chickenpox cases reported in Lee County, all in children under 12 years old with at least 1 dose of varicella vaccine.

Influenza has been decreasing in Lee County in 2015. It appears as if flu season began earlier in autumn 2014 and peaked in December. Current estimates show that the seasonal flu vaccine is approximately 23% efficacious this year. 3 pediatric deaths from influenza have been reported in Florida this season, none were in Lee County.

5 cases of measles have been identified in travelers to Florida, but no cases have been confirmed in Florida residents. Contact tracing investigations have taken place to alert anyone who may have been exposed. So far in 2015, 102 cases of measles have currently been diagnosed in the United States, most of which are linked to an outbreak involving Disneyland in California.

Summary of Ebola in West Africa

22,487 total cases since outbreak started in early 2014, with 8,979 deaths. The current countries affected are Guinea, Sierra Leone, and Liberia. No cases in Florida. Any person traveling from those areas to Florida is screened and temperature checks are conducted twice daily through active, direct monitoring.

PRESIDENT'S MESSAGE

Expansion of Scope-of-Practice Doesn't Have to be a Four-Letter Word

By the time this goes to press, the Florida's Teaching Hospitals will have already announced the findings from a study highlighting the physician specialist shortages in Florida, and I must admit that as I write this I have not yet seen the study, yet there are some basic facts that will surely be in it... and certainly this won't be news to any of us. More than 85% of physicians currently in the state of Florida are over 40, including me. Florida ranks 42nd of

the 50 states in the number of general medical education positions per 100,000 people and only 19 resident physicians per 100,000 people. Florida needs an additional 3,352 residency positions to meet the national average ratio of residents per population. This is all according to the Association of American Medical Colleges.

As I wait with everyone else to see the results of this new study, I guess I want to share some thoughts. One is that this isn't news to any of us, as we've seen lots of information in the literature over the last several years about the increasing shortage of physicians. It takes money to train doctors, money that's even harder to come by in the recent economic environment. Two, more specifically as a primary care physician; we certainly have seen this shortage coming a long way out. However, we should read this study the same way we read any other study, with a critical eye to who commissioned it, any potential bias in its findings, and how applicable it really is to each of us.

No doubt the study will highlight the very real looming shortage of physicians in the state, both primary care and subspecialty. We have taken very real steps in our own County in our strong support for Lee Memorial Health System's collaboration with FSU (go Noles!) in their development of the FSU family medicine residency program, knowing that graduating residents are more likely to remain in the same area for their careers. However we can't ignore and simply continue to fight our battles against any and all expansions of scope-of-practice. Non-physician health practitioners already play a vital role and are potentially underutilized in many areas.

I fear that the Florida Medical Association, including our own medical society, is already losing the fight against the expansion of scope of practice. Even more importantly, rather than viewing it as a fight, we should be viewing it as an opportunity. Anesthesiologists and nurse anesthetists figured things out years ago. In primary care we have long worked side-by-side with physician assistants and nurse practitioners to our mutual benefit and the benefit of our patients. Many states already allow physician extenders to prescribe schedule II and III medications (not Florida). I certainly would not suggest that an optometrist should be doing retinal surgery, but there is certainly a very large gray area within which non-physician healthcare providers can play an important role...in ALL SPECIALTIES.

One huge point in expanding scope-of-practice is that non-physician providers cost a lot less to train and hire. It would be nice if we could train as many doctors as we need, but as our healthcare dollars become increasingly tight, we have to be open to alternatives. We can't let perfect be the enemy of good. I have worked alongside nurse practitioners and physician assistants, both in the civilian and military worlds, in whom I would place my life.

We need to realize that if we don't get involved in the discussion in a more collaborative way then we will simply be left at the wayside and lose our position at the table. Likewise, if we come to the table too late, we may find no one wants to listen to us either way. To ignore expansion of scope-of-practice in addressing the looming physician shortage in our state would be not only foolhardy but also unconscionable.

THE AFFORDABLE CARE ACT ON TRIAL AGAIN IN KING V. BURWELL

The Affordable Care Act is heading back to the Supreme Court this Spring. The issue presented to the Supreme Court on this occasion is whether the IRS is authorized promulgate regulations to extend tax credit subsidies for coverage purchased through Federal Government's Health Care Exchange.

The Affordable Care Act allows individuals who purchased health coverage through State-established Health Care Exchanges to subsidize a portion of that coverage through the form of refundable tax credits. The United States treasury directly pays each eligible taxpayer to offset the cost of the taxpayer's insurance premium. However, a majority of States (including Florida) have elected not to establish their own Health Care Exchanges. In order to provide coverage to persons in these States, the Federal Government set up its own Health Care Exchange marketplace.

The petitioners argue that, although the plain language of the statute limits the subsidies to only those persons who are able to purchase coverage through a State Exchange, the IRS enacted regulations that grant these subsidies to all Exchanges, including the Federal marketplace used by consumers in States that chose not to create their own Exchanges. The IRS reasoned that the Affordable Care Act was not intended to limit the subsidies to only those consumers in States that chose to establish their own Exchanges. Moreover, the Federal Government argues that the Federal Exchange is actually individual State Exchanges operated by HHS. The Government argues that each one is a state-specific marketplace—plans offering coverage on the Exchange in a particular State must be licensed by that State, and premiums for plans offered on the Exchange are based on rating areas and risk pools unique to the State. However, the petitioners argue that the IRS was not empowered to enact this regulation, and that there should be no subsidies in States that chose not to establish their own Exchanges.

The petitioners argue that employers are also affected by the IRS' decision to extend the subsidies to States that chose not to establish their own Exchanges. The Affordable Care Act assesses financial penalties on

large employers that do not sponsor health insurance coverage to full-time employees. However, the payment is only triggered if at one or more employees enroll in Government-subsidized individual coverage. In a State that chose not to establish an Exchange, the petitioners argue that the plain language of the Act would not allow for an individual to enroll in Government-subsidized individual coverage. Thus, an employer who did not sponsor health insurance would not be subject to a penalty.

In their Petition for a Writ of Certiorari, the individuals challenging the Affordable Care Act assert that the petitioners assert that more clarity is required, because at present "millions of people have no idea if they may rely on the IRS's promise to subsidize their health coverage, or if that money will be clawed back. Employers in 36 States have no idea if they will be penalized under the ACA's employer mandate, or are effectively exempt from it. Insurers have no idea if their customers will pay for health coverage in which they enrolled, or if large numbers will default."

Oral arguments are set before the Supreme Court on March 4, 2015, and a decision will likely be published in June.

THE RAMIREZ REPORT, FEBRUARY 2015

As the new Executive Director, I had the pleasure of accompanying Ann Wilke to the Florida Medical Assocation's Board of Governor Meeting in Palm Beach Gardens, FL. This meeting was held at the PGA National Resort and Spa February 6-8. This conference gave me the opportunity to learn more about the FMA and the people that are in the State of Florida working hard for the good of our physicians.

The first meeting on the agenda was with the Council of Florida Medical Society Executives. This meeting was geared to gathering all of the county medical society execs, like myself, to come up with ideas to better serve our physicians. The State of Florida has 54 members and 10 of us attended the meeting. At the end of this meeting, Ann was presented with a cake and some mementos of her years of service with the CFMSE. Later that night we were privileged to be able to attend dinner at the home of Dr. and Mrs. Alan Pillersdorf, the 2015 FMA President. We are very thankful to Dr. Pillersdorf and his lovely wife for the delicious food and good company.

Having come from a clinical background, the issues presented at the Saturday and Sunday Board of Governor's meetings greatly intrigued me. There were many topics touched on, but I will only mention a few here. It is helpful to be reminded that people, including physicians and medical personnel, thrive on affirmation and praise. To have a good team, everyone needs to be respectful and happy. Happiness as a physician is being threatened by physician burnout. The issues addressed in regards to physician burnout were that there were too many bureaucratic tasks, too many hours, too little income and too much computerization. One final topic that was interesting to me was the law in 2009 that cracked down on pill

mills. Before this law was enacted, Florida was known as the home of the oxycodone express. The law has cut out the pill mills and deaths from overdoses have plummeted. But this change has brought on a new problem. Patients who are legitimately in need of narcotics are having their prescriptions declined to be filled by local pharmacies. This is mostly due two reasons: pharmacies only have a certain allotment to hand out per month and the fear of being so heavily fined keeps them leery of filling prescriptions of such a heavy dosage. A few deaths have occurred with patients that could not handle the severe withdrawl symptoms. It was mentioned that should you have a patient or a physician on a patient's behalf, has problems with not having a legitimate prescription filled, they should contact the Florida Board of Pharmacy with the Department of Health. FLORIDA ABOVE AVERAGE ON VACCINATIONS

The News-Press, February 8, 2015

While presidential candidates bicker over whether vaccines should be mandatory, Floridians have done a good job immunizing their kids.

About 93.4 percent of pre-school children in the Sunshine State have received the measles, mumps, rubella (MMR) vaccine, according to an analysis released this week by the Trust for America's Health.

That places Florida 14th nationally. New Hampshire leads the nation at 96.3 percent while West Virginia comes in last at 86 percent.

The debate has been fueled by recent statements from two likely GOP presidential nominees – New Jersey Gov. Chris Christie and Kentucky Sen. Rand Paul – who said parents should have discretion over whether to have their kids inoculated.

HOW TO BECOME A KEY CONTACT

A Key Contact is a physician or an Alliance member who agrees to represent physicians and patients to our local representatives. They are encouraged to get to know our representatives and to keep them and their staff informed of issues that are affecting medicine.

As a Key Contact you are also a member of the Lee County Medical Society Legislative Committee. Key Contacts are invited to all Legislative Committee meetings and to meet with Senators and Representatives to discuss important issues to our Medical Community. They also are involved in campaign fundraising to support candidates friendly to medicine. The Lee County Medical Society feels that this is a very important way for the Medical Society to influence legislative decisions that affect physicians and their practices.

HOW TO WRITE YOUR LEGISLATOR

- 1. Know your legislators' district(s) and the correct spelling of their names. Refer to district maps and directories.

- 3. Write on personal stationary, LCMS letterhead, or on plain paper. A personal letter is best! Your return address should be on the letter, not just the envelope. This will enable your legislator to reply.
- 4. Do not use postcards or form letters except when advised to do so by the FMA legislative Affairs Office or the CMS Legislative Committee
- 5. A good rule to follow is one subject per letter. Try to keep your letter to one page no matter how important the
- 6. issue. This gives your letter more impact and makes a reply easier. It also takes up less the staff's and legislator's time
- 6. Make clear the position of the issue you are on, and ask the legislator to support your position.
- 7. Refer to exact bill numbers if available and short or popular titles.
- 8. Don't threaten or write in a belligerent tone.
- 9. Don't remind them of broken promises
- 10. Don't write so often that your letters lose their impact.
- 11. Illustrate your position with a local example.
- 12. Sign your name legibly and type your name under your signature.

SARPA - (SENIOR AND RETIRED PHYSICIANS ASSOCIATION)

The Senior and Retired Physicians Association of Lee County came into being in 1997 with eighteen charter members. It has since expanded by word of mouth recruiting to about seventy five. Originally intended as an unofficial arm of the Lee County Medical Society, SARPA's membership voted to be independent in order to keep the costs down. Nevertheless, we have retained close ties to the Society with a presence at times on its Legislative Committee and an open invitation for SARPA members to attend all regular LCMS meetings for the cost of the meal.

SARPA is fundamentally a social organization. Physician, dentist, and medical scientist members and their spouses gather monthly (November-April) to meet new friends and get reacquainted with old ones. Meetings are primarily held at the Forest Country Club and feature excellent meals and programs of general interest. As a rule, technical medical subjects are not included in our programs. Past subjects have included medical updates by James Nathan, CEO of Lee Memorial Health System and an Honorary Member of our organization; an address by the President of Florida Gulf Coast University; talks by local authors, such as Robert Macomber; talks by the former head of Desilu Studios, a maritime historian, a local archeologist; tours of Children's Hospital; and evenings on the dinner theatre train and at the Royal Palm Dinner theatre. Our Program Committee is currently planning interesting programs for next season. Members are notified as these are confirmed. Our average meeting attendance ranges from approximately fifty to eighty persons.

While our mission is predominately social, over the years we have had Public Affairs and Outreach Committees which have been active in the community. We have co-sponsored a health fair in Bonita Springs and established a program for volunteer members to provide assistance to case managers and administrators at LMHS hospitals. SARPA has also been active in working to allow physicians with active out-of-state licenses to volunteer their services pro-bono for the medically disadvantaged in Lee County. Several members' spouses volunteer regularly at Health Park, and all of us are emissaries for Lee Memorial Health Systems, which has generously sponsored SARPA from its beginning.

Membership dues are \$40.00 per year. Doctors and their spouses are both considered full members with payment of single dues per household. We "pay as we go" for our meal functions and meetings. A spouse who becomes widowed remains a full member without paying dues.

Other medical advisors include a board member who is a retired OB/GYN and the Executive Director who is a registered nurse with obstetric and NICU clinical experience.

All care provided is in compliance with applicable laws and regulations. Policies are in place to protect the client and assure that care delivered is within acceptable standards of care. Verity operates under HIPAA to protect privacy and assure accurate, adequate keeping of medical records. We work with local clinics and providers to share records when the client has provided written permission to do so.

THE FLORIDA HOUSE HAS PROPOSED A MASSIVE SCOPE OF PRACTICE EXPANSION BILL AND WE NEED YOUR HELP!

Oppose Scope of Practice Expansion – CS/CS/HB 7113

- CS/CS/HB 7113 rolls several harmful provisions into one bill.
- ARNP Independent Practice. This legislation would expand the scope of practice for advanced practice nurses by allowing them to diagnose and treat virtually any medical condition, without any physician oversight. ARNPs are an important part of the medical team, but allowing them to practice without any physician supervision is unjustified and would pose serious dangers for Floridians seeking health care.
- Controlled Substance Prescribing. This legislation will allow ARNPs to administer, dispense, and prescribe medicinal drugs INCLUDING CONTROLLED SUBSTANCES & NARCOTICS. Since 2011, the Legislature has made great strides in combating the pill mill epidemic related to abuse and over-dispensing of narcotics. The proposed legislation would allow approximately 10,000 additional people statewide the authority to prescribe narcotics. This vast expanse in access to narcotics would potentially undo the progress the Legislature has made in fixing the narcotic abuse epidemic.
- Telemedicine. This legislation would allow physicians and numerous other health care practitioners to practice telemedicine/telehealth in Florida without having to obtain a Florida license. Telemedicine can be employed effectively in Florida, but there is no reason to remove the protection for Florida patients that licensure brings.

Tell them there is no evidence that such a broad based expansion will reduce costs to the healthcare system. Let them know that nurses play an important role in your practice; however allowing them to practice independently is unnecessary and unsafe.


