Office of Special Education & Rehabilitative Services (OSERS) Resources

- OSEP releases a new <u>OSEP Fast Facts: Children Identified with Autism</u>, which takes an updated look at our data on children whose primary disability is autism. We revised and updated our very first (and one of our most popular).
 - Highlights from 2024 OSEP Fast Fact: Children Identified with Autism
 - In SY 2022-23, the percentage of students with disabilities identified with autism is 12.81%. States report a range from 5.76% to 17.28% of students with disabilities identified with autism.
 - In SY 2021-22, Students with disabilities identified with autism were less likely to be subject to a disciplinary removal than all students with disabilities.
 - In SY 2022-23, States/entities and LEAs were more like to identify males with autism than females when compared to all students with disabilities.
 - In SY 2021-22, students identified with autism, ages 14-21, exiting school were less likely to drop out and more likely to receive a certificate than all students with disabilities.
 - In SY 2022-23, States/entities and LEAs are more likely to identify Asian students with autism when compared to all students with disabilities.
 - In SY 2022-23, students identified with autism were less likely to be served inside the regular class 80% or more of the day than all students with disabilities.

- Announce Intermediate School Districts (ISD)
 who will be part of Cohort #1.
- Share Student Record Review (SRR), Interview Questions, and Parent Focus Group description.
- Share dates ISDs will be monitored.
- Memo sent to all ISD directors.

LRE Monitoring Process

- MDE OSE convenes virtual meeting with all ISDs in Cohort #1.
- Monitoring visits occur throughout the 2024-2025 school year.
- Selection of records will be determined using an MDE OSE sample selection protocol.
- General Education and Special Education staff will be interviewed.
- Interviews and the Parent Focus Group will be held in person.

Correction

- Corrective Action to be completed within one year.
- Student Level Corrective Action to be completed within 30 school days.
- Five-year improvement plan supported by an MDE OSE Technical Assistance staff member assigned to Cohort #1.
