- A. 75% Attendance Letter
  - MAASE joined other education associations in support of the elimination of 75% attendance minimum.
- B. Education Associations Partner on Critical Shortage
  - Associations and MDE meet weekly to align organization initiatives in this area. Additionally, the 94d special education shortage task force is getting off the ground.
- C. MASSP Partnership in Addressing Considerations for Students with Disabilities in Virtual Learning
  - MASSP worked with MDE to share options for distance and remote learning. MAASE members supported the work by partnering on a supplemental resource.
- D. SEILN Critical Shortage Workgroup
