WHAT's NEW?

Accountability/State Assessments

- The 2012-2013 MARSE rule set, 2012-106 ED, has completed the rule promulgation process and has been enacted.
 - The new MARSE took effect September 26, 2013. The up to date MARSE is available at the Office of Regulatory Reform website. The OSE will be updating its websites, documents, and resources as soon as possible and sending out notifications as these updates are completed.

Data Collection

- The annual data memo, which provides information on new data collection characteristics, changes to characteristics and common data reporting problems was released September 30.
- One new characteristic is the Date of Initial IEP. When reporting this date, it is the date that a new IEP has been completed AND offer of FAPE is made.
- Upcoming Deadlines:
 - October 25: Educational Assessment and Accountability (EAA) "As of" date for fall assessments
 - November 6: Fall 2013 General Collection submission deadline
 - November 13: Fall 2013 General Collection certification deadline and Early Childhood Fall 2013 Collection certification deadline

Monitoring

- August 15, 2013 Workbook
 - Eight hundred and forty-three locals have acknowledged their reports.
 - Eight locals have still not acknowledged their reports.
- Fall Monitoring Cycle
 - Thirty-eight school districts will participate in an on-site monitoring visit with a total of 42 monitoring activities including Significant Disproportionality – Identification, Significant Disproportionality – Discipline, Indicator 9, Indicator 10, and General Supervision Monitoring.
 - Seven school districts will participate in a desk audit for Significant Disproportionality – Discipline or Indicator 10.

- The first on-site visit was September 16, 2013. The last on-site visit is scheduled for October 24 through October 25, 2013.
- Desk audits will also be completed by October 25, 2013.
- The OSE Monitoring and Technical Assistance Team has conducted the following in preparation for and in assisting implementation of the Fall 2013 Monitoring:
 - August 20, 2013 New CIMS Coordinator Webinar This training for local CIMS Coordinators was held in the morning.
 - August 20, 2013 Local Webinar for all local CIMS Coordinators This training for new and returning local CIMS Coordinators was held in the afternoon.
 - September 11, 2013 Focused Monitoring Training for ISD Monitors and OSE Leads and Technical Assistance Staff for Significant Disproportionality – Identification, Significant Disproportionality – Discipline, Indicator 9, Indicator 10, and General Supervision Monitoring
 - September 16, 2013 Training for new ISD Monitors 12 new monitors participated from throughout the state in a full day of training. The training focused on the most immediate monitoring activities in the morning. Staff from Program Accountability spent the afternoon with the group describing rule development and promulgation, prospective new rule packages, assistance available through the Help Line, the intermediate school district plan, state complaints, and due process complaints.
 - September 17, 2013 COP call for ISD monitors to discuss validation reviews and desk audit timelines.
 - September 20, 2013 Monitoring and Technical Assistance Team Conference Call with Lead Monitors to clarify questions that have arose during the first week of onsite visits.

Medicaid

- The National Alliance for Medicaid in Education (NAME) Annual Conference is being held in Grand Rapids this week, and many of you and your staff are in attendance. This meeting has shattered the record for registrants, so Jane Reagan thanks you for your strong support. Please provide her feedback on your/staff experiences there.
- The federal Department of Health and Human Services, Centers for Medicare and Medicaid Services (CMS) Office of the Inspector General auditors, have informed the Michigan Medicaid School Based Services program that they have chosen to audit the Michigan Medicaid program next.
 - As far as we know, this means these federal auditors will be auditing the Michigan Medicaid Program, not individual school districts. At the time of this writing there is very little we know, including: the dates they will arrive for the entrance conference; the quarter(s) being audited; or the scope of the audit. As soon as that info is available, we will let you know.
- Michigan's Medicaid program is now adding a special code to allow for reimbursement for those instances in which the child's eligibility/services status has been determined by the

REED process. The initial announcement was not well written and has been re-written and re-issued in October.

- The scheduled meetings of the Medicaid School Based Services Implementers are:
 November 12, 2013; March 11, 2014; and May 20, 2014. All are held at Ingham ISD and take place from 1:00 pm to 3:00 pm. Phone and web access are both available, with agendas and handouts coming to you one week prior to each meeting.
- Please continue to inform Jane Reagan if you have issues with a Medicaid provider/physician's office/health plan/clinic that denies a family services and sends them to your school for therapies. In general, this is NOT Medicaid's policy, so Jane and Kevin Bauer at Medicaid want to know when you become aware of families being denied services to which they may be entitled.
