- Assistive Technology Guide: Michigan Department of Education-Low Incidence Outreach announces: The Michigan Assistive Technology Guidelines for Teachers of the Blind and Visually Impaired is an expanded document based on the Michigan Educational Technology Standards (METS) that specifically guides teachers of students from prekindergarten through grade 12 who are blind or have a visual impairment, with assistive technology. These guidelines follow the six key concepts of the METS:

Data Collection

- June 30: Michigan Student Data System (MSDS) 2014 End-of-Year (EOY) Collection certification deadline.
- June 30: Registry of Educational Personnel (REP) End-of-Year Collection submission deadline.
- The Special Education data on the Michigan School Data website is not the official child count.
- July 1, 2014: The Center for Educational Performance and Information (CEPI) will remove all 2012-2013 school year data from the staging area. If you wish to save/download any data, please do so by June 30, 2014. For help, contact CEPI Support 517-335-0505 and select option 3.

Monitoring

- The monitoring team completed 16 on-site visits this monitoring cycle. Many of the findings were related to the REED or IEP participants.
- No on-site visits were conducted for B-5 (educational environments). Data alert letters will be issued in the August 2014 Workbook.
- Please review the Reports page carefully in the August 2014 Workbook and be aware that a new letter may be there regarding B-5 data.

Medicaid School Based Services (SBS) Program

- The Medicaid School Based Services staff have been discussing the possibility of hosting an educational statewide one-day conference devoted exclusively to the Michigan School Based Services program. On May 22, a survey was sent to all the ISDs asking for program ideas, date preferences and budget limits. Proposed dates were Fridays in August: the 15th or the 22nd. As soon as details are set, we will let you know.

- The OSEP has finalized and disseminated the Part B State Performance Plan/Annual Performance Report reporting requirements. Details to be shared in August.
- The Michigan Departments of Education and Community Health, noting 3 years ago that Michigan ranks worst in the country for its school nurse-to-student ratio, created a **School Nurse Shortage Task Force**. Consisting of ~30 stakeholders from across the State, the group has gathered data (most difficult), set priorities, agreed on models for school nurse practice to adapt to any district, and developed a plan that will increase the number of school nurses in Michigan. As of April 1st, 2014, MDE-LIO is now offering the American Sign Language Proficiency Interview (ASLPI) in place of the SLPI for adults who work with students who are deaf/hard of hearing in K-12 or post-secondary educational programs as well as for students who are deaf/hard of hearing over age 16 who would like a college reportable score. For all other students who are deaf/hard of hearing enrolled in district or ISD level educational programming, the SLPI (modified) will still be administered.
