# Low Incidence Outreach (LIO)

- The Unified English Braille Code (UEB) Workshop, sponsored by Low Incidence Outreach, was held on May 13th and 14th. Over 150 professionals attended the workshop where they learned the new Braille code, which will be implemented nationwide on January 4, 2016. - The Michigan Consortium for Teacher Endorsement for Visual Impairment and Deaf and Hard of Hearing was created to address teacher shortages in blind/visual impairment (VI) and deaf and hard of hearing (DHH). Partial tuition reimbursement is available to students who are certified teachers in Michigan and eligible for the program.
