BCBS Physician Assistant Reimbursement Policy

Cross Blue Shield's decision to reduce PA's reimbursement unless some rather restrictive guidelines are met. The Michigan Academy of Physician Assistants has been in ongoing discussions with Blue Cross Blue Shield of Michigan, the Michigan State Medical Society and the Michigan Osteopathic Association in an attempt to affect changes in these guidelines. As we have previously communicated, BCBSM has already announced their intention to individually credential PAs for "direct billing" of their services. Unfortunately, the proposed language demands reductions in reimbursement to 85% of the physician fee schedule unless certain restrictive guidelines are met.

I would like to update you on **Blue**

The Michigan Academy of Physician Assistants has been working diligently to educate our physician colleagues and BCBSM on the detrimental effects this will have on patient care, practice efficiency and practice reimbursement especially in rural areas. During a telephone conference that MAPA initiated, Dr. Simmer, Chief Medical Officer for BCBSM, informed us that this process started over 1 1/2 years ago (without MAPA's involvement) and the motivation behind the decision arose from negotiations with "major stake holders" (i.e. the auto companies) who demanded discounts for healthcare services. In addition BCBSM has been highly motivated to bring parity to

their individual contracts (some of which previously did not provide reimbursement for PA services).

In the meeting, MAPA representatives outlined the uniqueness of PA provided services and the team based model of healthcare delivery we provide, highlighting potential downfalls of the proposed guidelines, such as reduced access in an already ailing Michigan Healthcare system. These downfalls include increased administrative burden and penalizing practices where more experienced/mature **PAs** who inherently may require less supervision will not qualify for 100% reimbursement (yet are still appropriately supervised under current BCBSM policies and in the Michigan Public Health code). These concerns were acknowledged and Dr. Simmer suggested MSMS, MOA and MAPA offer language that might clarify certain areas of their proposed policy with a deadline for final input being 2/13/2008.

After proposed language changes by both MSMS and MAPA were shared, a Third Party Payer meeting was held on 2/13/2008 at MSMS. Dr. Simmer was an unexpected attendee and again reiterated BCBSM's intention to go ahead with their proposed guidelines with "further clarification" to be printed in the upcoming March "The Record". Throughout this process

and at this meeting **MAPA** made it clear that we did not support any discount in our services due to the high quality, cost effective nature of the care we provide and our unique relationship with our supervising physicians.

Realizing that BCBSM is highly motivated to please their major stakeholders and fully intends to enact this new policy, MAPA again suggested language changes that more closely mirror Michigan state law.

Dr. Simmer acknowledged our input but noted that his final version would be published in "The Record" but that the language would likely be altered only slightly.

A Climate Change?

I have been in office as
President of the Michigan
Academy of Physician
Assistants for almost 8
months, involved with the
Academy for over 8 years
and continue to be in awe of
how hard this organization
works for the PAs of
Michigan! The individual
volunteers that make up the
Board of Directors as well
as the committee chairs and
their members truly work
diligently to promote and

protect our practice here in Michigan. I point this out to you for a reason, over these months MAPA has seen what I perceive as a change in the practice climate for PAs here in Michigan.

While jobs are truly plentiful and, in spite of the many gains we've made in the legislative arena protecting our scope-of-practice, MAPA has seen outside entities try to "define" how we are supervised beyond what is well illustrated in Michigan Public Health Code. Along the same lines we are seeing much in the way of misinformation on what are appropriate billing practices for PA services often times from "expert" billing consultants. The reasons seem to vary as to why these issues arise but in part, supervision of non physician providers seems to be under scrutiny due to the advent of "Minute Clinics" and how physicians view them. Insurers are also expressing concern about non physician providers providing care in this type of setting and whether there will be "appropriate" supervision. Another interesting reason centers around major payers of healthcare benefits demanding deep discounts for the care provided to their customers which is thus passed along to physicians, healthcare systems and in recent cases PAs.

Many PAs are aware of the recent decisions that Blue Cross Blue Shield of Michigan has made regarding reimbursement for our services. If not, see the article regarding supervision guidelines for BCBSM in this newsletter. In addition to these new guidelines and the potential discounts tied to these, BCBSM is also implementing plans to halt reimbursement for PAs that are hospital employed and providing inpatient services only. Also, the enrollment process tied to their new supervision guidelines also appears to exclude PAs from reimbursement for care provided in mental health

settings and also states that the PA can be terminated as an enrollee "at will" which for our physician colleagues there is usually the provision for "due process" in such an event. I caution individuals to consider such issues before completing their enrollment forms.

MAPA has been working feverishly to educate BCBSM, Physicians, hospitals and our fellow PAs as to how bad these plans will be for Michigan Healthcare and BCBSM patients. Realizing that in a climate where deep discounts are being demanded and that BCBSM is able to make policy changes autonomously we will continue to fight for what is right for our patients and the PAs of MI. Specifically we will continue dialogue with our physician colleagues, major Michigan healthcare groups and Blue Cross to try and come to a positive result.

I am often asked by PAs, both members and nonmembers alike, as to what it is you get for your membership to MAPA. Here is what I say: "Beyond high quality CME conferences, a great newsletter, plus access to MAPA's website that will answer many practice and reimbursement questions...but most importantly you get "Advocacy"!" Know that MAPA and its volunteers put in long hours to help and maintain our ability to practice here in Michigan. Now here is where YOU come in. Realize that you and your supervising physician too will play a huge role in the coming weeks and months regarding how the proposed BCBSM reimbursement policies will turn out. I encourage you to have your supervising physician contact BCBSM and their physician organizations about why these decisions are bad for Michigan Healthcare. Also realize that we as PAs can no longer be passive in our practices. We must educate ourselves and evolve as experts on billing and reimbursement for our services so as to educate those around us (Our Spring Professional CME is a good start in this area). We must individually advocate to maintain our practice environment and maintain our ability to provide "high quality, cost effective care" for our patients.

Will You Accept The PAMPAC Challenge?

Will you accept the Physician Assistants of Michigan Political Action Committee (PAMPAC) CHALLENGE? PAMPAC challenges all PAs in the State to contribute at least one hour of your pay each year to PAMPAC. It is easy to figure out how much to donate but first I would like to explain why you should consider taking up this challenge. PAMPAC allows the PA profession in Michigan (You) to participate more effectively in the legislative process that governs our ability to practice. With that sentence I think I have given you all of the information needed to consider donating to PAMPAC but for those not yet convinced then I will explain more.

PAMPAC is allowed to accept donations in order to direct monies to political candidates who we feel would best support the PA Profession in Michigan. We select candidates, both democrat and republican, who espouse an understanding of our role in health care and support us when we, proactively, hopefully not reactively, interact with the legislative process.

PAMPAC also works to educate those politicians who are less familiar with, and less of an advocate for, our profession. By supporting candidates that advocate for PAs, and educating those who don't, we can help ensure the continuance of a positive practice environment for PAs in Michigan.

So why have a political action committee and a legislative committee? Aren't they the same? MAPA's Legislative Committee is made up of your colleagues who volunteer their time to study the issues that confront our PA profession today, and decide what approach to use to overcome or improve upon those issues. PAMPAC accepts donations from PAs that allow our lobbyist to attend fund raising functions to support the campaigns of the candidates we feel are critically important to us.

The majority of the candidates that we support are members of the State of Michigan's Health Policy Committee, which is the main legislative committee we interact with. Hopefully you recall that in 2006 the Health Policy Committee blocked the Advanced Practice Nurses Independent Practice Bill from leaving their committee and did not allow it in front of the legislature for a vote. Although that decision was based on multiple factors, I can say that PAMPAC, through your contributions, helped support key members of that committee get elected and we will continue to support them in the future.

The problem is that we cannot continue to support the politicians who directly make decisions critical to our practice environment without your financial support. PAMPAC has no endowment, no rich benefactor, no Sugar Daddy (or mommy), no guardian angel or fairy godmother, no lottery winnings. **All that PAMPAC has is YOU!**

Without support from PAs such as you, PAMPAC is ineffective!

Here is an accounting of our PAC along with other key health care associations in Michigan. The January filings have not been tabulated and placed on line yet. As you can see, several of the groups have spent a lot of money. Actually the goal is to spend the money when needed. **Our account is woefully low and this limits our lobbyist to perform his job to the utmost.**

PA Workforce Issues

Adopted from Larson, E.H. & Hart, L.G. (2007).

Growth and Change in the Physician Assistant Workforce in the United States, 1967-2000. Journal of Allied Health; 36:121-130.

In an effort to stay abreast of the research regarding the Physician Assistant profession, MAPA strives to monitor not only what is happening in Michigan, but what is happening across the country. In a recent publication, a PA workforce study that was conducted by the WWAMI Center for Health Workforce Studies (funded by the National Center for Health Workforce Analysis of the Bureau of Health Professions, Health Resources and Services Administrations) was highlighted. Here is the abstract from that article:

"The physician assistant (PA) profession grew rapidly in the 1970s and 1990s. As acceptance of PAs in the health care system increased, roles for PAs in specialty care took shape and the scope of PA practice became more clearly defined. This report describes key elements of change in the demography and distribution of the PA population between 1967 and 200, as well as the spread of PA training programs. Individual-level data from the American Academy of Physician Assistants, supplemented with county-level aggregate data from the Area Resource File, were used to describe the emergence of the PA profession between 1967 and 2000. Data on 49,641 PAs who had completed training by 2000 were analyzed. More than half (52.4%) of PAs active in 2000 were women. PA participation in the rural workforce remains high, with more than 18% of PAs practicing in rural settings, compared with about 20% in 1980. Primary care participation appears to have stabilized at about 47% among active PAs for whom specialty is known. By 2000, 51.5% of practicing PAs had been trained in the states where they worked. The profession has grown rapidly; 56% of all PAs were trained between 1991 and 2000. In 2000, more than 42% of accredited PA programs offered a master's degree, compared to master's degree programs in 1986. Although many critical issues of scope of practice and patient and physician acceptance of PAs have been resolved, the PA profession remains young and continues to evolve. Whether the historical contribution of PAs to primary care for rural and underserved populations can be sustained in the face of increasing specialization and higher-level academic credentialing is not clear."
