Pedro... the Face of Hope

"Mama Julie," as the Mozambican children call PA Julie Malacusky, has spent an astonishing career around the world caring for children who do not have homes, for parents who have lost their children to malnutrition and for communities that need an infusion of tenderness and attention. She has tirelessly given her time and money to fund trips to India, Brazil and Mozambique, bringing along with her much needed medicines and donations.

An ordained minister, Malacusky wanted to become a PA to relieve the suffering of underprivileged children. Her goal was realized in her early twenties during a six-week trip to Calcutta, India. The lack of sanitation and protection provided for children throughout Calcutta led her to build a home for children a year and a half later.

"After this trip I knew my life would be about easing the suffering of impoverished children," said Malacusky.

Upon completing her work in Calcutta, Malacusky traveled to Brazil where she witnessed children living on the streets and sidewalks of Brazil, malnourished and involved in drug activities. Such children ad no way of improving their situations. Malacusky and her colleagues decided to take action, and founded The Dream Project, which helps street children reintegrate into society and sponsors their vocational training. The Dream Project also places orphaned and abandoned children into family style orphan-homes. Malacusky was the mpetus for the opening of a safe shelter for young girls on the street in Brazil.

When Malacusky returned from Brazil to her home in Michigan, she was determined to further improve the lives of children around the world. Malacusky is responsible for raising the funds to pay local staff, provide for the needs of the children, and train relief volunteers.

In 2004, Malacusky moved to Mozambique with a heart compelled to make a difference for those suffering in the AIDS and orphan crisis of Africa. For two years Malacusky lived without running water or electricity, and faced her great fear of black mamba snakes. Along with a co-worker, she oversaw the construction, human resources, health care and social service aspects of building homes for orphans.

Her next venture was to convince the district administrator to allow children to move from the streets into new orphan homes she would build. He gave the go-ahead and contributed six acres of land to the project. As one fellow PA described, "She [Malacusky] has dedicated her life to these orphaned children in hopes of rescuing them, raising them as leaders, equipping and empowering them to bring hope and help to their country."

The 2009 AAPA Humanitarian of the Year Award recipient has selflessly put her own life on the line for individuals and communities around the world. Any setbacks she has encountered serve as fuel for her determination, and her smile grows wider with each life saved.

Malacusky was quick to give credit to others. She accepted the award of behalf of her team and said, "I want to thank the Lord Jesus without whom none of this would be possible."



Michigan Automated Prescription System (MAPS): Assists Health Professionals to Track Patients' Controlled Substance Use

According to Dr. Scott Fishman, author of the Federation of State Medical Boards' *Responsible Opioid Prescribing: A Physician's Guide*, "Appropriate concerns about the potentially harmful or addictive aspects of opioid medications can be balanced with the equally valid needs of optimal pain relief with adequate risk management." One of the tools that will allow for adequate risk management is the Bureau of Health Professions' Michigan Automated Prescription System (MAPS).

Users of MAPS — dentists, veterinarians, physicians, nurse practitioners, physician assistants and pharmacists — are encouraged to request MAPS reports on their patients to review their prescription records of Schedule II – V controlled substances. Online requests for reports take, on average, less than five minutes. Faxed requests take a minimum of 24 hours.

Just an Observation

As a PA for the past two decades and a preceptor, I have fielded a number of questions throughout the years from many PA students and newly minted PA grads. Most of the questions are of the clinical variety--naturally. However, of the non-clinical variety, there is one that I get asked the most; the one that many grapple with or fret about as they embark on their new chosen careers.

"Would it be best if I go into a specialty right off the bat, or should I do family practice first?" In other words, should they become a "specialist" or become a "generalist." Many wrestle with this from the outset, and rightfully so...I did too, 21 years ago.

As much as I try to remain unbiased in my answer(s), I always seem to gravitate to the (somewhat expected) biased response that most senior or experienced PAs would provide when asked to play "Mr. Career Advisor."

Become a "generalist" first, then a "specialist". Why? In my opinion and experience, many PAs get locked in to a specialty for a number of years without developing their "generalist" (primary care) foundation. Without expanding their knowledge base, they may jeopardize their market appeal should they become burned out after a long strings of specialty jobs. I have witnessed this with many of my peers, in spite of having the ability to transition between specialties.

But keep in mind that to become a truly knowledgeable & effective clinician, you must have at least three to five years of solid "generalist" experience under your belt. Yet having said that, we all know that there are always exceptions to the rules. For instance, I know a few of my classmates who have never done primary care or family practice since graduating from PA school. All they have done is specialty medicine and nothing else and quite successfully, I must add.

So which career track to choose? My solicited or unsolicited advise is always "know thyself" and follow your heart. But if you have an inclination or a burning desire to become a "specialist" first, then, by all means, pursue your dreams and nothing less. Do not let anyone dissuade you otherwise, just go for it! However, if you are in no rush to get to the top of the mountain (so-to-speak) and want to become the very best while building your credentials and marketability, then the "generalist" route may be the way to go.

But then again, that's one individual's opinion---my personal observation.

UD Mercy PA Students and Faculty Participate in MiDoor Outreach

On Saturday, May 16, 2009, PA students and faculty from the University of Detroit Mercy provided free health screening, blood pressure, glucose and cholesterol checks to Detroit-area patients attending the Michigan Day of Oral Health Outreach (MiDoor). Patients were also provided with educational materials on diabetes, dyslipidemia and hypertension, as well as a list of community organizations offering free or reduced cost health care. PA students Jay Williamson and Linda Verhun ('09) received a \$2500 grant from the National PA Foundation to purchase equipment and supplies for this screening. The MiDoor event was hosted by the UD Mercy School of Dentistry and Clinic in partnership with the Michigan Department of Community Health, and over 250 low-income adults were screened and received basic dental services such as fillings, extractions and minor denture repair. Other UD Mercy health professions students and staff also participated in providing pre-dental work health screening. Governor Jennifer Granholm, who had called for the Michigan Day of Oral Health Outreach in her 2009 State of the State address, personally attended the event and visited with patients and volunteers.

Immunity Protection for Michigan PAs

At the request of MAPA, Senator Tom George of Kalamazoo has re-introduced legislation that would add PAs to the list of those health care providers protected from liability while volunteering for a governmental search and rescue (SAR) operation. Senate Bill 688 has been introduced, and referred to the Judiciary Committee. PAs in Michigan would be protected from liability, with the exception of gross negligence, while caring for patients during one of these SAR missions. Currently Physicians, nurses, and EMS personnel are listed as protected under Michigan law. Last year the Judiciary committee rejected a similar bill, after it was opposed by the trial lawyers association.

Professional Corporation Issue Phil Schafer, PA-C

MAPA continues to work diligently to pass legislation that would allow Michigan PAs to partner with physicians to form a Professional Corporation (PC). Many meetings, discussions and changes continue to take place, which has brought this reality closer than ever. Three senate bills were introduced this spring to resolve this problem, but as written, would force the current PCs that are solely owned by PAs to restructure or become illegal. MAPA has continued to fight for these previously established PCs and the PAs who own them. Currently there is an agreement among the major parties involved, including the state licensing bureau, the commerce department, and the Attorney General's office, that would allow new wording to be added. MAPA is hopeful that we can now have this important piece of legislation move forward. MAPA continues to work closely with the sponsor of these bills, Senator Tony Stamas of Midland, and we remain hopeful that this will move through the legislature this fall.

New Educational Web-cast Will Help Doctors and Their Patients "Just Say No" to Antibiotics for Colds and Flu

MARR Coalition and Wayne State University School of Medicine Join Forces to Preserve Michigan's Antibiotic Lifeline



Okemos, Michigan, August 4, 2009 – The Michigan Antibiotic Resistance Reduction Coalition (MARR) and Wayne State University School of Medicine are joining forces to host a new CME-accredited (continuing medical education) web-cast on Tuesday October 6, 2009 from 10:00 a.m. to 1:00 p.m. to promote appropriate management of upper respiratory infections. The program will be accessible for registration from the MARR website at www.reducemisuse. org and the Wayne State University website at www.med.wayne.edu/cme in early September.

"Wayne State University School of Medicine is pleased to be part of this effort to educate primary care practitioners on appropriate antibiotic use," said David Pieper, Assistant Dean, CME Wayne State University School of Medicine, Executive Director, Southeast Michigan Center for Medical Education, "It is very much in tune with our mission to provide the medical resources needed to improve the overall health of the community."

Specifically designed for Michigan primary care practitioners, including physicians, physician assistants and nurse practitioners, the presentation will include information about antibiotic resistance, treatment guidelines for upper respiratory infections (URIs), and strategies to improve patient satisfaction when antibiotics are requested but not necessary for the treatment of the illness. It will also provide useful advice on how to establish effective practice protocols that improve patient outcomes by setting reasonable expectations for URI treatment and management.

The web-cast will be presented by members of the MARR Coalition, including Stephen Lerner, MD, Professor of Medicine, Wayne State University School of Medicine, Division of Infectious Diseases; Mohamad Fakih, MD, Medical Director, Infection Control, St. John Hospital and Medical Center; and Marla Rowe Gorosh, MD, Senior Staff, Family Medicine, Organizational Development, Henry Ford Health Systems. David Pieper and MARR Coalition Executive Director, Jane Finn, will provide additional support and content development.

For healthcare professionals unable to participate in the live event, the program will be archived online for one year, until October 5, 2010. Healthcare practitioners nationwide will also be invited to participate through MARR's partnership with the Centers for Disease Control and Prevention (CDC).

The Wayne State University School of Medicine and the Michigan Osteopathic Association will provide CME accreditation.

"This activity has been planned and implemented in accordance with the Essential Areas and policies of the Accreditation Council for Continuing Medical Education through the joint sponsorship of Wayne State University School of Medicine and the Michigan Antibiotic Resistance Reduction Coalition (MARR).

Health Care Employers, Providers and MSLRP Marketing Partners

The Michigan State Loan Repayment Program (MSLRP) provides loan repayment assistance to medical, dental and mental health care providers who enter into MSLRP service obligations. These service obligations require participants to provide full-time, primary health care services at an eligible, non-profit practice site, located in a Health

Professional Shortage Area (HPSA) for a period of two to four years.

FY 2009 First-Come, First-Served Application Period Remains Open. Employers may still take advantage of combining their contributions equally with available federal program funds to double their resources intended for provider loan repayment contracts.

Remaining federal funds must be committed no later than August 31, 2009, or be returned to the Health Resources and Services Administration (HRSA).

Interested Providers and Employers should apply As Soon As Possible!

- Participants receive these loan repayment benefits tax-free.
- Contracts are awarded to eligible providers on a first-come, first-served basis, regardless of priority status.
- Contracts may start as soon as the month following application and employment.
- Application forms are available on the MSLRP Website at: www.michigan.gov/mslrp.
- These contracts are not affected by the State's budget situation, because no state funds are involved.
