Your ability to practice medicine and provide efficient care for your patients has been questioned by the Michigan State Medical Society (MSMS).

MSMS is a professional society that represents physicians and medical students in the state of Michigan with a stated mission focused on improving physician lives with core values centered on advocating on the behalf of physicians.

Last week, MSMS announced their intent to redefine the existing PA practice law **to now require** "Physician-led" practice agreements. This planned legislation would require oversight of PA prescriptive abilities, listing all PA duties and responsibilities, and mandates involvement of physicians in several aspects of your patient care.

MAPA believes we currently have the best practice environment for PA's in the country and have been the role model for many other states. The proposed legislation from MSMS would undo your ability to efficiently practice patient-centered medicine. This current position is not reflective of the <u>objective data available showing that PA's provide high-quality</u>, patient-centered, safe care.

MAPA, MSMS, and other physician organizations, have worked together for decades to collectively serve our patients and communities. MAPA continues to strive for collaboration with these organizations to foster the team-based care model we have established.

Examples of how MAPA has worked for you in this area include:

- MAPA worked with MSMS to ensure their support for the Michigan PA Practice Act in 2016. This historic law was sponsored by a physician and created a national precedent for PA's with limiting physician liability for care PA's provide patients.
- MAPA has worked with other supportive physician organizations such as the Michigan Osteopathic Association, Michigan Academy of Family Physicians, Michigan Society of Addiction Medicine, and Michigan Psychological Association in advocating for PA's to be recognized as Mental Health Providers in Michigan.
