### MBMA is Asking for Our Participation!

### **Roof Live Load Study**

A team of researchers from UMass Amherst is investigating live loads on low-slope (2:12 and less) roofs (roof live loads – RLL). The goal of this project is to assess whether current provisions for RLL, which specify a 20 lb/ft2 (psf) load, correctly capture the intensity and distribution of potential loads and, if not, to propose a new value for the RLL intensity. Historically, live load intensities (e.g. 50 psf for interior office spaces) have been determined through a combination of field surveys, questionnaires and focus groups, and modeling. This was not done for RLL. This questionnaire represents a preliminary effort to gather information from building owners, maintainers and other interested parties to help inform assessment of current RLL provisions.

### THE HEAT IS ON

With temperatures rising early this year, it's time to start thinking about your heat illness prevention program. OSHA has... it will again be one of their national emphasis programs (NEP) and a focus of agency resources.

Under the NEP, inspectors have been instructed to inquire about a company's heat illness prevention program on heat priority days – days where the heat index is expected to be 80°F or more. And we all know that it doesn't take much to get to that point.



If your company does not have a formal heat illness prevention program, it's time to put one into place. Consider the following when forming your game plan.

- 1. Water & shade Make sure workers have ready access to cool drinking water throughout the day and a shaded or cool area for breaks. The employer is obligated to provide drinking water regardless of whether personnel bring their own.
- 2. Hydration Supervisors should be trained to schedule more frequent breaks during hot weather to allow for hydration & body temp recovery. These "hydration breaks" give supervisory personnel a great opportunity to ensure that each person on the crew is drinking water and not exhibiting heat illness signs/symptoms. Workers should drink at least two 16 oz. bottles of water per hour in the heat and be trained to not substitute caffeinated drinks (soda, iced tea, coffee...) or sports drinks for the water they need. When going to the john, if urine is not clear to light yellow in color, you may not be drinking enough water.
- 3. Scheduling To the extent feasible, supervisors should be instructed to schedule the most physically demanding work for cooler times of the day (usually earlier in the morning or at night). Also, look at the week's weather forecast do any days offer lower temps/humidity or breezy weather?
- 4. Attire Wear lightweight, light-colored, loose-fitting clothes. Cooling towels may also be helpful but be careful. They can trap heat if not periodically refreshed.
- 5. Acclimatization Realize that the body needs time to acclimatize to higher heat & humidity. Supervisors must understand that production might dip during this period, but hydration breaks remain critical and will ultimately maximize work that gets done. Crews that travel to warmer climates must be especially mindful of acclimatization.
- 6. Employee training & monitoring Train your crew on the hazards & symptoms of heat-related illness, what they can do to minimize its effects, and then on the importance of keeping an eye on one another. Train them on how to respond to a heat-related illness and when 911 is necessary. Train supervisors in their responsibilities and on the need to monitor heat index and how crew members are responding. Training should also emphasize the importance of frequent hydration breaks, acclimatization periods, and a buddy system.

Heat-related illness can be managed and deaths prevented – relatively easily. But everyone needs to be on the same page and understand that this is a serious hazard and that we all have a role in prevention.
