## Need help getting workers? Use this tax credit to pay a hiring bonus.

The economy is quickly recovering from the pandemic and many area small businesses are seeing an increase in demand. But, thanks to stimulus checks, higher unemployment compensation, and continuing health and safety fears, many employers are finding it difficult to entice workers back to their jobs.

Some larger employers — from restaurant chains to **Wawa** — have been offering hiring bonuses. But **can small businesses still struggling** afford the same? Thanks to a little-known federal tax program, the answer could be yes.

The program is called the **Work Opportunity Tax Credit**. It's been around for a number of years, but was extended in December's stimulus bill through the end of 2025. The credit — which reduces the amount of federal taxes owed — can be a lucrative recruiting tool for small businesses that want to pay hiring bonuses.

#### **How to Improve and Promote Safety in Construction**

The construction industry poses unique health and safety challenges for its workers. In fact, about one out of every five workplace deaths in calendar year 2019 were construction-related, according to **OSHA**. Luckily, health and safety processes play a vital role in minimizing risks.

I spoke with two industry experts, **Steve Mellard**, national safety director at Anson Industries, and **Desiree Ropel**, safety manager at Hermanson Company, for an insider look into building a safety culture within the construction industry.

#### The Importance of a Safety Culture

The term safety culture was first used by the International Atomic Energy Agency in its 1986 Chernobyl accident summary report to describe how the thinking and behaviors of people in the nuclear plant contributed to the accident. Decades later, successfully increasing employee buy-in to build a safety culture and safety program is still something that many construction organizations struggle with.

Aside from minimizing health risks and saving your organization money, a safety management program that fosters a safety culture also provides other benefits, including:

- Improvements in quality and production
- · Increased employee morale
- · Gains in employee recruiting and retention
- · Better image and reputation among customers, suppliers and the community.

If having a safety program is the first step, the second step is ensuring that it is followed and enforced; otherwise, it will have little meaning or impact. Ropel points to the importance of buy-in from all employees: "It's less about the words on the pages and mostly about buy-in from the people," she says.

#### Why good leaders communicate how much they care

#### Tips to boost employee recruitment and retention

If you can't find workers, you're not alone. At each keynote speech I give, I ask the audience to raise their hands if it's difficult to hire new employees. Just about everyone raises their hand. I then ask if they have trouble retaining them. Again, nearly everyone raises their hand.

As the U.S. economy continues to improve, the labor shortage and skills deficit will only get worse. For example, the worker shortage in the manufacturing sector alone is estimated to reach 2.4 million by 2028, according to a Deloitte and Manufacturing Institute study. And the costs for companies are high, exceeding a trillion dollars in lost revenue over the decade.

# OSHA Provides Update on COVID Guidance

One of the topics discussed during the MBCEA National Conference was how to handle COVID related issues, including vaccine mandates. The primary drivers behind questions relating to mandating vaccines are protecting people when they come back to work and insulating the company from liability for COVID related incidents. The analysis on the legality of COVID vaccine mandates has not changed, as the Equal Employment Opportunity Commission's most recent publication confirms that vaccine mandates, with some exceptions, are legally permissible. The recent guidance from OSHA speaks to the separate issue of the employer's obligation once employees are vaccinated.

As most people know, the Centers for Disease Control and Prevention recently changed its recommendation on masking policies to allow those who are vaccinated to go without a mask in most settings. In an announcement on June 10, 2021, OSHA followed suit by indicating that employers can follow CDC's guidance on mask use and social distancing. In a fully vaccinated environment, masking and social distancing can be lifted. OSHA expounded its position by stating that if a portion of the company's work force is not vaccinated, the previous masking and social distancing guidance remains in effect in all physical spaces and areas where co-workers may come into contact with each other. Masking and social distancing is not required in any area where only fully vaccinated personnel are permitted.

We are stronger and better as a result."
