## A Big Infrastructure Deal Faces a New Hurdle

(Bloomberg Opinion by Conor Sen) -- Democrats and Republicans seem to disagree about almost everything with one exception: the need to repair and upgrade America's shaky infrastructure. Although it's difficult to envision big legislation passing in an election year, Democratic House Speaker Nancy Pelosi says she intends to try. One thing working in favor of a large infrastructure bill is that both parties have grown increasingly comfortable with running huge budget deficits. But that doesn't answer a pressing new issue: In the tightening and evolving U.S. jobs market, it might be hard to find enough construction workers. In other words, if money was an obstacle before, now it might be a labor shortage.
