New Worker Walkaround Rule Problematic Joshua Quinter - Offit Kurman

OSHA is proposing a new rule that would allow an employee to choose a third party representative to accompany an OSHA inspector on a job site inspection. This third party representative could be a union representative, a community activist, or even a family member. There does not appear to be any real criteria as it relates to the qualifications of the selected third party representative. This rule, if it passes in its current form, is a bad idea for a number of reasons.

First, contractors are in charge of and responsible for safety on the job site. When an OSHA


representative comes on site, he or she brings an added element to the safety obligations. The contractor remains obligated for the safety of all personnel on site; but OSHA inspectors, since they work for the government, don't always believe they are required to follow the same safety protocols for a variety of reasons. This new rule introduces another person into category. More importantly, the rule does not provide any requirement for safety training or certifications to ensure the selected third party can be there safely.

#### WITH A LITTLE HELP FROM MY FRIENDS

You may have recently noticed the increase in awareness and resources devoted to mental health for workers in the construction industry. Suicide among construction workers has become a serious topic, as it now accounts for about 4% of construction deaths – yes, these suicides occurred ON THE JOB. This is twice the number of workers killed from trench cave-ins and doesn't even account for worker suicides that do not occur during work hours.



While Fed. OSHA does not directly regulate employer suicide prevention programs, they do provide resources devoted to this topic (link at end of this article). Of course, investigation of complaints and at-work deaths continues to be a part of their function and, if necessary and appropriate, the General Duty Clause could be applied.

Like most of you, I am a professional in a field other than counseling. But I try to do a better job of identifying situations where someone may be reaching out for help, just not in a very direct way. Although sometimes subtle, there is a difference between someone just bitching and someone who may be struggling with underlying issues. The resources provided at the end of this article help with making this distinction.

Asking for help – especially needs relating to mental health and especially through construction co-workers – is a tall order for most people. We all have issues – marital, kids, gambling, drugs/alcohol, financial... many are minor and can be managed. But some folks are less able to feel that sense of control over their problem(s) or get themselves to a point where they are incapable of seeing a path forward. They need help but may be afraid to ask friends at work because they don't want others to know their problems or "be made an ass out of." Yet construction is unlike most other industries in that your co-workers become de facto family. This relationship may sometimes be a little complicated or dysfunctional, but teamwork and the rewards of problem-solving and hard work make the relationships among our crew members something unique.

I love my brother, but distance between us probably keeps us from being at each other's throat all the time. But I would never want to see him suffer. I have an ear and know when to set pettiness aside. I also know where I could go if professional help is needed. That doesn't make me special – it makes me just like you and just like any other human being with a soul.

Many people who contemplate suicide exhibit signs. It may be their way of reaching out for help without having to directly ask. Sometimes we just need a little help from our friends.
