TECHNICAL CORNER - Critical Lift Plans

ASME B30.5 provides guidelines for crane operations, particularly for critical lifts, which involve significant risk or complexity. A critical lift plan is necessary when lifting heavy loads, using multiple cranes, or when any condition increases the potential for accidents or equipment failure. These plans ensure safety, compliance, and effective communication among all parties involved.

When to Use Critical Lift Plans:

- 1. Heavy Loads: Lifting loads that exceed standard limits or require special considerations.
- 2. Multiple Cranes: Coordinating lifts involving more than one crane, where precise synchronization is essential.
- 3. Complex Rigging: Utilizing intricate rigging configurations or non-standard lifting methods.
- 4. Challenging Environments: Working in confined spaces, near power lines, or in areas with limited access.
- 5. High Consequence: Situations where failure could lead to significant injury or property damage.

How to Create a Critical Lift Plan:

- 1. Define the Lift: Clearly specify the load, including weight, dimensions, and center of gravity.
- 2. Conduct a Risk Assessment: Identify potential hazards related to the lift, including environmental factors and equipment limitations.
- 3. Select Equipment: Choose the appropriate crane(s) and rigging equipment based on the lift's requirements and conditions.

- 4. Develop Procedures: Create detailed procedures that outline the lifting process, including rigging methods, signaling protocols, and emergency responses.
- 5. Create Lift Diagrams: Prepare diagrams to visualize the lift setup, showing equipment locations, load paths, and rigging configurations.
- 6. Assign Responsibilities: Designate roles for all personnel involved in the lift, ensuring clarity in communication and task delegation.
- 7. Review and Approve: Collaborate with safety officers, engineers, and team members to review the plan, making necessary adjustments before final approval.
- 8. Conduct a Pre-Lift Meeting: Gather all involved personnel to discuss the plan, address concerns, and reinforce safety measures before executing the lift.
- 9. Document and Monitor: Keep a record of the critical lift plan and monitor adherence during the operation, ready to adjust as conditions change.

By following these guidelines, you can effectively use ASME B30.5 critical lift plans to ensure safe and successful lifting operations. Note, a Critical Lift Plan template is included in the **Members Area**.



POWER LINE SAFETY – part 3

Last time around we discussed Federal OSHA safety measures that must be taken if our crane, at maximum working radius, could come within 20 ft. or power lines up to 350 kV. (This distance can be reduced to 10 ft. if line voltage is verified to be 50 kV or less).

The options included: 1) Having the lines deenergized & grounded, 2) Having the lines relocated, or 3) Maintaining minimum required clearance and using encroachment prevention measures.



Encroachment prevention measures are a secondary layer of safety to be used when it is necessary to maintain a minimum required clearance between the crane/load and power lines. With this option, the following requirements must be met:

1. Planning meeting with operator, lift crew, lift director (if one has been assigned), and other workers that will be in the hoist area. Review location of power lines & steps implemented to prevent encroachment.

2. Tag lines (if used) must be nonconductive.

3. Elevated warning line, barricade, or line of signs, with flags or similar hi-viz markings (in view of operator) at Min. Clearance Distance.

4. If operator unable to see elevated warning line, must use dedicated spotter, PLUS one of the following precautions:

- Proximity alarm set to warn operator.
- · Device that warns operator when to stop movement (ex: range control warning device).
- · Device that automatically limits range of movement.
- Insulating link

Although I often run into situations out on site that rely on maintaining min. required clearance, I rarely experience that all the required encroachment precautions are being taken... especially #3.

Like the rest of the lift, ensuring power line safety requires planning, but it is well worth the time invested.
