

SENATOR THERESE MURRAY CRANBERRY EDUCATIONAL SCHOLARSHIP



The Cape Cod Cranberry Growers' Association is pleased to announce that applications for the Senator Therese Murray Cranberry Educational Scholarship are now open. This year the CCCGA will be offering one \$1,000 scholarship.

Applicants need to be immediate family members of a CCCGA grower-member, or a year-round or part-time employee of a grower member. Applicants should also be currently enrolled at an institution of higher learning (post-high school) with a GPA of 2.5 or better. The application guidelines, requirements and form are enclosed.

The completed application form must be received at the CCCGA office no later than **12PM, Thursday, May 25, 2023**. Completed electronic submissions should be sent to psilvia@cranberries.org.

The recipient of the scholarship will be notified no later than July 28th. The awardee will be invited to the CCCGA Annual Meeting on Wednesday, August 16st at White Dog Cranberry LTD at 6 Palmer Mill Road, Halifax for formal recognition.



CHANGING ON THE FLY

Victory at last! Recently I have been touting the challenges that cranberries have been facing in our local communities. I'm pleased to report, great progress has been made! In Halifax, where the town attempted to shut down a grower moving material from one bog to another to finish a renovation project, the grower has been able to continue and finish that job. The grower exercised their right to farm but was courteous to avoid moving material during school bus times. The town appreciated this accommodation and the grower was able to do what they needed to do. A win for the support of normal farming practices.

In Carver, a more impactful battle was occurring. A citizen petition article was on the Town Meeting warrant, calling for a moratorium on all agricultural earth removal. If you are not aware, Massachusetts law allows 10 citizens to bring forward an article for town meeting to consider. That's what happened in Carver. I have written about this previously and some of you may have seen our email blasts on it. The article was so narrowly written that a grower couldn't so much as move a shovel full of sand across the street to repair a flume, never mind take on a sanding or bog renovation project. This article was clearly anti-cranberry and would violate numerous state protections for agriculture, not to mention leaving the town in a precarious situation from a liability perspective, as noted by town counsel at Town Meeting.

CCCGA organized a campaign to fight against this short-sighted article. Spoiler alert, cranberry agriculture won! And it wasn't close. The cranberry community rallied and with the support of most of the room, resoundingly defeated the article looking to damage the cranberry industry. We had a good story to tell based on factual information, the laws of the Commonwealth, and the positive benefits that a healthy cranberry industry can bring to the town of Carver. The proponents of the article had none of that and it showed.

This win was not easy and it took the entire industry and beyond to make it happen. CCCGA helped organize the effort and developed the strategy and process to make this possible. There are many people to thank and countless

others who I'm sure were working their own circles that we were not aware of but together, the united message was essential. Special thanks go out to your CCCGA leadership team of Steve Ward and John Mason, who really pushed the message far and wide. We had an ad hoc group of Carver growers (not necessarily residents) that met frequently to develop the outreach strategy and approach for Town Meeting. This group also included some earth removal companies that are sustaining members of the Association; they provided direct support and also encouraged their employees to attend Town Meeting. All of these individuals that spent many hours at CCCGA were critical to the success of the vote. I'd like to call out four members of the team, Bob Bentley, Sarah Stearns, Dick Ward, and Eric Weston. They really stepped up with critical background work and insight.

We had some great cranberry industry speakers address the Town Meeting assembly. They spoke with heart-felt conviction and told their personal stories – they were Gary Garretson, Dick Ward, Eric Weston, and Mary Ellen Williams. Sarah Hewins, a select board member and longtime supporter of cranberries also spoke against the article. There were several others from the Carver community who also stood and showed their support.

Lastly, you had your CCCGA team that helped out too. Emma Wick designed the card, with an assist from Linda Burke at AD Makepeace and editing from our media consultant, Michelle McGrath, that was distributed throughout town to help inform the public as to why this by-law was bad for cranberries. Emma and Kim Miot handed out the cards to people attending Town Meeting, along with Mike Wainio and Steve Ward. It was sometimes an uncomfortable experience, putting themselves out there but shows the level of dedication that not only the growers have for cranberries but your CCCGA staff as well. Kim and Emma volunteered for that tour of duty – it was not required. Bonnie Soule not only sent out the numerous emails to rally member support, she also developed a series of social media posts leading up to the meeting, with

positive and factual messaging. Kim Miot put together some professional-looking video pieces for this social media campaign. Our communications consultant, Michele Pecoraro, provided experienced feedback on this campaign as well. Bonnie and Emma also helped last weekend, monitoring social media to keep us informed of what was going on and helping us craft an appropriate response. Finally, Michele Pecoraro arranged a meeting with the South Shore Realtors Association, who sent a message out to all of their agents, asking them to help spread the word to vote against this article.

With many people to thank, there are some undoubtedly missed. Please be sure you know we thank each and every one of you for all that you did to support this effort. It was good to see and uplifting. The grower turnout was outstanding. Kim Miot even brought her in-laws to get their vote cast. Beyond the growers that turned out for Town Meeting, we had handlers, our sustaining business members, and also waiting to speak if necessary was Bill Madden of GAF Engineering, who was prepared to deliver answers on any technical aspects of earth removal. Fortunately that was not necessary. All in all, we had a great night for cranberry agriculture. It showed our industry is invested in their future and our local community still recognizes that.

These two local issues demonstrate that our local agriculture is going to continue to come under scrutiny. Although we pushed back on these two instances, there's undoubtedly more to come. We know it and we must act accordingly. Michele Pecoraro will be delivering her final report on CCCGA's strategic communications and messaging plan at the end of the month. The CCCGA board will be continuing to discuss strategy based on her plan and also work that we know needs to be done in our local communities. There is much to do to educate the public on the value of cranberries and continue our role as stewards of the land and being good neighbors in our communities. Town elections are coming up. Don't take them for granted. See who's on the ballot, understand if they support agriculture. If they don't, use your voice to vote for another candidate. We need to support those who support us. We have spring frost starting, the growing season is off and running but hopefully these recent

AG DAY AT THE STATE HOUSE

April 12th was Agriculture Day at the State House. Agricultural groups, organizations, farmers, and students from all over the Commonwealth gathered in the Hall of Flags to showcase the diversity and economic value and importance of agriculture in Massachusetts. “Ag Day,” as it is more commonly called, is also a great opportunity to interact with state legislators and their staff, highlighting the successes and challenges that we see in agriculture today.

Our group included Steve Ward, Brian Wick, Alex Manchester, Eric Weston, Kim Miot, and Emma Wick. Our table featured a variety of sweetened dried cranberries donated by Decas Cranberry and Ocean Spray Cranberries, as well as samples of cranberry juice, including 100% cranberry juice. The 100% cranberry juice was a BIG hit — people absolutely loved it and kept coming back for more! Other commodity groups had displays of local cheeses, ice cream, milk, honey, maple syrup, pickles, baked goods, oysters, flowers, and a variety of other products produced in Massachusetts.

We spent the afternoon meeting one-on-one with legislators and other ag stakeholders to discuss important and enduring issues that impact the cranberry industry today. The opportunity to talk with law and policy-makers is hugely important, and allows the industry to build a strong and sustainable support system. Ag Day was overall a fun, refreshing experience, that was very well attended by legislators, staff and State House employees. It was a great opportunity to showcase the importance and diversity of agriculture to the Commonwealth. We were so happy to have it back after a three-year pause due to the pandemic.



The Cranberry Educational Foundation is pleased to announce the application process for the 2023 Merit Award. The Mission of the Cranberry Educational Foundation is to introduce the American cranberry, cranberry farming and its heritage to the communities, neighbors and visitors in the area. This quality educational outreach will enrich understanding and provide strong relationships throughout the community.

Funds raised throughout the year are used to offer three scholarships to any high school or college student in the cranberry growing towns in Massachusetts who are furthering their education. However, individuals studying in the fields of cranberry agriculture, natural resources or the environment will receive priority.

CRANBERRY BOG RENOVATION TAX CREDIT UPDATE

We have some news on the bog renovation tax credits. The 2020 refunds have been finalized and growers are starting to see them appear in their bank accounts. The 2021 credits were supposed to be finalized by the end of March and then submitted for payment, which based on the 2020 applications, can take several more weeks to process. The 2022 returns are not close to being finalized and certainly will not be ready when taxes are due this year. This means that anyone waiting on a 2022 credit should either file for an extension on your taxes or file an amended return when they are complete. Check with your accountant as to what will work best for you. We are engaged with the state to see if the process may be faster in the future. With only one tax credit available per year at this point, that alone should speed up the process.

To assist Plymouth County Extension and the New England Center of Excellence in Vector-Borne Diseases, we are helping to distribute a new survey about tick and mosquito-borne diseases. They sent out a similar survey a couple of years ago, but they are looking to gather more data over a wider area this time. They are hoping to get opinions from the cranberry industry.

The survey is to learn more about what people are and are not doing to protect themselves against ticks and mosquitoes – Very important information that's pretty challenging to gather normally.

There are numerous grant opportunities now available through the Massachusetts Department of Agricultural Resources. Highlights of the programs are found below. For more information on all of these programs and more, visit the [MDAR website](#).

Cranberry Bog Renovation Grant Program

Funding to implement cranberry bog renovations that promote more efficient bogs both in design and production while enhancing the business and environmental sustainability of the cranberry operation.

This grant program is currently accepting applications. Applications are due by 4:00pm on Friday, May 26th, 2023.

Climate Smart Agriculture Program (CSAP)

The Climate Smart Agriculture Program links MDAR's water, energy and climate grants together into one application. This includes the Agricultural Climate Resiliency & Efficiencies (ACRE) Program, the Agricultural Environmental Enhancement Program (AEEP), and the Agricultural Energy Grant Program (ENER). **This grant program is currently accepting applications. Applications are due by 4:00pm on Friday, May 26th, 2023.**

Agricultural Climate Resiliency & Efficiencies (ACRE) Program

This grant program is for the implementation of projects that help the agricultural sector adapt to climate change, mitigate climate change, improve economic resiliency, and advance general goals identified in the Massachusetts Local Action Food Plan.

Agricultural Environmental Enhancement Program (AEEP)

This grant program is for the implementation of agricultural conservation practices that reduce or prevent negative impacts to the Commonwealth's natural resources that may result from agricultural practices, while maintaining sustainability and productivity of the agricultural operation.

Agricultural Energy Grant Program

This grant program is for the implementation of agricultural projects that improve energy efficiency and facilitate adoption of alternative clean energy technologies.

Agricultural Food Safety Improvement Program (AFSIP)

This grant program is for the implementation of practices that prevent or reduce food safety risks for produce or aquaculture operations, meet regulatory requirements, and improve market access.

This grant program is currently accepting applications. Applications are due by 4:00pm on Friday, May 26th, 2023.

Farm Energy Discount Program

This program provides discounts on electricity and natural gas bills. Discounts are 10% to eligible entities engaged in production agriculture. Certification by the Massachusetts Department of Agricultural Resources (MDAR) is required. MDAR must approve eligible persons or corporations.

GAP/GHP Reimbursement

This program funds research projects that address challenges and opportunities in marketing, transportation, and distribution of agricultural products.

Any grower located in the Commonwealth of Massachusetts that applies must complete the USDA GAP/GHP or Harmonized audit.

Eligible parties may apply for reimbursement to cover the cost of the audit if they are successful.

Rollover Protective Structure (ROPS) Retrofit Program

7 out of 10 farms are out of business within five years of a fatal tractor rollover. It makes sense to protect yourself, your family and your business. Rollover protective structures (ROPS) are 99% effective in preventing rollover deaths and injuries.

This grant program will rebate 70% of the cost of purchasing and installing the ROPS (up to \$865 maximum rebate). Rebate funds are good towards the price of the ROPS kit, shipping charges, tax, professional installation costs, and a sun canopy. You can buy and install the ROPS kit (rollbar and seatbelt) as well as any of the previous items.

Farm Viability Enhancement Program (FVEP)


FVEP provides business planning and technical assistance to help established farms identify strategies to increase farm viability. Participants selected to participate in the program may be offered grant funds of \$75,000 - \$165,000 to implement strategies identified in the planning process in return for signing an agricultural covenant on the farm property for a 10 or 15-year term.

This grant program is currently accepting applications. Applications are due by 4:00pm on Monday, May 1st, 2023

Matching Enterprise Grants for Agriculture Program (MEGA)

This grant program assists beginner farmers who are between 1 and 10 years in business by providing technical assistance and business planning. Grant funds of up to \$10,000, \$20,000, or \$30,000 may be available with a 1:1 match to assist farmers whose goal is to raise agricultural products and who are developing their farms into commercially viable operations.

This grant program is currently accepting applications. Applications are due by 4:00pm on Monday, May 1st, 2023.





UPDATES FROM THE CMC

Per the CMC's Marketing Order, a Continuance Referendum is conducted every four years in May to ascertain whether continuance is favored by growers. The next referendum is scheduled for May 2023 and USDA will be sending ballots to all growers of record from the last complete crop year, 2021. The order states: "The Secretary shall terminate the provisions of this part whenever he finds by referendum or otherwise that such termination is favored by a majority of the growers: Provided, That such majority has, during the current fiscal year, produced more than 50 percent of the volume of the cranberries which were produced within the production area. Such termination shall become effective on the last day of July subsequent to the announcement thereof by the Secretary." It is important to note that, "USDA considers the results of the referendum **and** all other relevant information concerning the operation of the order and the relative benefits and disadvantages to the growers, processors and consumers in order to determine whether continued operation of the order would tend to effectuate the declared policy of the Act." Ultimately, it is the USDA Secretary who has the final say on the continuance or termination of the Cranberry Marketing Committee.

In April, CMC will be sending an Impact Report to all growers. This document provides a recap of the work the CMC has done between 2018 and 2022, as well as some background and explanation of how the Marketing Order operates. As the industry prepares for the upcoming Continuance Referendum in May 2023, we wanted to provide you with a tool to understand precisely how your assessment dollars are being spent and what kinds of returns you are getting on your investment.

- **Cropland Harvested** – This land represents the highest use of land in the agricultural enterprise. All land from which a crop was harvested, or hay was cut, in the current year falls into this category. This includes the land in vegetables, sod, nurseries, orchards, vineyards, other perennial plantings, and greenhouses.
- **Dairy, Beef and Hay; Cropland Pastured, Other Cropland & Permanent Pasture** – Cropland used for pasture or grazing, or land considered as tillable but is elected to be fallow or in cover crops. It can and often is used to produce crops, but its maximum income may not be realized in a particular year. This category also includes land planted in crops, which were to be harvested after the census year, and land is typically not tillable, best suited for grazing or possibly part of an erosion control program, plus necessary and related lands.
- **Nonproductive Land** – The land on the farm which is nonproductive primarily due to slope, drainage capacity, soil type or topography.




