#### **CANCELLATION POLICY**

A refund 50% of the amount may be issued up until 15 business days before the event. For cancellations after 15 business days refunds will not be given.

Virtual visibility placements (logos, videos, banners, platform listings, shoutouts, etc.) may vary based on platform and technical limitations. MichBio is not responsible for third-party platform outages, internet interruptions, or technical failures beyond reasonable control. MichBio will make reasonable efforts to deliver all agreed-upon benefits.

#### PLATFORM USAGE & CONDUCT

Sponsors/exhibitors must abide by professional conduct standards within the virtual platform (chat, breakout rooms, Q&A, etc.).
