# GENERAL INFORMATION

## Convention Goals

In the past, the Michigan Pharmacists Association (MPA) has adapted to meet the demands and limitations of public health crises and at the same time, continued to deliver an engaging, high-quality experience for pharmacy professionals throughout Michigan and beyond. MPA is excited for its last year at the Convention site in Detroit. MPA's goals for the Annual Convention include the following:

- Provide quality continuing education programs, focusing on the latest treatment options and hottest issues in pharmacy
- Offer various networking options for attendees
- Facilitate opportunities for attendees to discuss the outlook of pharmacy
- Celebrate the future of pharmacy by honoring Michigan's pharmacy leaders
- Provide activities for attendees to continue their professional development

## Target Audience

Programs at the Annual Convention were planned to meet the needs of pharmacists, residents, pharmacy technicians and student pharmacists in a variety of practice settings, as well as those in the pharmaceutical industry and academia.

## Cancellation Policy

Cancellations after Feb. 10, 2024, no-shows or changes made onsite to registrations will not be refunded. Refunds will not be given for inclement weather, nor will refunds be given due to registration errors made by the participant.

If you selected convention attendance with a new membership purchase through the registration process, you will not be eligible for a refund should you choose to cancel your event attendance. If convention attendance cancellation is necessary, you must contact the MPA office directly to process your cancellation and keep your membership intact.



## Parking at the Renaissance Center

Parking facilities are not owned or operated by the Detroit Marriott at the Renaissance Center.

Note: Parking facilities are not able to extend discounted parking to Convention attendees.

- Port Atwater Parking – Accessible from Beaubien Street near Tower 200
- Beaubien Parking – Accessible from Beaubien Street (this garage is recommended by MPA as guests will have in-and-out access each day for \$25)

## Program Restrictions

Children under 16 years of age will not be allowed in the educational sessions or the exhibit hall. All guests in the MPA convention space must be registered for the convention and be wearing their registration badge. If you wish to bring a guest with you into the convention space, that guest must be registered and have an attendee badge. The cost to register a guest who will not claim CE credit is \$250.

If you register a guest, you are confirming your guest will not claim CE credit.

By registering, you acknowledge that your information will be provided unless you opted out on the registration form. # GENERAL INFORMATION

## Continuing Education Accreditation

The profession of pharmacy has moved in a direction that focuses on continuous professional development (CPD) for pharmacists and pharmacy technicians. MPA plays a critical role in CPD and aims to provide continuing education programs that support the continued development of pharmacy professionals and enhance competency. In an effort to assist you in targeting programs that will enhance your professional development, these activities are accredited through the Accreditation Council for Pharmacy Education (ACPE) for pharmacist and pharmacy technician continuing education credit.



*Michigan Pharmacists Association is accredited by the Accreditation Council for Pharmacy Education (ACPE) as a provider of continuing pharmacy education.*

Individuals have the opportunity to earn up to 14 hours of LIVE continuing pharmacy education (CPE) credit throughout the weekend. Educational activities are structured to meet knowledge- and application-based educational needs. A knowledge-based activity acquires factual knowledge. An application-based activity applies to information learned in the timeframe allotted. Information in knowledge- and application-type activities is based on evidence as accepted in the literature by the healthcare professions. CPE credit will be earned based on participation in individually accredited activities. Attendance and participation are required before obtaining CPE credit. **Any individual who is more than 15 minutes late to an activity or leaves an activity early will not be granted CPE credit.** This procedure will be strictly enforced, so please plan accordingly.

CPE Monitor is a national, collaborative effort by the Accreditation Council for Pharmacy Education (ACPE) and the National Association of Boards of Pharmacy (NABP) to provide an electronic system for pharmacists and pharmacy technicians to track their completed CPE credits. To obtain your e-profile ID, visit [MyCPEMonitor.net](http://MyCPEMonitor.net). Pharmacists and pharmacy technicians earning continuing education credit, while meeting all requirements, will be able to view a comprehensive list of the ACPE-accredited activities they have taken on their CPE Monitor account.

MPA reserves the right to revoke continuing education credit for individuals who have not paid the registration rate in full or to participants who claim to have attended programs on days for which they were not registered. Partial credit will not be awarded.

## Required Continuing Education

Continuing education requirements for licensed Michigan pharmacists and pharmacy technicians are indicated below.

Pharmacists are required to earn (inclusive of the 30 hours normally earned in a licensure period):

- 10 hours of live CPE credit that provide direct interaction between faculty and participants
- One hour of pain and symptom management CPE credit
- One hour of pharmacy ethics and jurisprudence
- In addition to the 30 hours of required continuing education credit hours, licensure renewal cycles effective June 1, 2022 must complete two hours of implicit bias training

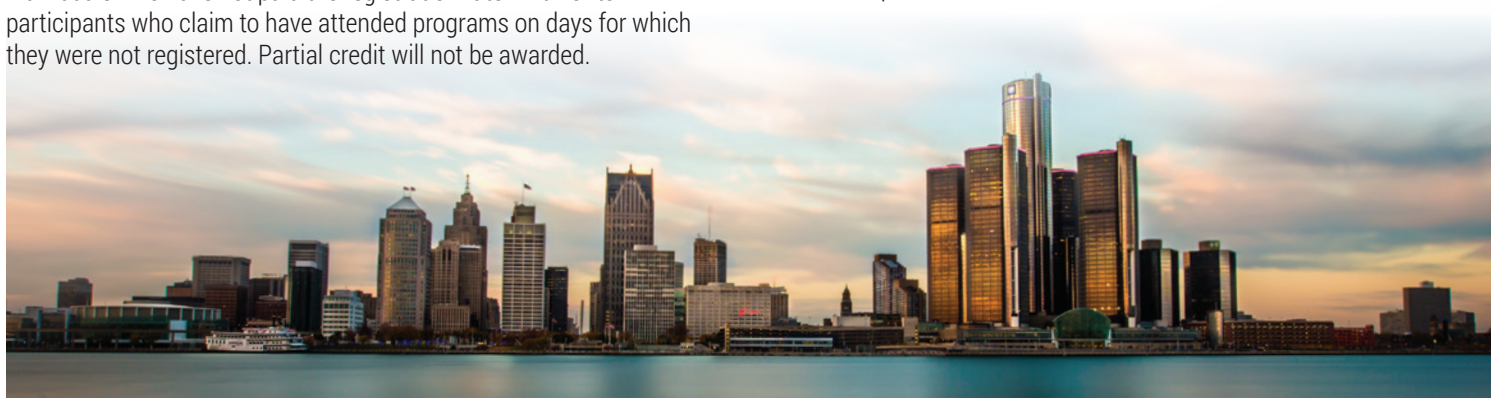
Pharmacy technicians are required to earn (inclusive of the 20 hours normally earned in a licensure period):

- Five hours of live CPE credit
- One hour of patient safety CPE credit
- One hour of pharmacy ethics and jurisprudence
- One hour of pain and symptom management CPE credit
- In addition to the 20 hours of required continuing education credit hours, licensure renewal cycles effective June 1, 2022 must complete two hours of implicit bias training

Look for pain, law, ethics and jurisprudence, patient safety, controlled substance awareness training and implicit bias training symbols next to continuing education programs in this brochure that meet education requirements. Additionally, according to state law, both pharmacists and pharmacy technicians must complete a one-time course on identifying victims of human trafficking.

In order to bill for medication therapy management (MTM) services for Medicaid beneficiaries, pharmacists must have successfully completed MTM program(s) approved by the Accreditation Council of Pharmacy Education.

State regulations mandate that pharmacists and pharmacy technicians cannot earn more than 12 hours of CPE credit in a 24-hour period.





# GENERAL INFORMATION

## Process to Claim Continuing Education Credit

Participants will be required to register for and complete program evaluations and applicable posttests through Lecture Panda.

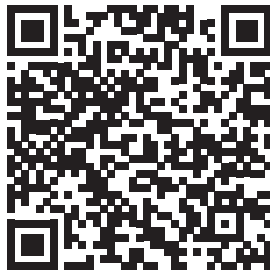
### INSTRUCTIONS

To earn pharmacy continuing education credit, complete the following steps.

1. Register with Lecture Panda – Prior to the Convention, you should have registered on the Lecture Panda website and set a username and password of your choice and provided your e-profile identification number and date of birth (MMDD format).

- If you have already registered on the Lecture Panda website, move to step 2 below.
- If you did not register on the Lecture Panda website, you must do that first. To do so, go to <https://www.lecturepanda.com/a/2024-MPA-AnnualConventionExposition> and click on the blue REGISTER button.

You **MUST** register to be able to claim CE credit. You can also scan the QR code with your cell phone or tablet to be directed to the Convention event page on the Lecture Panda website.



Upon registering on Lecture Panda, you will receive an email confirming registration with a link to complete credit requirements. This link allows you access to all program handouts, evaluations and posttests. To avoid emails going to your spam folder, be sure to set up your email account to allow emails from Lecture Panda.

2. Access Handouts – To access program handouts, refer to the registration confirmation email that you received from Lecture Panda and click on the blue button titled “Complete Credit Requirements.” You will be directed to all program handouts where you can conveniently pull them up on your PC, cell phone or tablet, or you can print them if you wish to have hard copies. **Please note hard copies of handouts will not be provided onsite;** however, you may go to the hotel’s business center to make copies for a fee.

3. Claim Credit – To complete all evaluations and posttests for programs that you attended and “claim credit”, refer to the registration confirmation email that you received from Lecture Panda and click on the blue button titled “Complete Credit Requirements.” You will be directed to confirm your name, email address, e-profile identification number and date of birth. Progress to the “Claim Credit” screens, where you will enter the program claim code provided at the end of each program and complete the evaluations and posttests. More information about program claim codes is below. Upon completion of the evaluations and posttests, credit will automatically be submitted to your CPE Monitor record. You must pass each posttest with a score of 70 percent or greater to earn credit.
4. Overall Event Evaluation – MPA would like to know about your overall experience while attending the Convention. Please be sure to complete the overall event evaluation on Lecture Panda in addition to program evaluations. Your feedback is used to improve the Convention and other MPA events.

## Program Claim Codes

When completing evaluations and posttests, you will be required to enter a “claim code” unique to each program. Be sure to listen at the end of each program to receive that program’s claim code. **Program claim codes will not be provided to participants after participants are released from the program.** It is recommended that you keep track of program claim codes by recording them as they are provided during sessions.

Posttest questions are not applicable to application-based programs; however, evaluations must be completed. For knowledge-based programs in which presenters did not submit posttest questions, attendees will not be penalized. MPA, as an ACPE-accredited provider, is required to report pharmacist and pharmacy technician CPE credit to CPE Monitor. ACPE guidelines prohibit MPA from issuing credit 60 days or more after the activity for any reason. Therefore, to avoid denial of credit, it is imperative that pharmacists and pharmacy technicians complete the online evaluations and posttests before April 23, 2024. Evaluations and posttests will not be available for completion and requests to process credit will not be accepted after this date. You will receive periodic emails from Lecture Panda reminding you to complete requirements. Due to this process, participants will not receive an attendance form to record programs attended.

### DETROIT, MICHIGAN

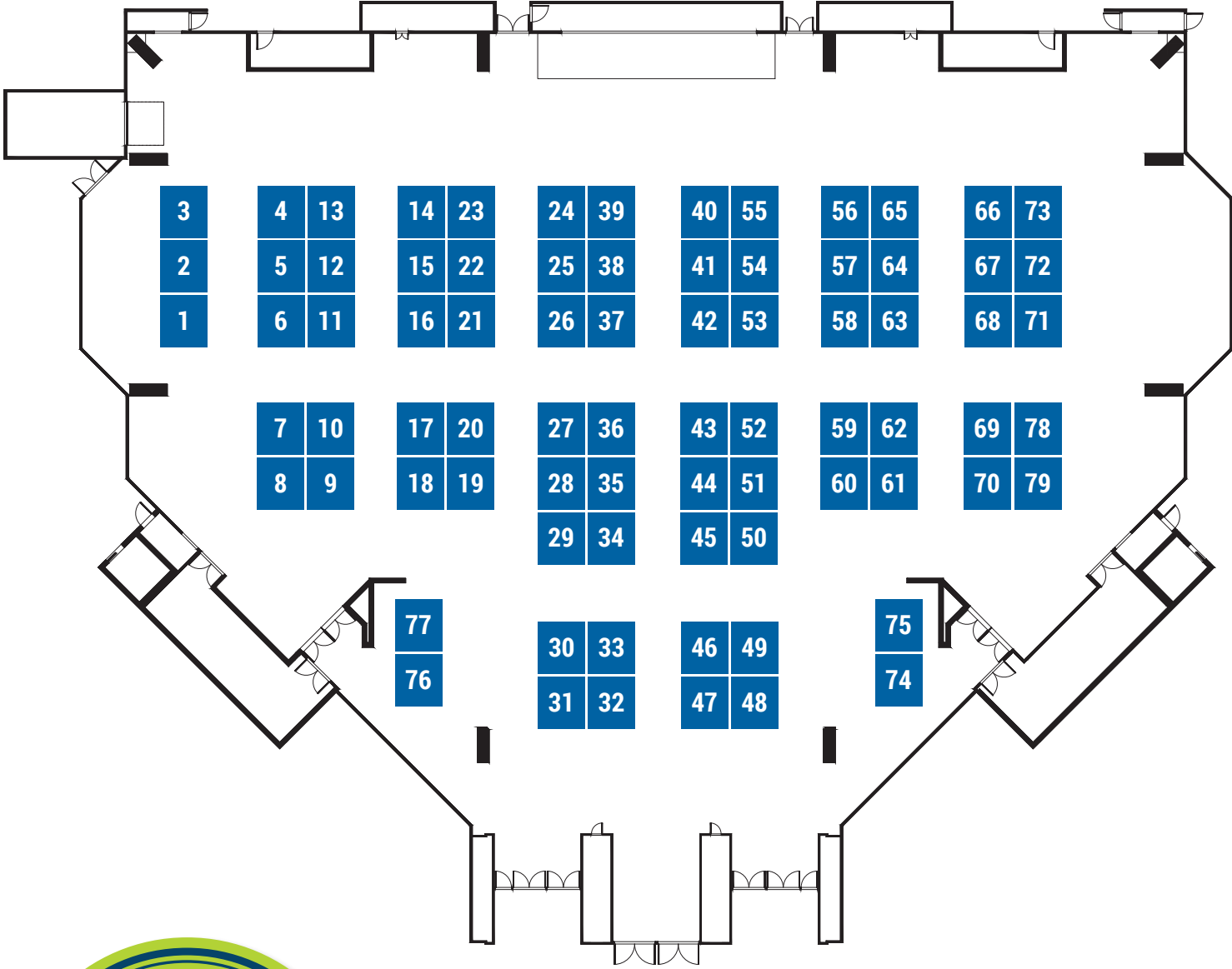


Exhibit Hall Entrance

# BOWL OF HYGEIA AWARD

The Bowl of Hygeia derives its name from the Greek goddess of the same name, who was the goddess of health, cleanliness and hygiene. The Bowl of Hygeia Award is given to a pharmacist who has made outstanding professional contributions and has participated in community or governmental activities that reflect well on the profession.

A 1981 Ferris State University graduate and metro Detroit native, Samojedny began his career at Nortown Drugs on 7 Mile and Ryan roads in Detroit, a pharmacy he owned and operated along with his father and brother. In 2012, he was tasked by Henry Ford Health System to lead Pharmacy Advantage, where he is now the director of specialty pharmacy operations. The Michigan Pharmacists Association (MPA) Pharmacist of the Year Award is presented annually as the highest honor in Michigan pharmacy. He served as adjunct clinical faculty for the colleges of pharmacy at the University of Michigan and Ferris State University.

Wagenknecht currently serves as chairman of the Michigan Health Information Network Shared Services board. He also served as member of the board of governors of the Pharmacy Technician Certification Board and chair of the Michigan Healthcare Stakeholders Opioid Stewardship Collaborative. He also served as the 2000-01 president of the National Alliance of State Pharmacy Associations (NASPA) and served as secretary and governor of the University of Michigan College of Pharmacy Board of Governors. He has also served on numerous other committees and task forces with the state of Michigan, including the Prescription Drug and Opioid Abuse Task Force and Commission, Michigan Patient Safety Commission and the Michigan Health Information Technology Commission.

Wagenknecht and his wife Amy live in Haslett and have two sons: Bryan, of Boston, and Jonathan, of Austin, Texas. They also have two granddaughters, Anna and Mabel, in Boston.

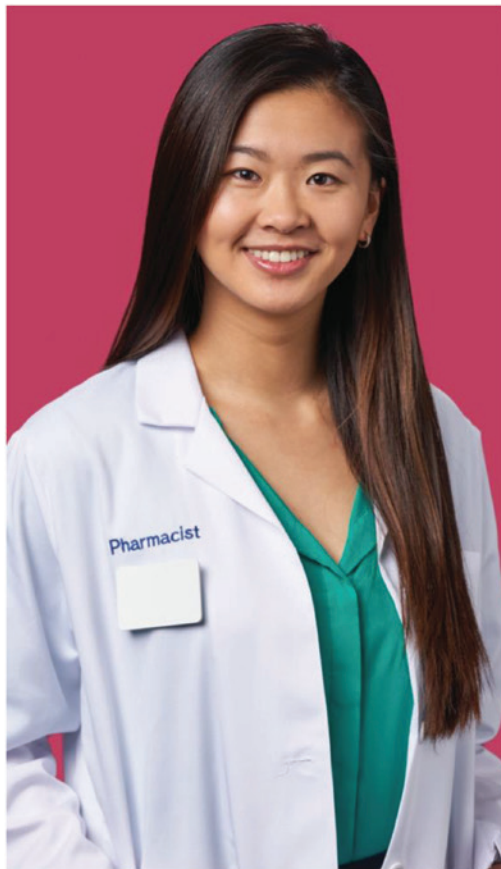

## Important Safety Information

### Warnings and Precautions

- **Risk of Thyroid C-Cell Tumors:** Patients should be further evaluated if serum calcitonin is measured and found to be elevated or thyroid nodules are noted on physical examination or neck imaging
- **Acute Pancreatitis:** Acute pancreatitis, including fatal and non-fatal hemorrhagic or necrotizing pancreatitis, has been observed in patients treated with GLP-1 receptor agonists, including semaglutide. Acute pancreatitis was observed in patients treated with Wegovy® in clinical trials. - **Acute Gallbladder Disease:** Treatment with Wegovy® was associated with an increased occurrence of cholelithiasis and cholecystitis. The incidence of cholelithiasis and cholecystitis was higher in Wegovy® pediatric patients aged 12 years and older than in Wegovy® adults. In clinical trials in adult patients, cholelithiasis was reported by 1.6% of Wegovy® patients and 0.7% of placebo patients. Cholecystitis was reported by 0.6% of Wegovy® patients and 0.2% of placebo patients. In a clinical trial in pediatric patients aged 12 years and older, cholelithiasis was reported by 3.8% of Wegovy® patients and 0% placebo patients. Cholecystitis was reported by 0.8% of Wegovy® pediatric patients and 0% placebo patients. Substantial or rapid weight loss can increase the risk of cholelithiasis; however, the incidence of acute gallbladder disease was greater in Wegovy® patients than in placebo patients, even after accounting for the degree of weight loss. If cholelithiasis is suspected, gallbladder studies and appropriate clinical follow-up are indicated
- **Hypoglycemia:** Wegovy® lowers blood glucose and can cause hypoglycemia. In a trial of adult patients with type 2 diabetes, hypoglycemia was reported in 6.2% of Wegovy® patients versus 2.5% of placebo patients. 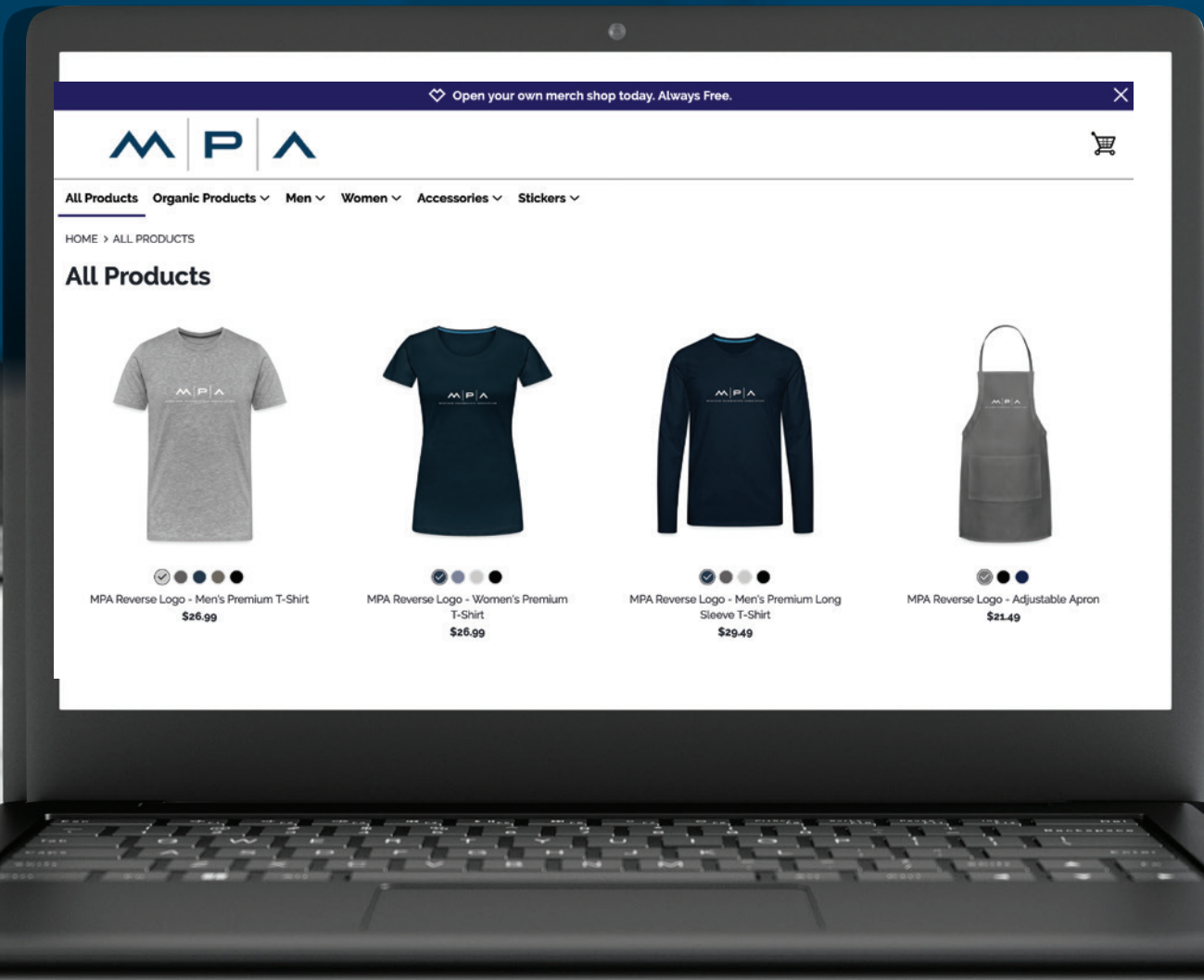
