

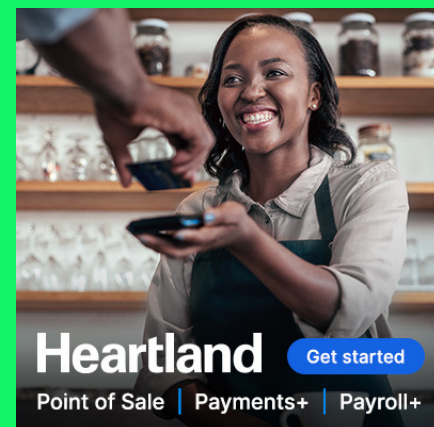


## Stay in Compliance with Liquor Control

Compliance with the elimination of Liquor Cards, assisted by the GKCRRA, is essential following the legislative changes in 2023. While employees are no longer required to obtain liquor permits, establishments must now enforce strict measures to prevent individuals with convictions related to sex crimes from selling alcoholic beverages. Additionally, at least one manager or supervisor must possess ServSafe Alcohol training or an equivalent certification, which must be kept on-site. Prior to hiring personnel for alcohol-related positions, licensees must diligently verify their eligibility by cross-referencing three designated databases for any records of sex crime convictions. As we gear up for summer and the potential for opening up patios, it's crucial to ensure compliance with these regulations to be prepared for routine inspections conducted by liquor control authorities.

This includes a current list of employees, color copies of identification for alcohol-serving staff, proof of alcohol manager certification, and a checklist of background checks conducted on employees. By adhering to these guidelines, establishments can uphold the highest standards of safety and compliance while efficiently managing their operations. 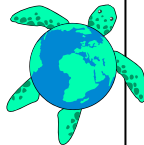
