Association Political Activity



- History
 - First Amendment:
 - Right to Petition Government
 - Right to Associate:
 - "[W]e have long understood as implicit in the right to engage in activities protected by the First Amendment a corresponding right to associate with others in pursuit of a wide variety of political, social, economic, educational, religious, and cultural ends."
 - *Roberts v. U.S. Jaycees*, 468 U.S. 609, 622 (1984)
 - "[T]he First Amendment safeguards an individual's right to participate in the public debate through political expression and political association." *McCutcheon v. FEC*, 572 U.S. 185, 203 (2014).

How is Protection Asserted?

- By a Party
 - Objection to a Discovery Request/Deposition Question
- By a Non-Party
 - Motion to Quash Third-Party Subpoena (Lupient Milwaukee, Inc., v. Nissan North America, Inc. (Case No. 18-cv-02023-JPS, ECF 32).



Protection Against Disclosure of Association Information



- The First Amendment Privilege (Historically)
 - "The Supreme Court has long recognized that compelled disclosure of political affiliations and activities can impose just as substantial a burden on First Amendment rights as can direct regulation." AFL-CIO v. FEC, 333 F.3d 168 (D.C. Cir. 2003).
 - "[W]here, as here, the Commission compels public disclosure of an association's confidential internal materials, it intrudes on the 'privacy of association and belief guaranteed by the First Amendment as well as **seriously interferes with internal group operations and effectiveness**." *Id.* at 177-78 (emphasis added).
 - "The freedom to associate with others for the common advancement of political beliefs and ideas lies at the heart of the First Amendment." *Perry v. Schwarzenegger*, 591 F.3d 1147, 1152 (9th Cir. 2010).
 - "Compelled disclosures concerning protected First Amendment political associations have a profound chilling effect on the exercise of political rights." Id. at 1156.
 - "Implicit in the right to associate with others to advance one's shared political beliefs is the right to exchange ideas and formulate strategy and messages, and to do so in private." *Id*.
 - "Questions concerning the constitutionality of state law are not decided upon review of campaign contributions, candidate support, a citizen's view of the law, or the like.... A decision on the merits of these claims does not hinge on the opinions or activities of FADA or even the motives or opinions of the legislators passing the Amendments." Alliance of Auto. Mfrs., Inc. v. Jones, Case No. 4:08cv555-MCR/CAS, 2013 WL 4838764 (N.D. Fla. Sept. 11, 2013)
