THE AMERICAN RESCUE PLAN AND DEPARTMENT PRIORITIES

The American Rescue Plan is aligned with the U.S. Department of Education (Department) commitment to on "Raising the Bar" in education – in three key areas: academic excellence; improving learning conditions; and preparing our students for a world of global competitiveness.

Within those themes, there are 6 strategies: accelerating learning, developing a wellrounded education, eliminating the educator shortage, investing in mental health, ensuring every student has a postsecondary pathway, and a pathway to multilingualism.

Secretary Cardona's priorities:

- Support students through pandemic response and recovery
- Boldly address opportunity and achievement gaps
- Make higher education more inclusive and affordable
- Ensure pathways through higher education lead to successful careers

HOW THE U.S. DEPARTMENT OF EDUCATION SUPPORTS GIFTED EDUCATION PROGRAMS



- The Elementary and Secondary Education Act of 1965 (ESEA), as amended by Every Student Succeeds Act (ESSA), emphasized the importance of providing a well-rounded education to all students. States and local districts have the discretion to define specifically what a well-rounded education means for students and how to best use Federal, State and local funds to meet the needs of their students to provide a well-rounded education. Title I provided more than \$18 billion in FY23 to States, school districts, and schools.
- We provide support for gifted and talented programs through discretionary grants: Javits Gifted and Talented Students Education Program

WHAT IS THE JAVITS PROGRAM?



Focus Areas

- Serving underrepresented students in gifted and talented programs
- Students in need of Educational Opportunities

• Eligible applicants must be one or more of the following:

- State educational agency;
- Local educational agency;
- Bureau of Indian Education;
- Institution of Higher Education;
- Other public agency; or
- Other private agency or organization.

ABSOLUTE PRIORITY FOR JAVITS GRANTS

Projects designed to develop new information that assists schools in the identification of, and provision of services to, gifted and talented students (including economically disadvantaged individuals, individuals who are English learners, and children with disabilities) who may not be identified and served through traditional assessment methods.

Jacob Javits Gifted and Talented Students Education Act Part of the ESEA of 1965 Funded \$9.6 Million

HISTORY OF THE JAVITS PROGRAM



No Child Left Behind (NCLB) – Reauthorized Reauthorized Section 4644 of the ESEA (program authority) Funds increased to \$12 Million Every Student Succeeds Act (ESSA) Federal funding continues to increase each year Currently at \$14.5 million
