As a follow up to our unprecedented "mandatory" dealer meeting in Greensboro in late August, the NCADA Board of Directors is set to meet this fall to continue to discuss plans to protect the automotive retail system and North Carolina automotive consumers. With more than 200 dealer attendees at the meeting, the clear consensus of the dealers was to take any and all efforts to tirelessly and aggressively protect our dealerships, our customers, our employees, our families and more importantly, our livelihoods. As stated by Robert Glaser in the meeting, "Failure is not an Option" when defending our industry.

As an NCADA dealer member, what role can you play to add to our collective efforts to protect ALL members?

• <u>Invite your Local NC House or Senate Member to your Dealership:</u> This is the single most important role you can play. Having a local House or Senate member to your dealership, introducing them to your employees and walking them through your dealership IS THE MOST IMPORTANT ROLE you can play.

Explain to them the number of employees you have, the civic organizations you support and the history that you have as part of your community. By introducing them to your employees, they have a better understanding of the economic value you provide to your local community. Lastly, take their picture with a group of your employees in the dealership and send it to NCADA... We will post it as part of our social media plan.

• <u>Support the NCADA AutoPAC</u>: Since the early 1990s, NCADA's PAC has supported those NC House and Senate members who are pro-dealer and pro-business. We need more candidates who clearly understand business issues. Your NCADA PAC contributions go a long way in helping this happen.

**GREENSBORO AUGUST 25, 2022** 



As part of NCADA's overall plan to protect the franchise system in response to multiple attacks on our industry, an important "All Dealer" meeting was called by the NCADA Board of Directors in late August.

The objective was to provide all NCADA dealer members with a critical update on the status of multiple issues threatening the industry's future. Including a special presentation from North Carolina Representative Ted Budd, industry discussions at the meeting focused on factory direct sales, build-to-order sales model, new EV sales channels, over-the-air updates, OEM subscription programs, and other critical issues.





The overarching goal of the meeting was to produce an overall strategy for North Carolina Dealers related to the several industry trends that are buffeting the industry. As part of the meeting, NCADA also updated dealers on the status of the NCADA Dealer Response Team and the status of efforts by several startup EV companies to sell directly to consumers in North Carolina.
