2021 was a banner year for NCBIO members and the life science industry in North Carolina with 19 major expansions, relocations or new facilities representing almost \$4 billion in investment and more than 4,000 jobs were announced across the state. Highlights from NCBIO members included:

- FUJIFILM's announcement of a \$2 billion biopharmaceutical manufacturing plant in Holly Springs that will bring 725 jobs paying an average salary of just under \$100,000 a year. The facility will be the largest end-to-end cell culture production plant in North America.
- Amgen will build a \$550 million manufacturing plant in Holly Springs creating 355 jobs from 2025 through 2029, at an average wage of nearly \$120,000.
- Thermo Fisher Scientific announced projects in Mebane, Asheville and Greenville that will collectively bring over \$350 million in investments and nearly 700 jobs.
- Biogen will invest \$200 million in a new facility on its RTP campus to support clinical production for its gene therapy pipeline and add 90 jobs to its RTP workforce of about 1,900 people.
- Cambrex Corp. will invest \$30 million and hire 78 more employees to expand its production capabilities in High Point.

I am also very pleased to report that the Sam Taylor Memorial Scholarship surpassed \$200,000 in gifts and pledges by the end of 2021. This generosity has put our goal of raising \$250,000 to fund four scholarships each semester in the NC Community Colleges System well within reach. Thank you to everyone who has given, and if you would like to make a gift, you can find more information here.

Finally, 2022 will see NCBIO continue to focus on educating legislators on the tremendous successes and opportunities of the life science industry here in NC. As we pursue policies designed to support the industry, please be sure you are talking to us about your pain points in addition to your successes. Our goal is to create the policy environment that will help you innovate to improve the lives and well-being of North Carolinians and people around the world.

New One NC Small Business SBIR/STTR funds available soon

As soon as the new state budget for Fiscal Year 2022 is certified, \$5 million in matching funds will be available to North Carolina companies applying for federal Small Business Innovation Research Program or Small Business Technology Transfer awards.

On Nov. 18, the legislature and governor enacted a two-year budget that includes \$5 million a year for the One NC Small Business Program. For the first time, the program's funding includes \$2 million in recurring funds that will be available each year, along with an additional \$3 million appropriated for FY 2022 and for FY 2023.

According to the NC Department of Commerce, the budget still has to be certified before One NC Small Business Program solicitations can be issued. Certification may not be complete until early-mid January. As soon as it is complete, solicitations for both the Phase I SBIR/STTR Incentive Program and the Phase I SBIR/STTR Matching Program will be available.

The SBIR/STTR Phase I Incentive Funds Program provides reimbursement to qualified North Carolina businesses for a portion of the costs incurred in **preparing and submitting** Phase I SBIR or STTR proposals to federal agencies.

The SBIR/STTR Phase I Matching Funds Program awards matching funds to North Carolina businesses who have **received** a federal Phase I Small Business Innovation Research Program or Small Business Technology Transfer award.

Companies compete for funding under these programs by submitting proposals in response to solicitations issued by participating federal agencies. The federal SBIR/STTR Program provides for funding competitions in two phases that are relevant to the North Carolina program:

- Phase I to conduct feasibility research (awards are generally \$50,000–\$250,000 for six months to one year)
- Phase II to expand and develop phase I results and develop commercially viable innovations (awards are generally \$750,000 for two years).

## Redistricting challenge making its way through courts

A Wake County Superior Court panel of three judges heard arguments on legislative and congressional districts Jan. 3-6. The NC Supreme Court instructed the three-judge panel to reach a decision by Jan. 11. Whatever the decision, it is expected to be appealed to a higher court.

If the Republican-drawn maps stand, the party is likely to win 10 or 11 of the 14 U.S. House races up for grabs in the 2022 midterm elections.

If the Supreme Court ultimately finds the maps unconstitutional, the court will decide who should redraw the maps and when the maps take effect. The delay created by the litigation over the maps and the scheduling of primary election will also affect the start date of the legislative short session, which typically begins in mid-May.

## Woodard, White join new health care, Medicaid committee

This week, NC Senate and House leaders assigned Life Sciences Caucus co-chairs Sen. Mike Woodard (D-Durham) and Rep. Donna White (R-Johnston) to the Joint Legislative Committee on Access to Healthcare and Medicaid Expansion, a committee that was established in the 2021 budget.

# OSHA COVID-19 vaccine mandate for large employers back in force (for now), Supreme Court to weigh in

In the ongoing legal battle over the Occupational Safety and Health Administration's emergency temporary standard on COVID-19 vaccination and testing, the United States Court of Appeals for the Sixth Circuit has allowed OSHA to move forward — for now — with enforcement. However, the U.S. Supreme Court is set to hear challenges today, Jan. 7, to the vaccine-or-test requirement and to the CMS requirement for health care workers.

The core of the order is the requirement that employers with more than 100 employees must implement and enforce a mandate that employees be fully vaccinated against COVID-19 by Jan. 4 or to submit to weekly COVID-19 testing and wear a mask.

However, in light of the numerous legal challenges and the uncertainties caused by the conflicting decisions in federal court, OSHA has stated that it will exercise its "enforcement discretion" to give employers some additional time to comply with deadlines published in the original order. OSHA said that it will not issue any citations for noncompliance with its vaccine and testing requirements before Jan. 10 and will not issue citations before Feb. 9 so long as employers are attempting to comply in good faith.

No final decisions have been reached regarding the government contractor vaccine mandate. The nationwide injunction remains in effect, and separate, more limited injunctions have been issued by other federal courts.

The United States Patent and Trademark Office published a <u>notice in the Federal Register</u> announcing an extension of its COVID-19 Prioritized Examination Pilot Program. Requests that are compliant with the program's requirements and are filed on or before March 31 will be accepted.

# NCBiotech partnership awarded up to \$500,000 to expand life science sector in NC

The award supports the further development of a plan to expand, connect, scale and promote the state's life sciences manufacturing cluster to power the transformation of North Carolina's economy and communities. It brings together stakeholders from academia, industry, state and local government and other nonprofits and includes seven complementary and aligned projects organized under a singular vision.

NCBiotech and its partners now advance to phase 2 of the challenge with plans to submit seven synergistic projects including developing innovation and technology development and increasing industry awareness and accessibility of training programs. The projects are all centered on expanding job opportunities in the life sciences.
