### COURSE DESCRIPTIONS

Participantswillcompleteoneofthefollowingcourseseach month of the program.

#### Leadership v. Management

Often, good leadership is mistakenly associated with good management, but there are fundamental differences between the two, and both are critical to a project, team, and organization success. This session will out linemis conceptions about the two and share examples of each in practice. It will also challenge participants to practice managerial and leaderships cenarios to develop the critical thinking skills necessary to adapt to complex challenges of each.

#### **Fiscal & Budget Management**

Thereisincreasingscrutiny of spending practices of government at all levels. Data drives discussions regarding funding and expenditures. While budget analysts may focus primarily on debits and credits, financial managers must understand the economy as a whole and be able to read trends, fore cast challenges, and navigatelegislation pertaining to the community. This course will provide you with an understanding of both fiscal and budget managements othat you can effectively provide the necessary services to your residents. Included will be an overview of the potential revenues treams for a township and a review of a township's taxing authority per the Ohio Revised Code.

#### Analyzing Data to Make Decisions

Data analysis is the act of gathering important information to guide decision-making. This evaluation to olturns numerical data into accessible information that can helpy oude termine the best way to proceed with a projector process. By learning how to properly gather and analyzed ata, you can improve your decision-making skills in the work place. This course will explore the different types of data analysis and how to use them to make more informed decisions.

#### Innovative Technology in Government

You will also be introduced to the emerging trends and strategies for practical application in your township.

#### **Creative Problem Solving**

Bring a real challenge and leave with research-based insights and methodsfortransformingyourselfandyourtownshipintobeingmore curious,fearless,andinnovative.Throughengagingcoursediscussions and practical, challenge-driven exercises, you will learn conceptual frameworks and behavioral habits for cultivating an inquiry-driven approach to leadership and life.

#### Utilizing Strategic Planning

Strategic planning is critical for any organization that wishes to achieve its mission. An effective process also provides opport unity for critical team/organization alalignment. Goodstrategic planning can move an organization toward its desired future. But the most valuable part of strategic planning can be the actual process itself. This session will explore key questions a leader must consider in advance of beginning the process. It will include discussions on how to identify a process that will be effective, and how the final plancan be used to direct work assignments and budgets so that your organization can achieve its goals and objectives and ultimate public service mission.

#### Leading Change & Leading in a Crisis

Most leaders accept that crisis management can become a part of theirjob without warning. And similar to crisis situations, significant organizational change can be challenging and also requires deliberate communication and cooperation. Developing astructured approach to crises and change is critical to mitigate disruption, particularly in the provision of critical government services. This module will explore the different ways to lead through crises and change, including practice scenarios using the methods of change management and transition management.

#### Cybersecurity
