Each year association members have the opportunity to apply or nominate a member for a position on the PAA Board of Directors.


The PAA Nominating Committee reviews the nominations and selects the candidates.

REQUIREMENTS

- 1. Directors shall be a natural person at least eighteen (18) years of age who need not be a resident of Pennsylvania.
- 2. Directors must hold a senior-level position in their respective organization and must be able to represent their organization on important industry matters.
- 3. Directors will serve a two-year term.
