WHAT ARE THE KEYSTONE AWARDS?

The Keystone Awards are a friendly competition where apartment communities are judged on their leasing abilities, maintenance readiness, and overall community appearance and offerings.

The Keystone Awards, previously known as the PAA Best of Apartment Living Awards, are an annual competition in which properties are judged by an independent company as a revealed or secret shopping reporter. The shopper utilizes criteria developed by the Keystone Awards Committee to assess the properties overall performance -through the eyes of a prospective resident.

Why companies participate in the Keystone Awards:

- Shopping reports can be used as a training tool for new and existing employees.
- Incentive for property teams to excel and maintain a property they are proud of.
- Recognition as a premier property in PA.

The Keystone Awards registration is from March through mid-April. Properties are judged May through July, when at their peak performance.

When you register for the Keystone Awards there are two tracks to choose from:

- Property Awards are judged by age, type of property, size of property, and price.
- Individual Awards are to recognize specific team members who excel at their role. A detailed analysis of both will be described in this publication.

Updates to the program for 2024:

REGISTRATION PROCESS

To register for the Keystone Awards:

1. Go to paahq.com.
2. Login to the website using your individual username and password. If you do not have a login, please email us at membership@paahq.com.
3. From the home page, proceed to the tabs across the top of the screen and hover over events
4. Select Keystone Awards Call to Entry from the drop-down menu.
5. The registration page will provide event details and information for you to review before registering.
6. Category icons will appear as you scroll down the page. You have now arrived at the registration page and there will be a choice of property awards categories along with individual award categories.

Property Awards Categories are as follows:

- Leasing Excellence Award
- Maintenance Excellence Award
- Overall Excellence Award
- Trilogy Award (All 3 Community Awards)
- Management Company of the Year

Individual Award Categories are as follows:

- Regional Property Manager of the Year
- Property Manager of the Year
- Assistant Manager of the Year
- Leasing Professional of the Year
- Maintenance Professional of the Year
- Rookie of the Year
- Supplier of the Year

Call to entry registrations require entries to be completed with *detailed* community information. Individual award applications must complete an application form and will also need to submit a short video. All entries require payment with 30 days of submission.

AWARD DESCRIPTION & CRITERIA

PROPERTY AWARDS

- It is important to review each award description and what the mystery shopper will be looking for as they visit your property.

***Properties entered in the Trilogy Category are eligible to compete for the Regional Top Ten! Top scoring properties with the highest average scores in each region will be honored.



1 Trilogy Award Package

The Trilogy Award Package allows a management company to register a property for all three community categories in one form! The property will be entered in the Leasing Excellence, Maintenance Excellence, and Overall Excellence categories (2,3,4) described below. This is the highest excellence Award.

2 Leasing Excellence

Your community will be judged specifically on how well the property leases apartments.

Judging includes:

- Reviewing the property's website, response to leasing questions via the internet, telephone skills, and an in-person tour.
- The judge will review every aspect of the leasing process. This is a 'mystery shop'.
- Evaluations for this category will take place between May 15th through July 31st.
- The top three highest scores will be based upon community size, price, type, and age.

3 Maintenance Excellence

This category is specific to the apartment community's overall level of care. Judging includes:

- A scheduled tour of the apartment community, a vacant-ready apartment, care of the amenities, common area, and maintenance programs.
- Judges will call the community with a scheduled appointment to tour.
- The tours will be scheduled from May 28th through July 31st.
- The top three highest scores will be based upon community size, price, type and age.

4 Overall Excellence

The community will be judged on:

- The community's overall appearance, maintenance, and amenities.
- This is a revealed, scheduled tour with evaluations taking place May 15th through July 31st
- The top three highest scores will be based upon community size, price, type and age.

5 Management Company of the Year

To be considered for this award, the management company shall complete **one** application in this category **AND** all properties are required to be entered in the Trilogy Award category to qualify. The Management Company who has the highest average score wins Management Company of the Year.

AWARD DESCRIPTION & CRITERIA

INDIVIDUAL AWARDS

Please note that for the Maintenance Professional and Leasing Professional individual awards you DO NOT need to be in a leadership position.

1

Regional Property Manager

To enter in this category, the Regional Property Manager's Portfolio **MUST** be entered in Leasing, Maintenance, and Overall categories.

- The regional property manager must submit a video to introduce themselves, identify the portfolio, style of communities, and location of your properties.
- The portfolio performance should be addressed in your video and an explanation of why you deserve to win the title of Regional Property Manager of the Year.
- There will be a Regional Property Manager winner for the Central, East, and West regions of the state.
- The highest scoring individual wins Regional Property Manager of the Year.

2

Property Manager

To enter in this category, the Property Manager's community **MUST** be entered in Leasing, Maintenance, and Overall categories.

- The property manager must submit a video to introduce themselves and identify the property, style of community, and location.
- The property performance should be addressed in your video and an explanation of why you deserve to win the title of Property Manager of the Year.
- There will be a Property Manager winner for the Central, East, and West regions of the state.
- The highest scoring individual wins Property Manager of the Year.

3

Assistant Property Manager

To enter in this category, the Assistant Property Manager's community **MUST** be entered in Leasing, Maintenance, and Overall categories.

- The assistant property manager must submit a video to introduce themselves, identify the property, style of community, and location.
- The property performance should be addressed in your video and an explanation of why you deserve to win the title of Assistant Property Manager of the Year.
- There will be an Assistant Property Manager winner for the Central, East, and West regions of the state.
- The highest scoring individual wins Assistant Property Manager of the Year.

4

Leasing Professional

To enter in this category, the Leasing Professional community **MUST** be entered in Leasing, Maintenance, and Overall categories.

- The leasing agent must submit a video to introduce themselves, identify the property, style of community, and location.
- The property performance should be addressed in your video and an explanation of why you deserve to win the title of Leasing Professional of the Year.
- There will be a Leasing Professional winner for the Central, East, and West regions of the state.
- The highest scoring individual wins Leasing Professional of the Year.

AWARD DESCRIPTION & CRITERIA

INDIVIDUAL AWARDS

Please note that for the Maintenance Professional and Leasing Professional individual awards you DO NOT need to be in a leadership position.

5 Maintenance Professional

To enter in this category, the Maintenance Professional community **MUST** be entered in Leasing, Maintenance, and Overall categories.

- The maintenance professional must submit a video to introduce themselves, identify the property, style of community, and location.
- The property performance should be addressed in your video and an explanation of why you deserve to win the title of Maintenance Professional of the Year.
- There will be a Maintenance Professional winner for the Central, East, and West regions of the state.
- The highest scoring individual wins Maintenance Professional of the Year.

6 Rookie of the Year

This award is given to a **NEW** employee at the apartment community who has been there for 3 – 9 months and is new to the industry!

- The rookie should be nominated by their immediate supervisor (Property Manager or Lead Service Technician).
- The nominating party will need to complete the registration for the rookie nominee and submit a video as to why this person deserves to be Rookie of the Year.
- One winner per region in the state.

7 Supplier of the Year

This award is given to suppliers in the rental housing industry!

- The supplier should be nominated by Property Management Companies and Properties.
- The nominating party will need to complete the registration for the supplier nominee and submit a video as to why this person deserves to be Supplier of the Year.
- One winner per region in the state.



THE JUDGING PROCESS

Rules and Regulations

Property Awards

- All property entries must pay for the award program and complete the required application for each award choice.
- It is important when completing the application that you choose the type of property you represent.
- There will be no phone shop in 2024. This has been replaced by a website inquiry.
- If you enter for the Maintenance Excellence Award, the shop will attempt to schedule an appointment twice. If the appointment cannot be met, the property forfeits the Maintenance Excellence Award Program.
- If you have one Maintenance Shop for multiple properties, you will only be able to register one Maintenance Excellence Shop and designate the property that is being nominated.
- Overall and Maintenance shops for 2024 will be a scheduled tour. If a shopper is unable to tour the community, they will make one additional attempt to return. Failure to tour the property will be documented and the entry will be forfeited by the property.
- When the property has registered for the award program, and at the time of the shop there is no vacancy, model or make-ready to show, an alternate option should be provided for the prospect in terms of virtual tour, photos, common area tour, grounds, and amenities tour.
- Revealed and mystery shops will begin May 15th through July 31st for Overall and Leasing Excellence.
- Maintenance Excellence scheduled appointments will be conducted after May 28th and extend through the end of July 2024.
- Property Awards are awarded in each region, Pittsburgh (West), Harrisburg (Central), and Philadelphia (East).

The Keystone Awards Committee will review all shopping reports where a tie is in place and determine the winner of the awards based on the narratives provided by the shopper, detailing their experience. All Individual Award submissions will be reviewed and judged by the Keystone Awards Committee.

Rules and Regulations

Individual Awards

- All individual entries must pay for the award program and complete the required Cognito Form for each award choice.
- The nominee must complete the form requirements that will review a list of accomplishments for the individual award.
- A video is required and should be submitted no later than July 15th, 2024. All videos received after this deadline will not be considered as a candidate for the individual award. Videos may not exceed 5 minutes.
- Introduce Yourself. Make sure you tell us your name, the Keystone Individual Award you were nominated for, your job title along with your career responsibilities, apartment community name, and how long you have worked at the property.
- Tell us Why You Are Awesome. This is your time to shine, what makes you stand out above the rest.
- You are welcome to enlist the help of others in preparing your video. For example, you could record a co-worker or supervisor endorsing your skills and abilities. A resident could help tell the story of your customer service philosophy. Maybe you would like to include how your family has supported you as you have excelled in your career and position with your company. Creativity and individuality are encouraged.
- **An application will need to be completed with the video submission.**
- There will be Individual Awards presented in each part of the state, Pittsburgh (West), Harrisburg (Central), and Philadelphia (East).

Failure to meet video deadlines will result in forfeiture of Call to Entry fee.

THE JUDGING PROCESS

Add info@paahq.com to your address book to help prevent emails from being directed to your spam folder.

Check your email registration and review the video and requirements.

When you register as an award contender, you will receive an email confirmation from PAA. In that email we have provided a video that will allow you to review the awards criteria along with some tips regarding what the shopping company will be looking for. In the past this has been a webinar you would join as organized by PAA. We will not be hosting the webinar in 2024 but we will be providing you the tools you need as soon as you register.
