** Board Meeting Report For December 2, 2023

- The Internal Revenue Service has released <u>Notice 2023-74</u> announcing a delay of the new \$600 Form 1099-K reporting threshold for third-party settlement organizations for calendar year 2023.
- As the IRS continues to work to implement the new law, the agency will treat 2023 as an additional transition year. This will reduce the potential confusion caused by the distribution of an estimated 44 million Forms 1099-K sent to many taxpayers who wouldn't expect one and may not have a tax obligation. As a result, reporting will not be required unless the taxpayer receives over \$20,000 and has more than 200 transactions in 2023.
- IR-2023-193, Oct. 19, 2023

WASHINGTON – As part of a larger effort to protect small businesses and organizations from scams, the Internal Revenue Service today announced the details of a special withdrawal process to help those who filed an Employee Retention Credit (ERC) claim and are concerned about its accuracy.

This new withdrawal option allows certain employers that filed an ERC claim but have not yet received a refund to withdraw their submission and avoid future repayment, interest and penalties. Employers that submitted an ERC claim that's still being processed can withdraw their claim and avoid the possibility of getting a refund for which they're ineligible.

The IRS created the withdrawal option to help small business owners and others who were pressured or misled by ERC marketers or promoters into filing ineligible claims. Claims that are withdrawn will be treated as if they were never filed. The IRS will not impose penalties or interest.

EDUCATION COMMITTEE CO-CHAIR REPORT FROM JAMES TICE 77th ANNUAL MEETING JUNE 2024

As we navigate through another year of challenges, the unwavering commitment and resilience of our committee members continues to inspire us all. Our collective dedication to the pursuit of excellence in education sustains and propels us forward. This report aims to shed light on our ongoing efforts, our triumphs amidst trials, and our relentless pursuit of providing high-quality education for all. We hope that it not only informs but also inspires you about the work we do and the difference we make every day.

A strategic planning session was held on 9/22/23. We discussed how well events are working and making sure the number of people attending are enough. We need to focus on increasing attendance. Chapter meetings need to be sustainable. Alternative meeting locations other than hotels should be explored for opportunities to save costs. Social activities and shredding events may help drive attendance. Chapter-wide co-sponsored programs can be held as revenue sharing events.

A strategic planning session was held via Zoom on 12/4/23 and 12/28/23. We discussed topics and CPE content delivery (In-person/online/hybrid), challenges in competitive pricing, and draft seminar cancellation policies. PSTAP will continue to piggy-back online courses from TaxSpeaker and provide revenue-sharing with the Chapters.

Simulcasts at Tax Speaker events will be allowed, and we need consistency in delivery for this option. Utilizing a simulcast option will pose challenges. We need to be profitable at events. We need to have quality equipment. It would take personnel to run video and polling monitoring. The facilities must have good WiFi. In short, we would need to avoid technical issues.

There are changing demographics, costs, and consumer demand patterns.

Statistics from 2015 through 2023 PSTAP seminars were reviewed. Attendance for the A&A and Business Entities events have declined to almost half their levels since 2015. The overall 1040 attendance has declined. The PA DOR and Ethics events seem to be holding.

Co-sponsored events may be held as revenue sharing events to make meetings sustainable. Alternative meeting locations other than hotels should be explored for opportunities to save costs. Integrating a social or a shredding event may help drive attendance. We are discussing "bundle discount" registrations as a way to drive members to 1040 and other events.

It is important to develop programs and speakers

Topic ideas and potential speakers are always appreciated, and I welcome input from every chapter. A blend of topics is needed to provide a balance of educational requirements and options to the members.
