Asahi/America, Inc. is allotted a <mark>Single</mark> booth for 2026, based on recent exhibit hall booth size All outstanding balances for the current year conference <u>must be paid in full</u> before pre-registration can begin. The current balance for Asahi/America, Inc. is <mark>\$0</mark>.

The details of the tier placement policy are outlined as follows:

• <u>TIER ONE:</u> Vendors who are exhibiting with us in 2025, with memberships extending over 30 years will receive priority in booth selection. These vendors may pre-register for the 2026 conference starting December 16th, 2024, at 9 am. This tier acknowledges those who have demonstrated long-term dedication and support.

- <u>TIER TWO:</u> Vendors who are exhibiting with us in 2025, with memberships between 20 and 29 years will be placed in tier 2. These vendors may pre-register for the 2026 conference starting January 13th, 2025, at 9 am. This tier reflects significant loyalty and contribution over a substantial period.
- <u>TIER THREE</u>: Vendors who are exhibiting with us in 2025, with memberships between 10 and 19 years will be placed in tier 3. These vendors may pre-register for the 2026 conference starting January 27th, 2025, at 9 am. Your ongoing commitment is valued and will be acknowledged accordingly.

- <u>ALL OTHER VENDORS</u>: All other vendors who do not fall into a previously mentioned tiers will be allowed to purchase any remaining booths starting March 12th, 2025 at 9 am.

If you disagree with this tier placement, <u>please submit a tier dispute form here</u> before November 15th, 2024, and we will do everything we can to verify and allow tier changes. This tiered approach ensures that our long-standing members are given appropriate recognition while also maintaining a balanced and equitable process for all vendors.
