Vision Statement:



Government Lelations

REPRESENTING THE INTERESTS OF APARTMENT & RENTAL HOUSING OWNERS, BUILDERS, DEVELOPERS AND MANAGEMENT



The SAAA Political Action Committee (PAC) works on behalf of SAAA members. Our PAC strives to develop and maintain productive relationships with key public officials at the local, state, and national levels. We are successful when we have active dialogue with public

policy makers in order to ensure that legislation is favorable to our industry.

Legislation can begin at every level of government and will have a significant impact on the bottom line of our businesses and on our daily work environment. A misconception exists that legislation exclusively impacts property and management company owners. The reality is that it has a global and direct impact on each of us in the industry. When a company's bottom line is impacted it affects employee benefits and financial decisions related to a property's expenses and the community.

The SAAA PAC has paved the way to ensure that the SAAA legislative team is able to be actively engaged on a daily basis with elected officials at the city, state and congressional levels. The SAAA PAC supports candidates for city and county political offices, Texas Legislature and statewide offices.





For well over 40 years, TAA has represented the views of rental housing owners, builders, developers and managers.

- TAA is the only organization representing all aspects of the rental housing industry with a full-time presence at the state capitol and before more than 20 state regulatory agencies.
- We have more than 10,400 members and represent 1.7 million units throughout the state.
- TAA advocates legislation designed to address the pressing problems and concerns of rental housing owners and professionals.
- TAA has been a key proponent of legislation to increase security measures for residents of rental housing. We've supported legislation that has set the standard for security devices required in residential rental housing, as well as fencing requirements for pool yards.
- TAA has also been instrumental in supporting the passage of meaningful tort reform in the state of Texas.
- TAA works closely with the NATIONAL APARTMENT ASSOCIATION / NATIONAL MULTIHOUSING COUNCIL Joint Legislative Office on federal issues affecting the multifamily rental housing industry, such as fair housing and environmental regulations.

The national association, in partnership with the National Multi Housing Council, maintains a full-time legislative staff that monitors national legislative activity and lobbies for our industry's interests.



The Professional Education Program (PEP) has been designed to be affordable and valuable to our apartment community members. For example, Main Street Apartments pays the one-time PEP tuition*; throughout the year, the manager, assistant manager, leasing consultants and maintenance personnel can attend any PEP approved class at no charge and all others at a reduced cost (starting at \$61 per class). PEP subscribers will be required to complete a registration form for each class they are planning to attend. SAAA members choosing not to become PEP subscribers may register individually for any course throughout the year for a single class fee. Each class has a specific cancellation date and all registrants are expected to adhere to the cancellation policy and will be responsible for fees accordingly.



National Apartment Association Professional Credential Courses
