

LICENSE AGREEMENT
SBCA Electronic BCSI

This LICENSE AGREEMENT (“Agreement”), effective as of the date of installation (“Effective Date”), is hereby made by and between Structural Building Components Association (“SBCA”) and you as an authorized user(s) and you as an authorized user agree as follows:

OWNERSHIP OF ELECTRONIC BCSI. (a) SBCA is the owner of an electronic version of the 2018 edition of *Building Component Safety Information Guide to Good Practice for Handling, Installing, Restraining & Bracing of Metal Plate Connected Wood Trusses* (“BCSI” and the electronic version of BCSI shall be referred to as “Electronic BCSI”) available through a SBCA owned website. (b) Licensee desires to receive internet access to the Electronic BCSI; and SBCA desires to provide Licensee with such access in accordance with the terms of this Agreement. (c) Licensee acknowledges and agrees that SBCA owns all right, title and interest in and to the Electronic BCSI, including without limitation any and all improvements, modifications, updates or derivative works, documentation user manuals or functional specifications, copyrights, patents, trade secrets, trademarks and other intellectual property rights therein. Licensee will not earn or acquire any rights or licenses under any copyrights, patents, trade secrets, trademarks, or other intellectual property rights on account of the use of Electronic BCSI or through this Agreement.

LICENSE GRANT AND LIMITATIONS. (a) Subject to the terms and conditions of this Agreement, SBCA hereby grants to Licensee a royalty-free, personal, nonexclusive, nontransferable, non-sublicensable and revocable license to use the Electronic BCSI for which sets forth proper handling, installing, restraining and bracing guidelines for Metal Plate Connected Wood Trusses that are simple, safe, proven methods consistent with accepted framing construction practices in the field. (b) No license is granted for any other purpose and there are no implied licenses in this Agreement. (c) The respective licenses granted to Licensee are granted on a Fee basis (as defined below) for the period of time the license remains in effect. (d) Licensee agrees not to modify, disassemble, decompile, reverse engineer the Electronic BCSI and will not print, copy, paste the content from the Electronic BCSI, and will furthermore not rent, lend, or transfer the Electronic BCSI to any third party. Licensee may use the Electronic BCSI only on web browsers owned and/or duly licensed by Licensee and shall comply, and ensure Licensee’s employees comply this Limitations section of the Agreement. (e) SBCA is under no obligation to provide any technical support for the Electronic BCSI or provide any updates, bug fixes or error corrections. If SBCA provides any such items, they will be considered to be part of the Electronic BCSI and subject to the terms of this Agreement.

FEE FOR LICENSE. The initial and recurring license Fee for SBCA members (of any type) shall be \$12.00 per year. The license Fee for any person or entity not a member of SBCA shall be \$36 per year (the “License Fee”). The License Fee amount shall be subject to change in the sole discretion of SBCA.

DISCLAIMER REGARDING USE OF ELECTRONIC BCSI. The information in the Electronic BCSI is offered as a minimum guideline only and nothing contained therein shall be construed in any manner as expanding the scope of responsibility of or imposing any additional liabilities on truss manufacturers and truss designers. Errata and updates are published periodically and are available at sbindustry.com/bcsi.php. Licensees are advised to use only the latest edition of BCSI.

LIMITATION OF LIABILITY. (a) SBCA HEREBY EXPRESSLY STATES TO LICENSEE THAT BCSI ESTABLISHES RECOMMENDED PRACTICES FOR THE HANDLING, STORING, INSTALLATION, AND BRACING OF STRUCTURAL BUILDING COMPONENTS AND IS NOT MEANT TO SOLELY REPLACE OTHER INDUSTRY UTILIZED PRACTICES AND MAY NOT APPLY OR MEET A SPECIFIC SITUATION OR CONDITION. THEREFORE, IN NO EVENT WILL SBCA OR ITS MEMBERS, DIRECTORS, EMPLOYEES, AND AGENTS BE LIABLE FOR ANY LOST REVENUE, PROFIT, OR DATA, OR FOR SPECIAL, INDIRECT, CONSEQUENTIAL, INCIDENTAL, OR PUNITIVE DAMAGES HOWEVER CAUSED AND REGARDLESS OF THE THEORY OF LIABILITY ARISING OUT OF THE USE OF OR INABILITY TO USE THE ELECTRONIC SBCA, EVEN IF SBCA HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. SOME STATES DO NOT ALLOW LIMITATION OR EXCLUSION OF LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES. (b) LICENSEE SHALL INDEMNIFY, DEFEND AND HOLD SBCA HARMLESS FROM ANY CLAIM, LIABILITY, DAMAGE, EXPENSE, OR DEMAND ARISING OUT OF OR IN CONNECTION WITH LICENSEE’S BREACH OF THIS AGREEMENT OR ANY LICENSEE USE OF

ELECTRONIC BCSI.

TERMINATION. This Agreement will automatically expire upon (i) Licensee's license of a newer version of the Electronic BCSI; (ii) Licensee ceasing to be a Regular Member of SBCA; or (iii) for any reason or no reason upon ten (10) days written notice from the other party. This Agreement may be immediately terminated upon Licensee's breach of this Agreement or if in SBCA's sole opinion, the Electronic BCSI is likely to become the subject of a claim of infringement of any intellectual property right. The rights and obligations of the parties, other than the license grant, will survive the expiration or termination of this Agreement.

GENERAL. (a) LICENSEE AGREES TO COMPLY WITH ALL APPLICABLE LAWS IN CONNECTION WITH LICENSEE'S USE OF ELECTRONIC BCSI INCLUDING BUT NOT LIMITED TO LAWS CONCERNING EXPORT CONTROLS AND INFRINGEMENT. LICENSEE AGREES TO INDEMNIFY SBCA AGAINST LIABILITY TO THIRD PARTIES (INCLUDING GOVERNMENTAL AUTHORITIES) RESULTING FROM LICENSEE'S FAILURE TO COMPLY WITH SUCH. (b) Licensee may not assign its rights or delegate its obligations hereunder, either in whole or in part, whether by operation of law or otherwise, without the prior written consent of SBCA. (c) Any attempted assignment or delegation without SBCA's written consent will be void. For purposes of this section, a twenty percent (20%) change in control shall constitute an assignment. (d) This Agreement and any action related thereto shall be governed, controlled, interpreted, and defined by and under the laws of the State of Texas, without regard to the conflicts of law provisions thereof. Unless waived by SBCA (which it may do in its sole discretion) the exclusive jurisdiction and venue of any action with respect to the subject matter of this Agreement shall be the District Court of Dallas County, Texas, or the U.S. District Court for the Northern District of Texas and each of the parties hereto submits itself to the exclusive jurisdiction and venue of such courts for the purpose of any such action. (e) This Agreement, including all exhibits which are incorporated herein by reference, constitutes the entire agreement between the parties with respect to the subject matter hereof, and supersedes and replaces all prior and contemporaneous understandings or agreements, written or oral, regarding such subject matter.
