PIP PIP Hooray! Reducing Harm with Patient Injury Prevention Rounds

Sanford USD Medical Center is committed to achieving zero preventable harm. Although improvement efforts continue, patient injuries still occur. Patient Injury Prevention (PIP) rounds serve as a key strategy in which clinical care leaders act as patient safety advocates, using a standardized tool to address nurse sensitive indicators. This approach reduces harm by ensuring best practices, essential interventions, and accountability measures are in place every shift. Within six months, the hospital achieved significant reductions in catheter associated urinary tract infections and central line–associated bloodstream infections. PIP rounds help align teams and support consistent delivery of high-quality care.

Homeward Bound

As a division of South Dakota's Department of Human Services, Long Term Services and Supports (LTSS) works to enhance the quality of life for older adults, individuals with disabilities, and their caregivers by providing access to a variety of home and community-based services. This presentation will provide an overview of LTSS programs and services, eligibility requirements, referral processes, and resources available to support individuals in maintaining independence in their homes and communities. Attendees will also learn about Home Again SD (Money Follows the Person), a federally funded program that helps eligible individuals transition from nursing homes, hospitals, or intermediate care facilities back into community living. Home Again SD assists participants in identifying and overcoming barriers to independent living by helping secure housing, establish a new residence, and access both short-term transition supports and ongoing services not otherwise covered by Medicaid, empowering older adults and people with disabilities to successfully return to and remain in the community.

2026 State of the Healthcare Industry

The healthcare industry is experiencing a pivotal shift—not driven by a single disruptor, but by a widespread redistribution of influence across the ecosystem as traditional social and political support structures continue to evolve. Long-standing assumptions about access, cost management, and clinical decision-making are being challenged by funding pressures, rising costs, and changing consumer expectations and trust. Healthcare leaders must understand the emerging stakeholders shaping this new landscape and the ripple effects across regional systems.
