PARKING:

Complimentary self-parking is available at Las Olas Parking Garage located at 200 Las Olas Cir, Fort Lauderdale, FL 33316, for attendees participating in the fishing tournament. Parking passes will need to be placed on the vehicle dashboard to avoid parking citations.

Due to known traffic in the area attendees are advised to head directly to the parking garage to give enough time to park and walk to the Fishing Headquarters (about 3 minutes walking distance). Please follow directional signs.

*** Please note parking is limited and we encourage attendees to carpool if possible.**

PARKING PASSES:

Parking passes will be handed out to registered attendees upon arrival to Las Olas Parking Garage located at 200 Las Olas Cir, Fort Lauderdale, FL 33316. A SEFAA representative will provide a parking voucher to put on your car dashboard. Please note that if you do not receive a voucher and display it prominently in your window, you will be subject to whatever parking regulations there may be including the hourly parking fee or towing.

Please note: Parking passes will be active from 1:00 pm to 8:00 pm. We encourage attendees to arrive at the garage by 12:50 pm promptly to allow enough time to collect their parking pass, park, and walk to the Fishing Headquarters.

RECOMMENDATIONS ON WHAT TO BRING:

- Mask/gaiter
- Sunscreen
- Sunglasses
- Hats
- Seasickness medication ([Ginger gum](#) is recommended)



- Hand sanitizer
- Cash for APAC donations
- Small fanny packs

RECOMMENDATIONS ON WHAT TO WEAR:

- Wear cool and comfortable clothes. Shorts and a lightweight/light-colored shirt are recommended
- Non-skid rubber-soled shoes are ideal. Sneakers are perfect
- Waterproof Jacket
- Don't forget a hat and sunglasses!

RESTRICTIONS:

- No coolers or large backpacks will be allowed on board
- No external alcoholic beverages are permitted onboard. All backpacks might be subject to revision at SEFAA or the Captain's discretion
- No glass allowed on board

GENERAL RULES:

1) All fish must be weighed in the presence of a registered angler who caught it. Fish must be in fresh, edible condition and caught on rod and reel. No mutilated fish. All anglers are encouraged to release fish not to be entered into the tournament. Any fish weighed may be cut open and kept by the tournament. If a fish is determined to be unacceptable by the Captain for any reason it will be released and not counted in the tournament.

2) No one except the angler may touch the rod, reel, line, or double line (if used) after the fish has been engaged and while the fish is being fought. Engaged shall be defined as the time at which the drag is engaged (engage the drag lever on or close the bail). No one except the angler who engages a fish may touch that rod. In the event of multiple hook ups on separate lines being fought by a single angler, all fish being caught shall



be accepted for weighing. A fish shall not be fought from a rod holder. However, in the case of multiple hook up, the angler may use a rod holder for its intended purpose.

3) There will be no weather days. The Captain is ultimately responsible for the crew and should make decisions as to safe sea conditions for the vessel. All participants in the tournament enter at their own risk.

4) Prizes: Prizes will be awarded to individuals as follows:

- Heaviest Fish: \$500.00
- Longest Fish: \$250.00
- Most Fish: \$250.00
- Coolest Fish: \$100.00
- Coolest Fish: \$100.00

In order to qualify for the tournament, the catch must be:

- Legal size
- In season
- Kept
- No shark, no ray
- Only fish caught and kept will count for the prize
- Catch and released fish will not count per the captain's order for this tournament
- Captain and mates will assist angler with identifying the fish, if it can be kept, removing the fish, and marking the fish. Mates will give each angler their marker to identify the fish caught (more instructions will be given by the captain upon departure)

5) All participants and their companions enter at their own risk, and hereby release, discharge, and further agree to indemnify and hold harmless The South East Florida Apartment Association and their sponsors, advertisers and other participants and any agents, employees, officers, directors, contractors, and successors of the above-mentioned organizations from any and all claims, losses, damages, demands, causes of action, suits and liability of every kind arising out of, connected to, or resulting from the event, including without limitation, any claim for loss, damage or



destruction of property, or injury (including death), regardless of whether such loss arises in whole or in part from the negligence of The South East Florida Apartment Association, its officers, employees, agents, sponsors, directors, contractors, or successors for any loss arising out of, connected to, or resulting from this event. I also understand that this release binds our heirs, executors, administrators, and assigns as well as ourselves.
