

### **Volleyball Tournament Rules & Regulations**

#### Anticipated attendance: 650 attendees

**Team Rules:** Teams should be made up of six (6) players. Each team must have always at least two (2) female players on the court during play or they will forfeit the match. Teams must consist of people who work for the company registered. If you are not able to complete a team you may ask another SEFAA member to join. It is expressly prohibited for any team to include in their team count professional volleyball players, "Ringers" or similarly situated individuals who are not directly employed by the Representative Company. Management Companies can play with other management and suppliers can play with other suppliers.

**Parking:** Complimentary self-parking is available at the Fort Lauderdale Beach Park lot, located at 700 Seabreeze Blvd., Fort Lauderdale, FL 33316.

#### \*Please note: Reserving parking spaces is prohibited.

Alternative parking options: Overflow parking is available at the attendees' expense in the parking garage directly across the street from B Ocean, located at 1140 Seabreeze Blvd, Fort Lauderdale, FL 33316.

**Loading Zone:** Attendees may drop off their items in the loading zone, however, cars cannot be left unattended. Vehicles may remain in the loading zone for a maximum of five **(5) minutes**. Please do not park in the areas that are restricted with parking cones. \*Please refrain from moving any pre-set parking cones.

#### Recommendations on what to bring:

- Tents (see specifications on branding below for sponsors and non-sponsoring attendees)
  - Tents must be weighted. <u>Stakes are prohibited.</u>
- Tables and chairs
- Additional food & beverage (the food trucks are limited to serving one meal and beverage per attendee; therefore, no additional meals may be purchased onsite)
- Water
- Sunscreen
- Sunglasses
- Hats
- Branded team shirts
- Games
- Cash for: PAC and community service donations



### **Restrictions:**

- Speakers/music that will prohibit attendees from hearing the tournament announcements. SEFAA Staff reserves the right to request the removal of such equipment if needed.
- Please be environmentally conscious of the items you bring to the beach such as plastic and promotional volleyballs and clean up your trash and area before you depart
- SEFAA is not providing or selling alcoholic beverages or permitting the consumption of alcoholic beverages at this event

# Sponsor exclusive benefits:

- Opportunity to utilize a company-branded tent
- Opportunity to raffle prizes (provided by sponsor) and announce the winner at DJ Booth
- Opportunity to distribute branded promotional items and collateral material during the event
- Designated tent location

# Non-sponsoring tents:

- All tents are required to be generic (no company-branded permitted)
- All tents must be placed in the designated area (second row of tent placements)

- Not allowed to provide raffle items at the event
