## SMCA Shares Insights with SMACNA Council of Chapter Representatives

SMCA's Chapter Representative Glen Armstrong (Restaurant Ventilation Design) and Executive Director Peter Jenkins joined SMACNA chapters from around the country in Scottsdale Arizona for the December Council meeting. The Council of Chapter Representatives implements SMACNA policies and programs at the local level, exchanges information between SMACNA chapters, and informs the SMACNA Board of Directors about local areas' needs, issues, and problems.

Attendees received updates from SMACNA leadership, including 2023-24
President Carol Duncan and CEO Aaron Hilger. SMACNA's technical
department provided insights into the newest technical standards and
innovative technology coming into the industry. Reports were also given on
the legislative and collective bargaining landscapes as 2023 approaches its end.

SMACNA has a new focus on chapter services as part of the "Accelerate Your Impact" program. Among the topics discussed by the Council were identifying industry leaders and encouraging contractor participation in association activities. In a time of generational change across much of the industry, keeping members engaged and developing new leaders is crucial.

#### **PA House Passes Responsible Contractor Bill**

In October, the Pennsylvania House passed HB 1449, which would establish responsible contractor requirements for all public works projects in the Commonwealth. Responsible Contractor Ordinances (RCOs) have been passed in numerous municipalities in the area with the support of SMCA and Local 19. Like municipal RCOs, HB 1449 would set standards for contractors wishing to bid on publicly funded projects – for example, the bill requires that at least 70% of workers on a project are enrolled in or graduated from an approved apprenticeship program. As of this writing, the bill now sits in the Senate State Government Committee.

## Advocacy Works! Separations Act Defended in Harrisburg

In a victory for SMACNA of PA and SMCA's Member Firms, the Senate Local Government Committee cancelled a fall meeting to consider legislation that would weaken the Pennsylvania Separations Act. Current policy requires the solicitation of separate bids and contract awards for electrical, HVAC, plumbing, and general construction. The bill discussed, SB 927, would permit some townships to seek out single prime contractors. SMACNA of PA and SMCA oppose this, as separate primes provide opportunities for small and local contractors to bid competitively on projects, saves taxpayers millions in construction costs, and provides local union jobs. Thanks to the advocacy of SMACNA of PA and SMCA's Legislative Committee members, this bill has been removed from the Committee meeting schedule.

# Annual Construction Outlook: What's in Store for '24?



Following a sluggish 2023 both for the American economy and construction starts, the new year is expected to show stronger growth in the construction sector. The Dodge Construction Network (DCN) expects total construction starts to gain 7% in the coming year, up from only 1% growth in 2023. Last year the economy struggled in large part due to inflation and the Federal Reserve's efforts to slow it. Assuming the Federal Reserve stops increasing interest rates to combat inflation, the influx of federal

funding for public works and infrastructure projects should put contractors in a position for growth in 2024.

Commercial construction was the biggest victim of 2023's financial issues, as the Federal Reserve's tight monetary policies made financing these projects difficult. The cultural shift towards working from home in many industries has caused a drop in office construction, particularly in urban areas like Philadelphia's Center City. DCN predicts this to continue, with an expected 2% drop in commercial construction nationwide in 2024 largely attributed to reduced office work. However, data centers and warehouses may help offset those losses.

Manufacturing and Industrial construction are on an upswing as 2024 begins thanks to an influx of federal dollars to improve the American supply chain and "onshore" production of semiconductors (the CHIPS Act), automobiles (Ford's "Blue Oval" project), and more. Life sciences and laboratory projects appear to be on the rise in cities like Philadelphia whether it be conversion of unused office space or institutional investments by the city's colleges and universities. One of the chief concerns DCN and other analysts have in 2024 is a nationwide labor shortage may hold construction starts back. On a positive note for SMCA contractors, this should not be an issue in the Philadelphia area as SMART Local Union 19 has robust apprenticeship and organization programs that provide an ample supply of skilled labor.

While nothing is certain given ongoing conflicts abroad, a looming Presidential election, and the possibilities of government shutdowns and/or economic recession, most signs indicate that 2024 will be a growth year for the economy and construction in the Philadelphia area. With large projects both ongoing and slated to begin throughout the city, a boost in federal infrastructure





# Prime Sheet Metal, Inc. Part of Major South Philly Community Rebuild

The City of Brotherly Love continues to work on building love, and they are doing so by rebuilding the Vare Recreational Facility on Morris Street in South Philly. City officials recognized to make the 100-year-old facility more appealing to the youth and the community, a makeover was desperately needed. The projected cost of the project is said to be \$20 million. However, monies from the city's soda tax will fund the rebuild. Once completed, contractor firms working on site like Prime Sheet Metal, Inc., will be elated to have had a hand in turning a grim city cornerstone into a masterpiece.

Prime Sheet Metal, Inc. Lead Foreman, Tony Prosperi, walked me through the gymnasium, classroom, and roof areas where HVAC units were installed or will be installed. One of Prime's units "Energy Recovery Ventilator" will be a major source of the output and input of power for the entire 20,000 square foot facility. This unit is positioned on the lower roof above the office area.

On this project Prime Sheet Metal, Inc. is contracted to Chadwick Services, while Gilbane, Inc is the General Contractor. At the conclusion of this project, Prime will also be completing projects at the Elmwood Park Zoo in Norristown and then they will begin working at William Penn Charter New Lower School and a 35-story high rise downtown.

## A Look Ahead


