# INDUSTRY & MARKET PULSE





As we step into the first quarter of 2025, the construction industry presents a dynamic landscape shaped by economic shifts, policy changes, and evolving market demands.

The U.S. construction sector demonstrated resilience in 2024, with a 5.6% growth, reaching a total value of \$1.27 trillion. Projections for 2025 suggest a continued upward trajectory, with an anticipated compound annual growth rate (CAGR) of 4.7% through 2028.

Employment in the construction industry has been robust, with the workforce expanding to 8.3 million in July 2024, surpassing the previous peak of 7.7 million in 2006. (<u>Deloitte United States</u>). However, the sector faces persistent labor shortages, particularly in skilled trades, leading to increased labor costs and project delays.

Construction job openings declined by 39.2% year-overyear in November 2024, and job quits fell by 14.2%, indicating reduced workforce mobility. Despite these figures, persistent skill shortages and tighter immigration policies are expected to drive up labor costs.

Material costs continue to influence project planning and budgeting. The implementation of a 25% tariff on steel and aluminum imports, effective from March 12, 2025, is anticipated to increase prices for products made with these materials, including homes, cars, and appliances. In 2024, imports comprised 23% of the U.S. steel market and 44% of the aluminum market, with significant portions sourced from Canada. The construction industry, consuming 47% of steel, is particularly sensitive to these changes.

## PHILADELPHIA'S 2026: A YEAR OF OPPORTUNITY

Insights from the recent Mayoral Luncheon and the Philadelphia Business Journal's Countdown to 2026 event provide a roadmap for how SMCA can contribute to and benefit from this transformative period.

Philadelphia is poised for a transformative 2026, hosting a series of high-profile events that will put the city in the global spotlight while driving economic growth. For SMCA and its members, this presents a unique chance to contribute to and benefit from this historic moment.

Mayor Cherelle Parker's vision for Philadelphia includes a cleaner, safer, and more economically vibrant city. Key initiatives like a 30,000-unit housing plan, police reform, and streamlined business processes aim to attract investment and prepare for the 2026 influx of visitors. Public-private partnerships, such as Comcast Spectacor's \$15 million upgrade to Xfinity Live! and the Sports Complex plaza, offer opportunities for SMCA members to provide critical HVAC and other systems, even as large-scale new construction is deferred until after 2026.

Gregory Deavens of Independence Health Group highlighted the importance of collaboration in addressing education, health, and economic mobility gaps. Philadelphia's leadership in workforce development aligns with SMCA's mission to train and certify the next generation of sheet metal workers, ensuring a skilled labor force ready to tackle upcoming projects.





### A SUMMER TO REMEMBER

The summer of 2026 will be a defining moment for Philadelphia:

- The PGA Championship in Newtown Square will draw global golf fans.
- The MLB All-Star Game will celebrate the city's baseball legacy.
- The FIFA World Cup will bring international attention and tourism.
- The 250th anniversary of the U.S. will honor Philadelphia's role as the birthplace of American independence.

### **POLICY WATCH**

## Insights from John Wanner, Executive Vice President of SMACNA Pennsylvania

Last November's elections brought about a sweeping change in the power structure of the federal government. With Republicans in control of the White House and both chambers of Congress, the nation's legislative agenda shifted dramatically. Everyday seems to bring new, and often surprising, issues.

The president's coattails helped his party flip Pennsylvania Congressional House seats from blue to red as well as the U.S. senate seat. Remarkably, those coat tails didn't extend any further down ballot. Not one single incumbent in the PA state House was defeated in the general election. The result is that the PA House maintained a 1 vote Democratic majority. In the PA Senate, the parties traded control of a couple of seats so that it also has the exact ratio as last session, 28 Republicans to 22 Democrats. Once again, PA has the only split legislature in the nation.



SMACNA of PA actively lobbies on issues such as expanding prevailing wage law to cover off-site fabrication, protecting the Separations Act, and prohibiting indemnification clauses designed to shift liability to subcontractors to name a few. Unlike the situation at the federal level, the political landscape in PA is entirely familiar. As a result, our efforts will build on the progress made during last session.

### **LEGISLATIVE REPORT**



Pennsylvania contractors should be aware of new annual reporting requirements for businesses in 2025. The Annual Report costs \$7 to file and must include the following information:

- Business name
- Jurisdiction of formation
- · Registered office address
- Principal office address
- Name of at least one governor
- · Names and titles of principal officers, if any
- Entity number issued by the PA Department of State



Members of the SMCA Legislative Committee/SMACNA CIC will attend the Brendan Boyle Phillies Spring Training event in Clearwater, FL next month.



Special elections for vacant Pennsylvania House and Senate seats are set for March 25. Until those are held, the House is operating at a 101-101 split between Democrats and Republicans. The GOP maintains control of the state Senate.



Bills addressing worker misclassification and expanding prevailing wage have been introduced but are unlikely to move until special elections are resolved.

## **Know the Requirements and Deadlines**



### Who Must File

Domestic and foreign:

- Business Corporations
- Nonprofit Corporations

- Limited Liability General Partnerships
- Professional Associations
- · Business Trusts



### Information Needed

- · Business name
- Jurisdiction
- · Registered office address
- Principal office address
- Name of at least one governor (director, member, partner, etc.)
- · Officer names (if any)
- Department of State file number



### **Filing Process**

- Search for your entity on our Business Filing Services, file.dos.pa.gov
- 2. Confirm/update your information
- 3. Pay the \$7 fee (no fee for nonprofits)
- 4. Download your filed report within minutes (annual reports submitted online will be processed instantly)

### **Deadlines & Compliance**

The annual report requirement begins in 2025.

Your filing window is based on your entity type:

- Corporations: Jan. 1 June 30
- Limited Liability Companies: Jan. 1 Sept. 30
- · All Others: Jan. 1 Dec. 31

Failure to file an annual report will result in the administrative **dissolution**, **termination**, **or cancellation** of your business registration.

The Department of State will notify entities **via email** (if provided) and **postcard** before the deadlines. Be sure your email is up to date.

You may update your report during the reporting year for **no additional fee.** 

## Reinstatement & Re-Registration

For **domestic** entities that have been administratively dissolved, reinstatement is possible anytime with fees (if the name is still available).

**Foreign** entities that have been administratively dissolved **must re-register** with no retroactive effect.



# SPOTLIGHT: PROJECTS & PEOPLE

### Prime Sheet Metal Contributes to Beautiful New Elementary School



On a frigid February day, the SMCA team—Greg Wharton and Julie Frieswyk—bundled up to tour the construction site of the new Lower School at William Penn Charter in Philadelphia. Outside, the cold bit hard, but industrial space heaters kept the interior warm for finishing crews—a relief for our visiting SMCA team. Among the key contributors to this major project is Prime Sheet Metal, Inc., an SMCA member shop owned by board director Dominic Bonitatis. As a subcontractor handling the HVAC fabrication and installation, Prime kicked off their work in August 2024, with the project eyeing an August 2025 finish.

This is a big one—a \$40 million-plus addition to Penn Charter's campus master plan, led by general contractor Intech Construction, with E.B. O'Reilly on the mechanical side. Prime Sheet Metal earned their spot on the team after a drawn-out bidding process that saw multiple rounds.

Sean Lally, the project manager, said the job fits Prime like a glove. The duct system's layout and the project's scale play to their strengths, and being part of a Penn Charter build carries extra weight for the crew.

Set to welcome pre-K through fifth graders in Fall 2025, the Lower School will be an "Academic Village" packed with classrooms, art spaces, a woodshop, and a sky garden. Prime's HVAC system will keep it all comfortable once it's up and running. Sean called the sheet metal work straightforward but noted the building's unique interior design concepts will give it a distinctive edge. It's the kind of project that promises a standout result.

Things have moved along steadily, with few bumps in the road. Sean tipped his hat to the solid teamwork between Intech, O'Reilly, and Prime's crew, especially foreman John Wilson. "He is Prime's first employee and has stayed with the company literally since day one," Sean said, highlighting how John has shepherded the job from sketches to the field. A union craftsman to the core, John's steady hand—drafting one day, installing the next—keeps the work tight and right.

That same care runs through Prime's approach. Sean spoke to the privilege of working on a school like Penn Charter, where their craft helps set the stage for students and teachers. "Working in and providing our services for a school and doing our part to provide the best conditions for future professionals across many walks of life is especially an honor for which we give our utmost respect," he said. For SMCA members, this project is a snapshot of union talent in action—Prime's role, alongside Intech and O'Reilly, underscores how our shops contribute to big builds. Next time you're near East Falls, take a look as the Lower School rises. By August 2025, Prime Sheet Metal's work will be part of Penn Charter's next chapter, a quiet nod to the skill union hands bring to the table.

## Construction Safety Week May 5-9

Construction Safety Week is scheduled for May 5-9. Safety Professionals and industry leaders who are also involved in safety will address the importance of safety to their designated trade. With the many risks workers are exposed to daily on a job site or in the shop, what better time than safety week to review risks presented to bring awareness to all employees from Apprentice to Journeyman.

SMCA firms should review what their recordable injuries were this far in the year and discuss how to mitigate employee exposures to the injuries. A different safety topic should be discussed throughout the week. Whether the topics discussed include OSHA's focus four (Falls, Caught-in-Between, Struck-by, Electrical) or mental health; the goal at the end of the week is that every employee will know where the company stands regarding safety in the workplace.

At the beginning of the week, topics related to the sheet metal industry will be shared in a special weekly circular. I will also plan to visit a few shops and possibly job sites on Thursday, May 8th and Friday, May 9th. Make safety week 2025 productive and a tone setter on how you want your employees, General Contractors, and Construction Managers to view your safety program.

## **JATC UPDATE**

The JATC has been hard at work for much of the past year to improve the Philadelphia apprenticeship program, taking on major initiatives to ensure that Local 19 members receive the best training possible and that SMCA contractors have the most skilled tradespeople in the Philadelphia area for years to come.





The Training Center earned "Platinum" status with the Sheet Metal International Training Institute in 2024, unlocking grant funding to enhance equipment and training for Local 19 apprentices and journeypersons.

The COVID-19 pandemic underscored Indoor Air Quality's ("IAQ") role in keeping medical staff, students, office workers, and communities safe and healthy. IAQ and "clean air" efforts rely on our industry's Testing and Balancing ("TAB") contractors. Philadelphia's Training Center pioneered TAB training in the 1980s and, with top-tier certification programs and a cutting-edge TAB lab, led early IAQ adoption. Recognizing evolving tech and customer needs, the JATC prioritizes a 2025 TAB lab renovation, partnering with industry experts and national TAB organizations to maintain its gold standard.

Workforce development remains a national challenge, especially in construction, as industries vie for top talent. In 2025, the Philadelphia JATC will tackle this with a Pre-Apprentice program—a recruiting tool offering hands-on sheet metal experience in the field and shop. It opens doors for diverse newcomers, equipping them with skills to transition into Apprentices and, eventually, Journeyperson Sheet Metal Workers.

The Philadelphia JATC strives to supply SMCA contractors and their Local 19 workforce with the expertise for HVAC, IAQ architectural projects, and commercial kitchens—delivering top-quality work on time and within budget.


