## 2024 SMFM PROGRAM DIRECTOR UPDATE

#### February 12, 2024

The American Board of Obstetrics and Gynecology (ABOG) recognizes that patients have diverse gender identities and is striving to use gender-inclusive language in its publications, literature, and other printed and digital materials. In some instances, ABOG uses the word "woman" (and the pronouns "she" and "her") to describe patients or individuals whose sex assigned at birth was female, whether they identify as female, male, or non-binary. As gender language continues to evolve in the scientific and medical communities, ABOG will periodically reassess this usage and will make appropriate adjustments as necessary. When describing or referencing study populations used in research, ABOG will use the gender terminology reported by the study investigators.





# MFM Certification 1974 to 2023








#### Subspecialty CEs *Candidate Score Reports*

#### Your Overall Performance

Examiners score candidates on a scale of 1-4 on all structured cases, their case lists, and their thesis. A score of 3 represents a Competent physician who is consistently knowledgeable, can routinely provide clinically capable care as an ABOG-certified subspecialist and is able to act as a consultant to OBGYN physicians. Although a score of 3 is Competent on the scale, ABOG takes into consideration that not all candidates will be able to achieve a competent score on all cases, and the exam cut-score is thus set lower, as determined by a panel of Subject Matter Experts.

Scores on the exam are determined through psychometric analyses. These scores are referred to as a "fair measure average." The fair measure average is a fair score that is adjusted, so it takes into account both case difficulty and examiner severity of your examination, in comparison to the cases/examiners other candidates received across the week. Candidates who score at or above the cut-score pass the examination. In addition, in order to account for measurement error, candidates who score within the 95% Confidence Interval (CI) band around the cut-score (shown in the gray area on the graph) also pass, even if final scores are below the cut-score.

Your score and the passing score are displayed graphically below on the overall distribution of scores for the 2021 REI Certifying Examination. This allows you to compare your score to the passing score and to other candidates who took the test in the same cycle as you.





2023 Program Pass Rates for the Subspecialty Certifying Exam



2023 Distribution of Program Pass Rates (Number of Programs = 69; Your Pass Rate = 100.00%)






### Three-Year Program Pass Rates



2021-23 Three-Year Program Pass Rates for the Subspecialty Certifying Examination





2021-23 Distribution of Three-Year Program Pass Rates (Number of Programs = 84; Your Pass Rate = 83.33%)





50% of fellows reported 3+ months disruption in research rotations and many fellows had significant disruptions in their laboratory or clinical research

#### 2024 CE candidates

- Theses will be reviewed and scored internally to determine that they meet ABOG standards.
- The thesis defense 30-minute session will be replaced by five structured cases, two focusing on evidence-based medicine and study design and three focused on clinical care.
- ABOG will reassess annually to ensure continued fairness for CE candidates

- Thesis neither turned in nor presented
