A Celebration of the Career of John R. Graham: A Distinguished Scholar and Mentor Location: California Ballroom

In this talk, we honor the contributions to personality assessment made by Dr. John R. (Jack) Graham (1940 – 2022). Dr. Graham's empirical work focused primarily on the Minnesota Multiphasic Personality Inventory (MMPI) family of instruments. He was a member of the team responsible for the first revision of the test, which led to the MMPI-2 and the MMPI-A. Dr. Graham was the author of a book about the MMPI family of instruments, now in its 6th edition, that has been used to train generations of assessment psychologists. As a professor at Kent State University, Dr. Graham regularly taught courses on personality assessment and he mentored over 40 doctoral students. His teaching extended outside of the classroom, as Dr. Graham also regularly conducted professional workshops on the MMPI instruments and personality assessment. Dr.

Graham was a fellow of the Society for Personality Assessment and was awarded the Bruno Klopfer award for his achievements in 2015. While Dr. Graham had many significant achievements in his career, he considered his most significant contributions to the field to be the psychologists he helped train and whose careers he helped launch. To commemorate Dr. Graham's legacy of mentorship, it is our pleasure to announce a new Society for Personality Assessment Award, the John R. Graham Award for Distinguished Mentorship in Personality Assessment.

Bruno Klopfer Award Lecture- Opportunities and Challenges with Rorschach Research [1 CE]

In this talk, I begin with a review of some of the fortuitous opportunities and choices that, in hindsight, importantly shaped my research agenda and career, including with the Society for Personality Assessment. I follow this with a discussion of the aims and strategies that guided my role as an accidental test developer, describing the psychometric principles and strategies that my co-authors and I implemented with the goal of enhancing applied Rorschach practice and research. Given this opportunity to talk both to people interested and already using the Rorschach as well as people who may not be interested and may even consider the Rorschach to be an inherently suspect assessment measure, I describe what the Rorschach task is and is not. In this, I describe a Bayesian predictive coding model of how minds work, which provides a seamless fit for what Hermann Rorschach (and I) thought the task provided information about to assessors. Time permitting, I also anticipate presenting a brief video vignette of its use in practice and then more explicitly illustrate how it is used in the context of the Rorschach Performance Assessment System (R-PAS). I then describe some of the challenges of using the Rorschach in research, including the costs of time and skeptical reviewers, and address some of the current critiques focused on R-PAS or its foundational research. I end with some aspirations for the future uses of the Rorschach in practice and research, including in the second edition of R-PAS.

► Describe the role that John Exner played in the development of the Rorschach Performance Assessment System (R-PAS).

► List two of the seven concrete outcomes that the R-PAS authors implemented based on their guiding theme of getting the psychometrics right to enhance the accuracy of its use in clinical practice.

► Describe how the model of Bayesian predictive processing meshes with Herman Rorschach's view of the information provided by the inkblot task.

► List at least two of the challenges of engaging in Rorschach research.



Gregory J. Meyer, Ph.D., is a Professor of Psychology at the University of Toledo. His research focuses on psychological assessment, with an emphasis on the integration of personality assessment methods and using the Rorschach as a measure of psychological processes grounded in behavioral performance. He has more than 95 peer-reviewed publications and an h-index of 52. He has received Distinguished Contribution Awards for specific articles and general contributions to assessment and he served as the Editor of the Journal of Personality Assessment for 11 years. He is a Fellow of the American Psychological Association (Division 5) and of the Society for Personality Assessment. In addition to co-authoring the manual for the Rorschach Performance Assessment System, he co-edited a casebook entitled Using the

Rorschach Performance Assessment System (R-PAS).

Decolonising Psychological Practice: An Indigenous Aotearoa New Zealand Perspective [1 CE]

The application of psychological paradigms and perspectives, when working alongside Indigenous peoples in 2024, require review and decolonialisation to ensure they promote cultural competence of the clinician to enable cultural safety for the Indigenous patient/client. This presentation will present and discuss the application of an Indigenous Health Model in Aotearoa New Zealand within psychological practice and training, including; lessons learnt, measuring appropriate outcomes, and the place of psychology in support of Indigenous Health advancement.

Goals & Objectives

- ► Discuss the role of Indigenous Health Models as tools of decolonisation.
- Describe the key components of The Meihana Model.
- ► Identify the impact of cultural competency on Indigenous health outcomes.



Suzanne is a registered psychologist and a member of the New Zealand Psychological Society. She is the Dean and the Head of Campus of the University of Otago, Christchurch. Suz has been involved in Māori health research and health professional education for over 20 years. Her work has included the development of an Indigenous Health model of health, which supports Indigenous and non-Indigenous health professionals signpost cultural competency and safety within their practice. Suzanne has received a number of awards including the Prime Minister's Supreme Award for tertiary teaching excellence and the Indigenous Leadership Award from the Leaders in Indigenous Medical Education (LIME). Suzanne was awarded the Joan Metge Medal for her research in Indigenous medical education.

Bridging the GAP: Bringing Assessment & Gender Affirming Practices Together [1CE]

Transgender and gender diverse (TGD) people are more visible in our society than ever before and are seeking psychological care across specialties. For general psychologists in the field of assessment, this likely means that they are seeing an increasing number of TGD individuals. This talk intends to highlight gender affirming practices that are particularly pertinent to the field of psychological and personality assessment so that attendees feel better equipped to provide competent, sensitive, and affirming assessment to the TGD community.

Goals & Objectives

- ► Describe the core tenants of the gender affirming model of care.
- ► List at least two (2) gender affirming practices that can be incorporated into one's assessment practice.
- Describe best practices for utilization of gender norms for scoring on assessments.



Dr. Col Williams is an attending-level, clinical psychologist in the Gender Multispecialty Service, GeMS, at Boston Children's Hospital and holds an Instructor of Psychology appointment at Harvard Medical School. Dr. Williams' expertise is centered on working with transgender and gender diverse individuals across the lifespan. This is founded upon Dr. Williams having completed two post-doctoral fellowships – the first fellowship focused on providing interdisciplinary care to LGBTQ+ veterans at the Bedford VA and the second fellowship focused on working with transgender youth and their families, youth with intersex conditions, and youth with urological health concerns at Boston Children's Hospital. Dr. Williams' current clinical, research, and scholarship is focused on the transgender and gender diverse community, and they have a niche

specialty in working with trans and gender diverse athletes.

Awards

The Society is dedicated to the development of methods of personality assessment, the advancement of research on their effectiveness, and the exchange of ideas about the theory and practice of assessment.

Bruno Klopfer and a group of his students founded the Society for Personality Assessment (SPA) in Essex County, New Jersey. The Society is a collegial organization dedicated to the advancement of professional personality assessment, to the development of procedures and concepts for personality assessment and to the ethical and responsible use of these techniques.

Initially incorporated as the Rorschach Institute, Inc., in 1938, the organization was renamed the Society for Personality Assessment in 1971 to reflect the Society's interest in the entire spectrum of issues present in contemporary personality assessment and to focus the Society as a special interest group, concerned with promoting the exchange of ideas and information about personality assessment in research and practice.

The Society organizes and conducts an Annual Convention as partial fulfillment of the incorporator's objective "to provide an annual assembly of sharing research findings and clinical experiences". In addition, the Society publishes the Journal of Personality Assessment and a newsletter, the SPA Exchange. The following awards are presented by the Society:

The **BRUNO KLOPFER MEMORIAL AWARD** is given for outstanding, long-term professional contribution to the field of personality assessment. The recipient gives an acceptance presentation.

The **JOHN E. EXNER SCHOLAR AWARD** honors the memory of John E. Exner, Ph.D., a pioneer in personality assessment, by supporting the research of a young personality assessor. Dr. Exner was committed to advancing the science of personality assessment by empirical research in the development and application of assessment instruments. This award honors that commitment by recognizing and supporting a young investigator examining any method of personality assessment.

The **JOHN R. GRAHAM AWARD FOR DISTINGUISHED MENTORSHIP IN PERSONALITY ASSESSMENT** is given to individuals who have fostered excellence in the field of personality assessment by their mentorship of students and junior colleagues. Excellence in mentorship is reflected in the quantity of their mentees, its direct impact on their careers, including the quality of their accomplishments in personality assessment. The mentor's influence on the next generation may be evident through training programs, research supervision, and/or clinical training.

The **SAMUEL J. and ANNE G. BECK AWARD** is given for outstanding early career research in the field of personality assessment. The award is presented in conjunction with the University of Chicago. The recipient gives an acceptance presentation.

The **SPA MID-CAREER SCHOLAR AWARD** is bestowed annually for outstanding mid-career impact and scholarship in the field of personality assessment. The award honors scholars who are 15-25 years beyond their graduate degree and whose work has contributed substantially to the body of knowledge to the field of personality assessment and psychological test development.

The **WALTER G. KLOPFER AWARD** is bestowed annually by the Society for Personality Assessment for distinguished contribution to the literature in personality assessment. Eligible contributions focus on statistically based research projects. The Journal for Personality Assessment Editor invites

all Consulting Editors to nominate outstanding articles from the previous year, each of which is then rated by the Editor and Associate Editors. In the event of a tie, two awards may be given.

The **MARTIN MAYMAN AWARD** is bestowed annually by the Society for Personality Assessment for a distinguished contribution to the literature in personality assessment. Eligible contributions may consist of an outstanding case study, qualitative research project, or theoretical development. The JPA Editor invites all Consulting Editors to nominate outstanding articles from the previous year, each of which is then rated by the Editor and Associate Editors. In the event of a tie, two awards may be given.

The **MARGUERITE R. HERTZ MEMORIAL** is a tribute to Dr. Hertz for her long-term professional contributions to personality assessment. The memorial is presented by a distinguished member of the Society in honor of a deceased eminence from the field of personality assessment. At times, the presenter also invites other members to join in relating anecdotes of their personal contact with the honoree.

The **MARY S. CERNEY STUDENT AWARD** is awarded to the best personality assessment research paper submitted by a student. This award carries a small stipend to help defray the cost of attending the Annual Convention.

The **DISTINGUISHED SERVICE AND CONTRIBUTION TO PERSONALITY ASSESSMENT AWARD** honors individuals promoting personality assessment through excellence in teaching, outreach, advocacy, or practice. Recipients are those whose work has made a meaningful contribution to the practice of personality assessment by way of direct service, policy development and implementation, innovation, teaching, training, professional publications, leadership, or advocacy for the profession.

Bruno Klopfer Memorial Award

Gregory J. Meyer, Ph.D., is a Professor of Psychology at the University of Toledo. His research focuses on psychological assessment, with an emphasis on the integration of personality assessment methods and using the Rorschach as a measure of psychological processes grounded in behavioral performance. He has more than 95 peer-reviewed publications and an h-index of 52. He has received Distinguished Contribution Awards for specific articles and general contributions to assessment and he served as the Editor of the Journal of Personality Assessment for 11 years. He is a Fellow of the American Psychological Association (Division 5) and of the Society for Personality Assessment. In addition to co-authoring the

manual for the Rorschach Performance Assessment System, he co-edited a casebook entitled Using the Rorschach Performance Assessment System (R-PAS).

John E. Exner Award

Adam P. Natoli, PhD, is a Ronald E. McNair Scholar and an Assistant Professor in the Department of Psychology and Philosophy at Sam Houston State University. Dr. Natoli is the director of the Multimethod Assessment & Personality Lab (MAPL), where he investigates all aspects of how we measure the things we measure. His program of research focuses on developing, evaluating, and applying advanced measurement and statistical methodologies to the empirical study of human behavior with a concentration on instrument psychometrics, applications of Artificial Intelligence in psychology, personality, psychodynamic principles, and forensic psychology. He is a Licensed Psychologist, teaches numerous

courses related to assessment, statistics, and clinical theory and practice. Before moving to Texas to join the faculty at Sam Houston State University, Dr. Natoli coached college ice hockey for close to a decade with the New Jersey Institute of Technology and served as a scout and trainer for the USA Hockey District Development Program. Dr. Natoli still loves ice hockey and enjoys spending time outdoors.

Arbisi, Ph.D., ABAP, ABPP, L.P. retired in 2023 after 33 years as a staff clinical psychologist at the Minneapolis VA Health Care Center and is currently a Professor in the Departments of Psychiatry and Psychology at the University of Minnesota. Dr. Arbisi has published extensively on the use of the MMPI-2/MMPI-2 RF/MMPI-3 in psychiatric and medical settings as well as in the assessment of trauma related conditions including PTSD. He has co-authored and developed several scales contained on the MMPI instruments including several scales designed to identify non-credible reporting of symptoms. His program of research is broadly focused on exploring the utility of psychological assessment

in applied clinical settings including whether integration of trait level personality information into treatment planning can promote treatment engagement and lead to improved clinical outcomes. Further, as an investigator in a series of longitudinal studies of risk and resilience factors in deployed national guard soldiers, his research was focused toward better understanding the contribution of dimensional models of personality and psychopathology in identifying soldiers most likely to weather the challenges of deployment without developing stressor-related psychiatric conditions.

Dr. Arbisi currently maintains an active medico-legal practice specializing in evaluating consequential psychological injuries and trauma related conditions.

Samuel J. and Anne G. Beck Early Career Award



Dr. Katie Lewis

Katie C. Lewis, PhD, serves as the Director of Research at the Austen Riggs Center. Her research examines interpersonal behaviors, personality processes, and suicidal ideation in adult psychiatric patients using experience sampling methodology. Dr. Lewis received a doctorate in clinical psychology from the Brooklyn campus of Long Island University. In the past, she has served as the graduate student representative on the Ethics Board of APA's Division 39 and as an Associate Editor for the Journal of the American Psychoanalytic Association. Her research has been supported by the Robert Wallerstein Fellowship in Psychoanalytic Research, the American Foundation for Suicide Prevention, the National

Institute of Mental Health (NIMH), and the Division 39 Marsha McCary Fund for Psychoanalysis. She has published and presented on a wide range of topics, including suicide and self-harming behaviors, personality psychopathology and assessment, loneliness and social disconnection, and the ethics of confidentiality in clinical writing. She currently serves as a Representative-at-Large and Co-Chair of the CE Committee for the Society for Personality Assessment, and as a Consulting Editor and Section Editor for the Journal of Personality Assessment.

SPA Mid-Career Scholar Award



Dr. Martin Sellbom

Martin Sellbom is a Professor in Clinical Psychology at the University of Otago in Dunedin, New Zealand. He received his Ph.D. in Clinical Psychology in 2007 from Kent State University. His research focuses on psychopathy and other personality disorders, the integration of personality and psychopathology, and personality assessment with the MMPI instruments. Professor Sellbom's work has been featured in over 300 publications with three books, including Introducing the MMPI-3 (coauthored with Yossef Ben-Porath). He has won several awards, including the American Psychological Foundation's Theodore Millon mid-career award for advancing personality science, American Psychology-Law

Society's Saleem Shah Award and Society for Personality Assessment's Samuel and Anne Beck Award for early career achievement. Professor Sellbom serves as the Editor-in-Chief for the Journal of Personality Assessment. For his clinical practice, he specializes in forensic psychological evaluations. Walter G. Kasey Stanton

Dr. Kasey Stanton is an assistant professor in the Department of Psychology at the University of Wyoming. Dr. Stanton completed his associates degree at Miles Community College and his bachelors degree at Montana State University Billings. Following that, he completed his masters degree and PhD in clinical psychology at the University of Notre Dame. Dr. Stanton's research focuses on measure development, clinical assessment, and personality assessment. He is interested in transdiagnostic, dimensional models of classification and assessment, with an emphasis on externalizing psychopathology, mood, and bipolar spectrum disorder symptoms.



Ashley Watts

Dr. Ashley Watts is an assistant professor at Vanderbilt University in the Department of Psychological Sciences. Dr. Watts received her masters and PhD in Psychology from Emory University. Following that, Dr. Watts completed a postdoctoral fellowship at the University of Missouri, where she was awarded a K99/R00 Pathway to Independence Award from the National Institute on Alcohol Abuse and Alcoholism. Her research focuses on understanding the causes and consequences of psychopathology, with a focus on addiction and quantitative modeling.



Holly Levin-Aspenson

Dr. Holly F. Levin-Aspenson is an assistant professor in the Department of Psychology at the University of North Texas. She completed her PhD in Clinical Psychology at the University of Notre Dame and her postdoctoral fellowship at the Alpert Medical School of Brown University. Dr. Levin-Aspenson's research focuses on clinical assessment and quantitative, dimensional models of psychopathology such as the Hierarchical Taxonomy of Psychopathology. This includes a focus on developing psychometrically-sound and clinically-useful measures for use in different settings.





Ryan Carpenter

Dr. Ryan Carpenter is an assistant professor in the Department of Psychological Sciences at the University of Missouri-St. Louis. He received his PhD in Clinical Psychology at the University of Missouri-Columbia, which included earning a minor in Psychological Methods and Statistics. Dr. Carpenter then proceeded to complete a postdoctoral fellowship at the Center for Alcohol and Addiction Studies at Brown University. Dr. Carpenter's research uses advanced statistical techniques to better understand behavior, mood, and substance use in everyday life, including using momentary assessment methods such as ecological momentary assessment.

Noah Emery

Dr. Noah N. Emery is an assistant professor in the Department of Psychology at Colorado State University. Dr. Emery completed his PhD at the University of South Dakota in 2018 and proceeded to complete a postdoctoral fellowship at the Center for Alcohol and Addiction Studies at Brown University. His research focuses on identifying mechanisms of behavior change underlying substance use and leveraging this information to improve intervention efforts. Dr. Emery uses advanced quantitative modeling and methods such as ecological momentary assessment to better understand dynamic processes at the momentary level.



Mark Zimmerman

Dr. Mark Zimmerman is the director of South County Psychiatry (North Kingstown, Rhode Island). Dr. Zimmerman completed his undergraduate degree at Columbia University and proceeded to complete his medical degree at the Chicago Medical School. He then completed postgraduate training at the Medical College of Pennsylvania. He is board certified in psychiatry, and he is a professor of psychiatry and human behavior at the Alpert Medical School of Brown University, in addition to his role as South County Psychiatry's director. He has published over 500 articles and book chapters on a wide range of topics, including psychiatric diagnosis and personality disorders, among others. This includes overseeing research

for the Rhode Island Methods to Improve Diagnostic Assessment and Services (MIDAS) Project, a clinical research study focused on improving routine clinical care that has been ongoing for more than 25 years.

Equity, Inclusion, and Social Justice Track

The Society for Personality Assessment is responding to the call for action from our membership to foster equity, inclusion, and social justice in our work as assessment psychologists. Our goal is to encourage work that applies to groups who are not typically represented in assessment research, presentations, and dialogues. This special track will be a home base and a launchpad for infusing the entire conference with energy and momentum towards these goals. Please be prepared to present and/or attend with a curious, positive and non-shaming attitude. All are welcome to participate.

Programs requested will be proposals that include systematically oppressed groups in their study, that extend the application of a test to other populations such as through translation to another language or establishment or new/updated norms, theoretical programs based on assessment with non-dominant groups or proposals that foster discussion of equity, inclusion, and social justice values and issues as they apply to assessment psychology.

Equity means that everyone gets what they need to succeed (Project READY, 2021). Inclusion is reflected in "organizational strategies and practices that promote meaningful social and academic interactions among persons and groups who differ in their experiences, their views, and their traits" (Tienda, 2013, p. 467). Social justice "is the virtue which guides us in creating those organized human interactions we call institutions. In turn, social institutions, when justly organized, provide us with access to what is good for the person, both individually and in our associations with others. Social justice also imposes on each of us a personal responsibility to collaborate with others...[and] to design and continually perfect our institutions as tools for personal and social development" (Center for Economic and Social Justice, 2021).

Education & Training

The mission of this interest group is to improve the quality of assessment training and supervision in the field of psychology, through improving and disseminating resources, promoting best practices, and advocating for rigor. Members of this interest group include academic and field-based trainers, supervisors, students, and clinicians. Topics addressed include bridging the gap between what is being taught in graduate programs and expectations for internship, licensure, and future practice; how to best assess competency during training; and how to best support those teaching and supervising assessment given the similarities and differences of graduate programs. Finally, the group will also make an effort to increase exposure to personality assessment throughout the psychology education lifespan, from undergraduate through postgraduate settings.

Psychoanalytic Assessment
