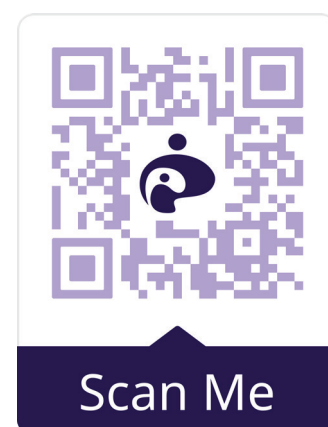

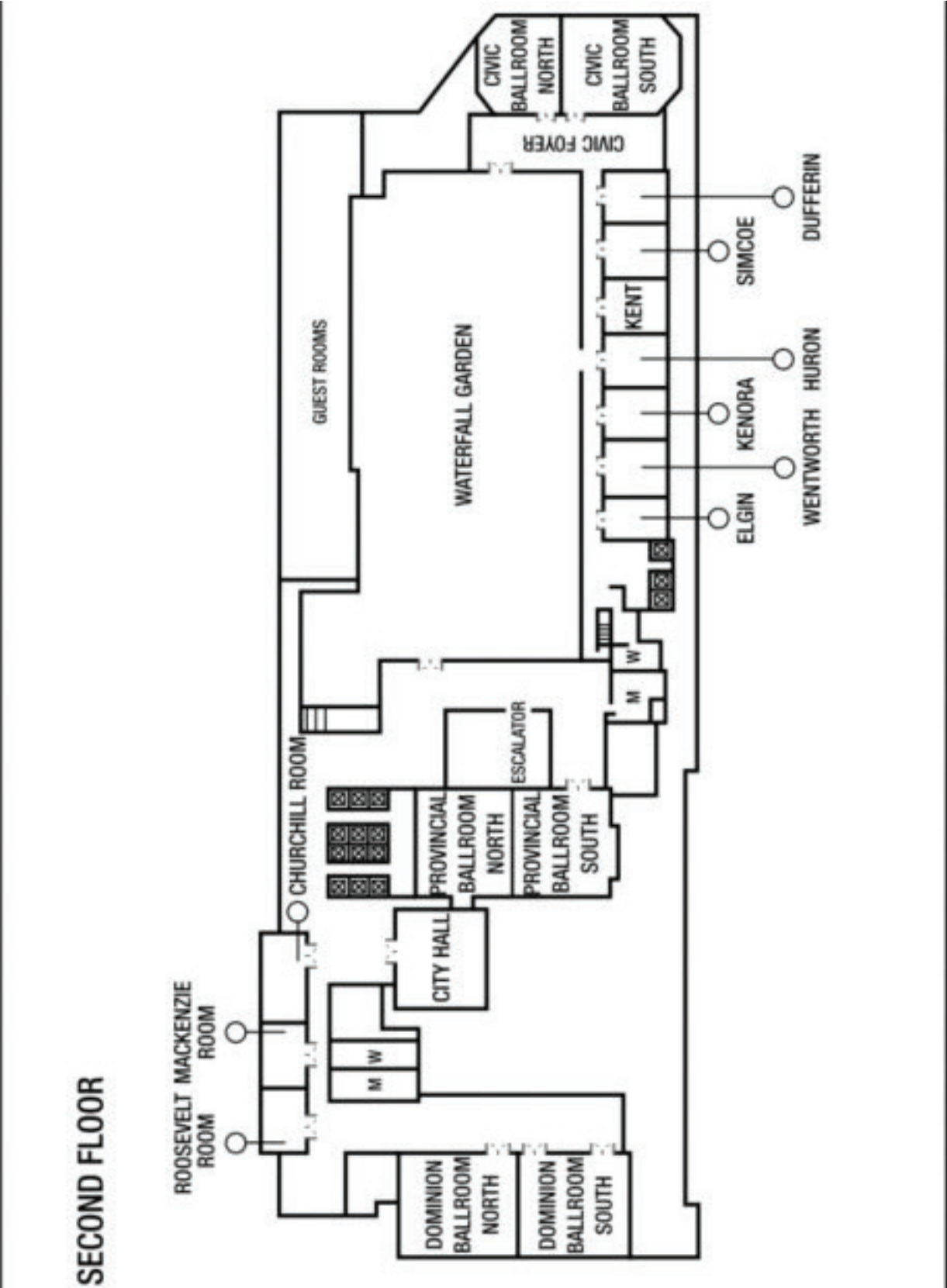

Equity, Inclusion, & Social Justice Track

The Society for Personality Assessment is responding to the call for action from our membership to foster equity, inclusion, and social justice in our work as assessment psychologists. Our goal is to encourage work that applies to groups who are not typically represented in assessment research, presentations, and dialogues. This special track will be a home base and a launchpad for infusing the entire conference with energy and momentum towards these goals. Please be prepared to present and/or attend with a curious, positive and non-shaming attitude. All are welcome to participate.

Programs requested will be proposals that include systematically oppressed groups in their study, that extend the application of a test to other populations such as through translation to another language or establishment of new/updated norms, theoretical programs based on assessment with non-dominant groups or proposals that foster discussion of equity, inclusion, and social justice values and issues as they apply to assessment psychology.

Equity means that everyone gets what they need to succeed (Project READY, 2021). Inclusion is reflected in "organizational strategies and practices that promote meaningful social and academic interactions among persons and groups who differ in their experiences, their views, and their traits" (Tienda, 2013, p. 467). Social justice "is the virtue which guides us in creating those organized human interactions we call institutions. In turn, social institutions, when justly organized, provide us with access to what is good for the person, both individually and in our associations with others. Social justice also imposes on each of us a personal responsibility to collaborate with others...[and] to design and continually perfect our institutions as tools for personal and social development" (Center for Economic and Social Justice, 2021).

Assessing Personality as it is Lived: Integrating Context and Daily Life Through Technology

As personality assessment continues to evolve, technological innovations offer new opportunities to expand how we conceptualize, measure, and interpret personality. This panel highlights three complementary approaches that illustrate how technology can deepen assessment by integrating personality structure with context, behavior, and data-driven analytic methods. Together, the panelists will demonstrate how technology can enhance core principles of personality assessment. Dr. Michael Roche will examine how personality dynamics unfold in daily life using an experience sampling methodology, combining person-specific data analysis with sample-wide associations to integrate nomothetic and idiographic insights. He considers how salient contexts, such as discrimination, influences these associations and the meaning behind them for personality assessment. Dr. Katie Lewis will present a clinical case study using a multimethod, experience sampling framework to investigate the daily interpersonal behaviors and experiences of a patient over the course of 1-year in residential treatment. She will illustrate how these findings expand our understanding of personality dynamics and provide support for integrating experience sampling methods into routine clinical assessment and practice. Finally, Dr. Adam Natoli will present research using machine learning and artificial intelligence to examine complex patterns in personality assessment research and practice, addressing both the promise of these methods for advancing measurement and the interpretive challenges they introduce. Across presentations, panelists will address how technology can expand ecological validity, clinical nuance, and analytic capacity in personality assessment, consequentially improving its utility and accessibility. Moderated by SPA President Dr. Nicole Cain, this session will emphasize responsible, theory-driven integration of technology and encourage attendees to consider how these approaches may be thoughtfully incorporated into their own research and clinical practice.

Learning Objectives

- Describe how ecological momentary assessment (EMA) can be used to assess external life events and contextual factors in conjunction with personality assessment.
- Explain how integrating EMA with personality assessment methods can enhance clinical case conceptualization and assessment feedback.
- Identify potential applications and limitations of machine learning and artificial intelligence approaches in the analysis and interpretation of personality assessment data.

Bruno Klopfer Award Lecture: Searching for Methods in the Madness [1 CE]

John Kurtz

John Kurtz will reflect on his educational and professional development as a psychologist, with frequent attention to the influence and encouragement of his journey from previous Klopfer Award winners. The theme of his research program has been the value of using multiple methods for personality assessment, and this theme will be illustrated with examples from various stages of his career. The many advantages of using knowledgeable informants has been a longstanding and frequent interest, and this method was used to investigate the stability of trait expression across different social contexts. Kurtz has also been interested in the use of sentence completion techniques to measure Loevinger's theory of ego development, and he will recount a study that examined the place of this construct in the five-factor trait taxonomy. His research with the Personality Assessment Inventory has evaluated techniques for discriminating ordinary defensiveness provoked by the selection context versus conscious attempts to conceal psychopathology. Currently, Kurtz and his students are reporting the results of a narrative assessment project. Stories of COVID-19 lockdown were collected from a large sample of young adults and rated for growth motivations, identity and coherence of self, and emotional investment in relationships. These narrative variables were found to be significant predictors of current self-reported well-being. Kurtz will conclude by expressing appreciation to the Society of Personality Assessment for its enduring openness to the many possible means for understanding the complex nature of human beings.

- Identify the distinction between the unconscious-defensive and conscious-deceptive varieties of positive response distortion.



Dr. John Kurtz is professor of psychology at Villanova University in suburban Philadelphia, where he has been a faculty member since 1996. He teaches courses in clinical psychology, personality theory, psychological testing, and the history of modern psychology. He is also a licensed psychologist in Pennsylvania since 1997, currently offering assessment and consultative services in reproductive medicine. Kurtz has been a member of the Society for Personality Assessment since 1991. He was Associate Editor of the Journal of Personality Assessment (JPA) from 2006 to 2013, and he has served on the editorial boards of JPA, Assessment, and Psychological Injury and Law.

Dr. Kurtz's research program has pursued diverse topics related to individual differences and problems of psychological assessment. He has conducted studies of the PAI, such as its utility in cases of traumatic brain injury and the validation of techniques designed to detect concealed psychopathology in selection contexts.

Reflections on the Measurement and Nomological Network of Wisdom [1 CE]

Wisdom is an ancient concept that has captured modern scientists' attention and interest. Defined as morally grounded excellence in social-cognitive processing, wisdom entails the application of our meta-cognitive capacities to solve complex and ill-defined life problems. The development of a cumulative and coherent science of wisdom has been complicated by the issue of how to measure it: some researchers prefer performance measures to assess people's wisdom-related expertise in living; other researchers prefer self-report measures to assess people's wisdom-related attributes. Each tradition has its strengths and limitations. In this address, I will present meta-analytic and empirical research to clarify wisdom's nomological network through the common and unique correlates that wisdom manifests across these measurement traditions. As wisdom and narcissism are defined antithetically, I will then examine whether the absence of narcissism constitutes a necessary condition for wisdom. I will close by reflecting on the role of gen AI in future wisdom research.

This talk is intended for those generally interested in the perplexing lack of convergence between self-report and performance measures, as well as for those specifically interested in the measurement of elusive psychological constructs such as wisdom.

Learning Objectives

By the end of this talk, attendees should:

- Know how wisdom is conceptualized within the common wisdom model
- Recognize commonly used self-report and performance wisdom measures
- Understand the strengths and the limitations of common wisdom measures
- Understand the correlates and necessary conditions of wisdom in self-report
- Understand the correlates and necessary conditions of wisdom in performance
- Understand the theoretical and empirical links between narcissism and wisdom



Marc A. Fournier is a professor in the Department of Psychology at the University of Toronto. He is principally interested in personality integration, person $\times$ situation interactions, and interpersonal processes: specifically, the integrative processes through which people develop and act from a unified sense of self and the interpersonal dynamics that serve to support these integrative processes. By extension, Prof. Fournier is interested in a range of constructs relevant to personality integration and self-congruence, including authenticity, defensiveness, narcissism, and wisdom. He uses an array of methodologies as part of this research, including the intensive repeated measurement of individuals in their naturalistic settings, the assessment of individuals

through knowledgeable informants, and narrative methods. Prof. Fournier previously served as President of the Society for Interpersonal Theory and Research, and currently serves as Associate Editor at Journal of Personality. His work is funded by the Social Sciences and Humanities Research Council of Canada.

From Self-Erasing to Standing True–Same Trait, Different Function

This keynote offers a lived experience perspective on the dimensional understanding of personality disorder, charting the shift from the onset of personality difficulties through disorder and into robust recovery.

Drawing on the ICD-11 and the Alternative Model for Personality Disorders (AMPD), Baltzersen examines how self and interpersonal impairments not only signal severity but also shape how traits are expressed. The level of functioning can dictate whether an inherent trait becomes protective, neutral, destructive, or pathological.

Through personal narrative, medical records, and reflections spanning from adolescence to recovery, the audience gains insight into this dynamic reorganization. What once appeared as impulsive self-destructiveness – described as “keeps finding herself in absurd and dangerous situations” – has, through functional recovery, transformed into spontaneous curiosity that now lads towards valuable and enriching environments.

This is a story that illustrates the core thesis of structural change: same trait, different function.

Learning Objectives

By the end of this talk, attendees should:

- Participants will gain insight into how personal narratives can illustrate theoretical models such as the ICD-11 and DSM-5 Alternative Model for Personality Disorders, deepening empathy and understanding in assessment and treatment contexts.
- Participants will learn how the same core traits can serve both protective and self-destructive functions depending on underlying personality organization.



Åse-Line Baltzersen is an advocate for dimensional and person-centered understandings of personality and personality disorder, and for improving access to effective, compassionate care. With a professional background in communication and knowledge translation, she works to bridge scientific insight, clinical language, and lived experience, effectively translating research and theory into accessible and meaningful understanding for patients, carers, and clinicians alike.

Baltzersen holds a bachelor's degree in Public Relations and Market Communication from BI Norwegian Business School and a master's degree in Interdisciplinary Health

Research from Oslo University Hospital.

She serves as Head of Communications for the Norwegian National Advisory Unit on Substance Use, Severe Concurrent Mental Health Disorders, and Personality Disorders (NRAPP), and is President of Personlighetsalliansen (The Personality Alliance), a national organization promoting collaboration between research, clinical services, and lived experience to improve awareness, reduce stigma, and strengthen care.

Her work focuses on how communication and narrative can translate knowledge into understanding, empathy, and change.

Awards

The Society is dedicated to the development of methods of personality assessment, the advancement of research on their effectiveness, and the exchange of ideas about the theory and practice of assessment.

Bruno Klopfer and a group of his students founded the Society for Personality Assessment (SPA) in Essex County, New Jersey. The Society is a collegial organization dedicated to the advancement of professional personality assessment, to the development of procedures and concepts for personality assessment and to the ethical and responsible use of these techniques.

Initially incorporated as the Rorschach Institute, Inc., in 1938, the organization was renamed the Society for Personality Assessment in 1971 to reflect the Society's interest in the entire spectrum of issues present in contemporary personality assessment and to focus the Society as a special interest group, concerned with promoting the exchange of ideas and information about personality assessment in research and practice.

The Society organizes and conducts an Annual Convention as partial fulfillment of the incorporator's objective "to provide an annual assembly of sharing research findings and clinical experiences". In addition, the Society publishes the Journal of Personality Assessment and a newsletter, the SPA Exchange. The following awards are presented by the Society:

The **BRUNO KLOPFER MEMORIAL AWARD** is given for outstanding, long-term professional contribution to the field of personality assessment. The recipient gives an acceptance presentation.

The **JOHN E. EXNER SCHOLAR AWARD** honors the memory of John E. Exner, Ph.D., a pioneer in personality assessment, by supporting the research of a young personality assessor. Dr. Exner was committed to advancing the science of personality assessment by empirical research in the development and application of assessment instruments. This award honors that commitment by recognizing and supporting a young investigator examining any method of personality assessment.

The **JOHN R. GRAHAM AWARD FOR DISTINGUISHED MENTORSHIP IN PERSONALITY ASSESSMENT** is given to individuals who have fostered excellence in the field of personality assessment by their mentorship of students and junior colleagues. Excellence in mentorship is reflected in the quantity of their mentees, its direct impact on their careers, including the quality of their accomplishments in personality assessment. The mentor's influence on the next generation may be evident through training programs, research supervision, and/or clinical training.

The **SAMUEL J. and ANNE G. BECK AWARD** is given for outstanding early career research in the field of personality assessment. The award is presented in conjunction with the University of Chicago. The recipient gives an acceptance presentation.

The **SPA MID-CAREER SCHOLAR AWARD** is bestowed annually for outstanding mid-career impact and scholarship in the field of personality assessment. The award honors scholars who are 15-25 years beyond their graduate degree and whose work has contributed substantially to the body of knowledge to the field of personality assessment and psychological test development.

The **WALTER G. KLOPFER AWARD** is bestowed annually by the Society for Personality Assessment for distinguished contribution to the literature in personality assessment. Eligible contributions focus on statistically based research

projects. The Journal for Personality Assessment Editor invites all Consulting Editors to nominate outstanding articles from the previous year, each of which is then rated by the Editor and Associate Editors. In the event of a tie, two awards may be given.

The **MARTIN MAYMAN AWARD** is bestowed annually by the Society for Personality Assessment for a distinguished contribution to the literature in personality assessment. Eligible contributions may consist of an outstanding case study, qualitative research project, or theoretical development. The JPA Editor invites all Consulting Editors to nominate outstanding articles from the previous year, each of which is then rated by the Editor and Associate Editors. In the event of a tie, two awards may be given.

The **MARGUERITE R. HERTZ MEMORIAL** is a tribute to Dr. Hertz for her long-term professional contributions to personality assessment. The memorial is presented by a distinguished member of the Society in honor of a deceased eminence from the field of personality assessment. At times, the presenter also invites other members to join in relating anecdotes of their personal contact with the honoree.

The **MARY S. CERNEY STUDENT AWARD** is awarded to the best personality assessment research paper submitted by a student. This award carries a small stipend to help defray the cost of attending the Annual Convention.

The **DISTINGUISHED SERVICE AND CONTRIBUTION TO PERSONALITY ASSESSMENT AWARD** honors individuals promoting personality assessment through excellence in teaching, outreach, advocacy, or practice. Recipients are those whose work has made a meaningful contribution to the practice of personality assessment by way of direct service, policy development and implementation, innovation, teaching, training, professional publications, leadership, or advocacy for the profession.

He teaches courses in clinical psychology, personality theory, psychological testing, and the history of modern psychology. He is also a licensed psychologist in Pennsylvania since 1997, currently offering assessment and consultative services in reproductive medicine.

Kurtz has been a member of the Society for Personality Assessment since 1991. He was Associate Editor of the Journal of Personality Assessment (JPA) from 2006 to 2013, and he has served on the editorial boards of JPA, Assessment, and Psychological Injury and Law.

Kurtz attended the University of California at Berkeley, graduating with Honors in Psychology in 1987. At Berkeley, he worked with and was influenced by Harrison Gough and Bill Meredith. Following undergraduate studies, Kurtz was a research assistant in the Social Ecology Laboratory at Stanford University School of Medicine, where he was mentored by Rudolf Moos. At Stanford, he assisted with the development of clinical assessment instruments for a project examining alcohol use in older adults. He obtained his Ph.D. in clinical psychology at Vanderbilt University in 1994. At Vanderbilt, Kurtz was mentored by Leslie Morey and completed dissertation research on judgment biases and memory disturbances associated with borderline personality disorder. He also assisted with the construction, standardization, and initial validation studies of the Personality Assessment Inventory (PAI). Kurtz completed a clinical internship at the Department of Veterans Affairs and University of Michigan Medical Centers in Ann Arbor, Michigan. He was awarded a research training fellowship in rehabilitation research from the National Institutes of Health. The fellowship

years allowed him to study personality factors in recovery and personality change following traumatic brain injury, collaborating with Steven Putnam at Wayne State University School of Medicine.

Dr. Kurtz's research program has pursued diverse topics related to individual differences and problems of psychological assessment. He has conducted studies of the PAI, such as its utility in cases of traumatic brain injury and the validation of techniques designed to detect concealed psychopathology in selection contexts. He is also interested in alternative approaches to personality assessment, such as the advantages of using informant raters and the predictive validity of sentence completion and narrative techniques. Dr. Kurtz has an ongoing interest in stability and change in trait expression and the course of personality development during the young adult years.



John E. Exner Scholar Award

Dr. Tiffany D. Russell

Dr. Russell graduated from the University of North Dakota, and she returned to her alma mater as an Assistant Professor in 2023. She is the director of the Violence, Identity, and Personality Lab (VIP Lab) at UND. Dr. Russell's research centers around dimensional conceptualizations of maladaptive personality traits, externalizing behaviors, and forensic assessment. She has a secondary line of research focusing on LGBTQIA+ mental health and treatment outcomes, as well as intimate partner violence

and personality pathology in LGBTQIA+ people. Dr. Russell also has a small private forensic practice where she specializes in family law cases and risk assessments.



John R. Graham Award for Distinguished Mentorship in Personality Assessment

Dr. Stephen Finn

Stephen Finn discovered his love of teaching and mentoring in high school, when he tutored others in math and Spanish for their New York State Regents exams. After completing his undergraduate degree, he spent a year at the University of Göttingen in Germany helping to teach statistics to psychology students. Eager to make statistics

engaging, he developed creative ways to bring the subject to life and was gratified when an unusually high number of students passed the national exam. During his Ph.D. training, Finn received outstanding supervision in psychological assessment from mentors Auke Tellegen, Ada Hegion, and Ken Hampton—an experience that deeply shaped his own approach to mentoring. As a faculty member at the University of Texas, he guided students in research, psychological assessment, and psychotherapy, and led assessment supervision groups for clinicians in the Austin community. In 1993, Finn founded the Center for Therapeutic Assessment, through which he has since taught thousands of psychologists worldwide about personality assessment and Therapeutic Assessment. His enduring goal has been to show how personality tests can serve as empathy magnifiers—tools to help clients understand themselves more fully and heal from shame. Many of the clinicians he has mentored now hold prominent academic or clinical positions and credit his influence as formative in their professional development.



Samuel J. and Anne G. Beck Early Career Award

Dr. Hilary DeShong

Dr. DeShong is a tenured Associate Professor and licensed clinical psychologist in the state of Mississippi. She currently works in the Department of Psychology at Mississippi State University where she has been for 8.5 years. She will be joining the Department of Psychology at West Virginia University in January 2026 and taking on the role of Director of Clinical Training in July. Prior to joining MSU, she completed her

APA-accredited predoctoral internship at the Ann Arbor Healthcare VA system and graduated from Oklahoma State University in 2017 with her doctorate degree in clinical psychology, working under the mentorship of Dr. Stephanie Mullins-Sweatt. Prior to OSU, she earned a master's in psychology from Villanova University in 2011 under the mentorship of Dr. John Kurtz. Her research focuses on personality traits and personality pathology in relation to overall well-being and general functioning. Her research cuts across several areas of cutting-edge methodologies, with focuses on personality pathology measurement tools, personality and health variables to improve person-centered treatments, the role of personality in relation to other psychopathology, and the underlying mechanisms of transdiagnostic factors such as emotion dysregulation.



SPA Mid-Career Scholar Award

Dr. Nicole M. Cain

Dr. Nicole M. Cain is Chair and Associate Professor in the Department of Clinical Psychology in the Graduate School of Applied and Professional Psychology at Rutgers University. She earned her doctorate in clinical psychology from The Pennsylvania State University and completed a postdoctoral fellowship at New York-Presbyterian Hospital/Weill Cornell Medical College with the Personality Disorders Institute. Dr. Cain currently serves as President-Elect of the Society for Personality Assessment and will

assume the presidency in January 2026. She previously served as Associate Editor for both the Journal of Personality Assessment and Assessment, and is a Past President of the Society for Interpersonal Theory and Research. Dr. Cain's research advances understanding of how personality and interpersonal processes shape psychopathology, treatment response, and maladaptive outcomes such as suicidal behavior. Her current NIMH-funded research employs ecological momentary assessment methods to elucidate how social disconnection contributes to suicide risk across the lifespan, with the goal of informing targeted interventions and prevention strategies.



Walter G. Klopfer Award- Understanding Alpha and Beta Sources of Common Variance: Theoretical Underpinning and a Practical Example

Dr. Steven Reise

Steve Reise, Ph.D., is a Professor of Psychology at UCLA in Quantitative Psychology (retired). His main line of research has been the application of item response theory (IRT) models to personality, psychopathology and health outcomes measures. He is also known for co-authoring a leading textbook in this area

(Embretson & Reise, 2026). In recent years, his research has centered on bifactor models (Reise, Mansolf, & Haviland, 2023) and projective IRT (Reise et al., 2025), as ways of modeling and judging the effects of multidimensionality on unidimensional model applications.



Dr. Mark Haviland

Mark G. Haviland, Ph.D., is an Emeritus Professor of Psychiatry at the Loma Linda University School of Medicine, where he was director of research for 30 years. His research interests include alexithymia and its assessment, as well as psychometrics. With Dr. Reise, he has co-authored several well-cited articles and chapters on item response theory (IRT) and bifactor model applications. Their most recent publications are on projective IRT and log-logistic and nominal response modeling. Dr. Haviland is retired and living in Portland, Oregon.



Martin Mayman Award - Personality Functioning, Problems in Living, and Personality Traits

Dr. Christopher Hopwood

Christopher J. Hopwood, Ph.D., is a professor of personality psychology at the University of Zurich. He received his Ph.D. from Texas A&M University and completed his doctoral internship at Harvard Medical School/Massachusetts General Hospital. He was formally on the faculty of Michigan State University and the University of California, Davis. He has published on clinical assessment, personality disorders, interpersonal processes, sustainability, and vegan psychology. His work has been funded by the National Institutes of Mental Health, the National Institutes of Drug Abuse, the International Psychoanalytic Association, Animal Charity Evaluators, and the Humboldt Foundation. He is the Editor-in-Chief of *Psychology of Human-Animal Intergroup Relations*, has been an Associate Editor at the *Journal of Personality and Social Psychology*, *Journal of Personality Assessment*, *Journal of Personality Disorders*, and *Assessment*, and serves on the editorial boards of several other journals. He has also served on the professional boards of the Society for Interpersonal Theory and Research, Society for Personality Assessment, and North American Society for the Study of Personality Disorders, and is a founding member of the Personality Change Consortium and the Society for the Psychology of Human-Animal Intergroup Relations.



Mary C. Cerney Student Paper Award- Examining Suicidal Ideation Disclosures to Mental Health Professionals

Dr. Taylor Rodriguez

Dr. Rodriguez is an Assistant Professor in the Department of Psychology at the University of Mississippi. She received her PhD in Clinical Psychology from Rutgers University under the mentorship of Dr. Joye Anestis, and joined the Ole Miss faculty in

the fall of 2025. Dr. Rodriguez's research examines how individual differences, including personality traits assessed via tools like the MMPI-3, relate to perceptions of and engagement with mental healthcare. She is particularly interested in using these insights to understand and improve treatment utilization and engagement among high-risk populations.



Distinguished Service and Contribution to Personality Assessment Award

Dr. Anthony D. Bram

Anthony D. Bram, PhD, ABPA, FABP is a psychologist and psychoanalyst in private practice in Lexington, MA, where he conducts psychological testing, psychodynamic and cognitive-behavioral therapy, and psychoanalysis with children and adults.

Dr. Bram is a part-time Lecturer in Psychology in the Department of Psychiatry at

Cambridge Health Alliance/Harvard Medical School and is on the faculty of the Boston Psychoanalytic Society and Institute where he is co-director of Child Psychoanalytic training. He received his doctorate from the University of Kansas and is a graduate of the Post-Doctoral training program at the Menninger Clinic in Topeka, Kansas where he was subsequently a Staff Psychologist. Dr. Bram completed adult psychoanalytic training at the Greater Kansas City Psychoanalytic Institute, and child analytic training from the Boston Psychoanalytic Society and Institute. Dr. Bram is a board-certified diplomate in Assessment Psychology and in Child/ Adolescent Psychoanalysis, and he has been a recipient of a Fellowship from the American Psychoanalytic Association, the Martin Mayman Award (two times) from the Society for Personality Assessment, Scientific Writing Award from the Menninger Clinic, and the Johanna Tabin Book Proposal Prize from Division 39 of the American Psychological Association, and the Philip Erdberg Teaching and Mentorship Award from the Rorschach Performance Assessment System (R-PAS). Dr. Bram's book Psychological Assessment of Emotional Dysregulation in Children and Adolescents: The Bipolar Spectrum and Beyond was published in 2025 by APA Books. His previous book Psychological Testing that Matters: Creating a Road Map for Effective Treatment was published by APA Books in 2014 and was translated into Japanese in 2025. He also co-edited the book Psychoanalytic Assessment Applications in Different Settings published by Routledge in 2021.
