Archives Management in Museums Session Review

This year's TAM conference was another truly wonderful experience, full of fellowship, museums, food and most importantly, great sessions. I was heartened to see so many good collection/exhibit sessions offered this year, and I was especially glad to see a session covering Archives Management. Almost every museum has archival material in some form or another, but the care and management of these collections seems to be a bit of a mystery to most museum curators, as demonstrated by the large number of attendees to the Archives Management in Museums: Goals and Gray Areas session at TAM.

The two presenters, Sammie Morris and

Lorraine Stuart, were excellent speakers who gave us wonderful hand-outs to take home. They covered the basics of archival management from setting up and organizing archives for your institution from scratch all the way to giving out the names of some granting agencies and foundations for funding archival projects. Ms. Morris's and Ms. Stuart's knowledge of archives was impressive, and they were generous in sharing their expertise with the audience through power point presentations, photographs and in answering our many questions. This session was definitely worth going to, and if you missed it, I would highly recommend the tape!

Environmental Monitoring Kits

The Environmental Monitoring Kit program addresses the conservation needs of small museums by giving them the ability to monitor their gallery and storage environments. By sharing equipment and training resources, small museums will have access to important equipment and valuable training at a very low cost. Check out a TAM Environmental Monitoring Kit from the regional kit

CMC MINUTES

Annual Business Meeting Houston, Texas March 27, 2003

WELCOME AND CALL TO ORDER

Megan Bryant called the meeting to order at 5:15 p.m. and welcomed new and returning Megan thanked Jeff members. BUSINESS REPORTS TO THE MEMBERSHIP

Secretary's Report

The Chair directed everyone's attention to the minutes for the Annual Business Meeting for 2002 and called for a motion to accept the minutes as presented. Betty Edmundson and Milly Walker so moved, and the minutes were approved.

Treasurer's Report

Chair The recognized Rebecca Huffstutler, Treasurer. Rebecca distributed a current treasurer's report showing a balance of \$749.45 as of March 26, 2003. The Committee began the year with a balance of \$1,702.63 and subsequently earned \$641.23 from memberships, donations and programming. supported \$555.00 Funds membership scholarships to Annual Meeting and attend \$1,000.00 underwriting of the pre-conference workshop, Managing the Collection Environment. Megan called for a motion to accept the Treasurer's report as presented. Betty Edmundson and Lisa Rebori so moved; the report was approved.

Workshops Review

The Chair asked Milly Walker, Vice-Chair, to review workshops for the past year. Milly provided a full report on four workshops in 2002, Handling. including Textiles: Storage, Care, Exhibition, Monitoring at the Museum of Fine Arts. Houston and Houston Museum Natural Science. Photodocumenting Your Collection at the Frontiers of Flight Museum, Galveston: Critters in Your Collection: the Ins and Outs of Pest Control at the Dallas Museum of Natural History, Dallas; and Picking Conservators Appraisers. Insurance at The Witte Museum, San Antonio. Megan called for a motion to accept the report as presented. Betty Edmondson and Kandy Taylor-Hille so moved; the report was approved.

Editor's Report

Megan recognized Jennifer Cook, Officer-at-Large and Editor, thanking her for working so hard on the newsletter during the past year. Jennifer noted the upcoming deadline for Newsletter submissions is April 20, 2003.

Chair's Report

Megan called on Kandy Taylor-Hille. Kandy asked the membership to participate in a moment of silence in memory of the extraordinary contributions of Reba Jones. Reba worked at the Amarillo Museum of Art for many years and was a staunch supporter of both the Registrar's Committee and the Collection Managers Committee. A

contribution to the Amarillo Museum of Art was made by the CMC in Reba's name.

Megan then reviewed the year for members and discussed membership benefits, including scholarships to the Annual Meeting. Megan introduced scholarship recipients for 2003: Amy Hooker of the Petroleum Museum, Anita Bryant of the Dublin Dr. Pepper Bottling Company Museum, and Patsy Burris of Varner-Hogg State Historic Site.

Megan thanked Kandy for sharing her facility for the Board's retreat. Megan discussed ideas which were presented at the retreat including the new resource table. Megan reminded members that need to renew their memberships to stop by the table. She reiterated that the table signs were provided by Oxbow Consulting. Thanks to Bruce!

Megan presented the slate of new officers for 2003-2005 terms: Vice-Chair: Carolyn Spears, Stone Fort Museum; Secretary, Catherine Campbell, Moody Mansion Museum; Officer-at-Large: Editor: Jennifer Cook, Mary Kay Museum.

NEW BUSINESS

Megan reminded everyone to submit ideas for sessions at the 2004 Annual Meeting in Waco. All members should consider proposing sessions to not only the CMC workshop schedule, but also to the TAM Program Committee. Upcoming workshops for CMC include: June 9th, Fake Food at McFaddin Ware House Museum in Beaumont; October 20, Care & Preservation of Photographic Collections at the Amon Carter Museum in Fort Worth, January 26; and Collection Managers Beware! Bad Stuff! At the Corpus Christi Museum of Science & History.

The Chair recognized Carolyn Spears who asked how many of the members had attended the Mold Session at TAM. A majority of members had attended the session. Carolyn discussed

the overall review of the session as good but attendees wanted more information that dealt directly with mold on collections. Carolyn explained environmental that concerns and health issues had to come first when there was only an hour available. However, Carolyn presented the possibility of making the January 2004 workshop a full day workshop on mold The membership collections. wholeheartedly agreed. Carolyn also asked for a show of hands on those interested in a workshop on EAD (encoded archival description) and a 2-day workshop on collection databases. A majority would like to know more about EAD and its uses. and also want a repeat of the database workshop held at Winedale several years ago.

Megan shared her recent correspondence with Toby Cunningham of the newly reformed Oklahoma Registrars' Association (OKRA). The group is interested in working jointly on a future workshop. Kim Cupit of Courthouse-on-the-Square Museum in Denton agreed to help with any joint workshop, and Mary Kirby suggested involving the Northeast Texas Museum Association.

Megan called for the membership to share news and successes of the past year. There were lots of successes and calls for involvement. Megan asked the membership to send in news to Jennifer throughout the year to keep each other updated on events.

Megan called for any additions to new business or a motion to adjourn the meeting. Milly Walker and Betty Edmondson so moved. Meeting adjourned at 6:05 pm.

MEMBER SPOTLIGHT

I have wanted to work in an art museum for as long as I can remember. As a child, I loved E. L. Konigsburg's novel in which two children ran away from home to live in the Metropolitan Museum of Art. I took my first art history class in seventh grade. My early interest in museums led me to volunteer at both the Witte Museum (working with Mimi

Quintanilla) and, portentously, the McNay Art Museum just after high school in San Antonio.

attended Duke University where I was an

art history major. As important as my studies were at Duke was the wonderful experience I had working at the Duke University Museum of Art as a curatorial assistant. I participated in every aspect of museum operations since the staff was quite small and everyone had to chip in to get things done. (Some things never change!) In my second year at Duke, I received a curatorial internship at the Whitney Museum of American Art, a much larger museum where departments and duties were more narrowly defined. At the Whitney, I began to realize that registrars actually did all of the nuts and bolts work of putting exhibitions together and managing collections.

After earning my B.A., I returned to New York and worked at Hirschl and Adler Modern Gallery. I soon realized, however, that I wanted to return home to Texas. I accepted an internship at the San Antonio Museum of Art where I worked with the

contemporary curator, Jim Edwards, on a number of important exhibitions. My career took a short detour after that internship ended, and I worked as a retail manager and waited for another museum position to open up. My patience paid off when I was hired to be the Collections Management Assistant at the McNay Art Museum in 1992. I was promoted to Collections

Manager later that year.

I have now been at the McNay for ten years. I have watched both the collection and the facility grow. During my

tenure, nearly 3,000 works of art

have been added to the collection, and our physical plant has undergone major changes, including the construction of a new auditorium. Most recently, I survived a major remodeling of the original McNay residence, a project which updated the museum's HVAC system and renovated some of the oldest exhibition spaces.

At the McNay, I have had the opportunity to work on over 120 exhibitions of varying scale and scope. I have learned a great deal, met many of my colleagues, and traveled near and far. The Collections Managers Committee has been a particular source of support in my career at the museum, offering information, useful contacts, and camaraderie. I look forward to many exciting projects here at the McNay in the future and to seeing everyone at our next meeting.




