Karen Anderson is the new registrar at the Panhandle-Plains Historical Museum replacing Brenda Haes. She will be spearheading the computerization of collections.


Terry Grose has completed her doctorate and accepted the position as Collection Manager at Baylor's Strecker Museum in Waco -- and we thought we were busy this year.

#### Pre-Conference Workshop

CMC is working with TAM to host the 1994 pre-conference workshop, *Planning and Preparedness*, at the TAM Annual Meeting in Houston. It is scheduled for Wednesday, March 16, 1994 from 8:30 am to 4:30 pm, at the Wyndham Warwick Hotel. Lunch and coffee breaks will be included for all participants. The workshop will be conducted by Dr. David B. Gracy, Gov. Bill Daniel Professor in Archival Enterprise, Graduate School of Library and Information Science, University of Texas at Austin, and Priscilla (Pat) Terry, Disaster Preparedness Coordinator, Office of Risk Management, Smithsonian Institution. The session will be interactive, and will cover the following topics: overview of disaster types; vulnerability assessment and rick management; preparation of a disaster plan; and training and networks.

Participants in the workshop will receive TAM's Ad Hoc Committee's manual on Disaster Preparedness/Recovery, *PREP: Texans Planning for Response & Emergency Preparedness.*Over 300 pages in length, the manual is contained in a looseleaf binder with tabbed sections for quick reference, allowing institutions to add material specific to their own needs.
