The Environmental Kits are now with the Kit Keepers in each region. Each kit contains an RH/ temperature data logger, a UV meter, a light meter, fade cards, sticky tape AND INSTRUMENTS. Review of Previous CMC & TAM Workshops

TAM Conservation Roundtable, Dallas, November 14, 1998 by Kathy Roland, Curator of Collections, Fort Concho, San Angelo


The moderator of the roundtable was Julie A. Reilly of the Gerald R. Ford Conservation Center, Omaha, Nebraska. Speakers were Walt Davis, Director of the Panhandle-Plains Historical Museum, Canyon; Tom Clareson, Preservation Service Manager of AMIGOS, Bibliographic Council, Inc. Dallas; Anne Zanikos, Conservator of Paintings, Sculpture and Wooden Artifacts, San Antonio; and Karen Motylewski, Director and Senior Lecturer, Graduate School of Library and Information Sciences, University of Austin.

The topic of objects conservation was well addressed through the roundtable conversation. Several serious problems concerning museum object conservation were brought up. It was most interesting that many of the professionals attending the roundtable did not know where to find the kind of conservator they need that are available in the Texas area. It was also apparent that the assessment of conditions of the objects in collections is a priority. One solution is to hire a conservator to provide a conservation survey. Of course, a major problem is the lack of funding to provide conservation for museum collections. One answer brought up was to market preservation needs to corporations and museum board members, so that resources can be reallocated towards the preservation of collection objects.

Crossing the Lines: The Ins and Outs of International, Interstate & Intrastate Shipping Monday, September 14, 1998 Bush Airport, Houston, Texas Sponsored by the TAM Collection Managers Committee

What did I learn from this workshop? **Seek Professional Help!** Although the title of the workshop covered the spectrum of shipping, all four speakers concentrated mainly on international shipping. Shipping objects, especially those coming through U.S. Customs, can be a complex task. Barbara Chambless, Import Specialist with U.S. Customs in Houston highlighted many of the regulations that are required under United States law. Her best advice was to allow plenty of lead time, make sure you have an accurate, detailed description and value of the object that is going through customs, ask questions, and have patience. The next speaker was Karen Gore with the U.S. Fish & Wildlife Service. She also gave very detailed information, along with some helpful handouts, on importing animals or objects containing wildlife material. Again, know exactly what you are dealing with and seek out the right professionals to help you through the process.

Custom broker Greg Posey of Posey Air Custom was the first speaker in the afternoon. He explained what services are offered by custom brokers and how they can help the customs process go more smoothly. He again reiterated the need to have detailed information and to work with professionals that have experience in the field. The final speaker of the day was Sheryl Nakano of Fortress/Fine Arts Express. Sheryl discussed security when shipping, things to consider when figuring the cost of a shipment, and the use of couriers. She provided some very helpful handouts. Although I felt that the workshop was geared toward larger institutions I did glean some valuable information. Staff in smaller institutions should contact colleagues that do this on a regular basis and find out businesses and services they would recommend. In the end it is always worth your time to seek professional help!

Building a Policy and Procedure Manual for Your Collection
Monday, November 2, 1998 Museum of East Texas, Lufkin
1998 TAM Workshop co-sponsored by the TAM Collection Managers Committee
and the Southeast Texas Museum Association

The excellent turn-out for this workshop (30+) said to me that the basics never go out of style and there is always a need to emphasize the fundamentals. The morning began with Briget Jones, Director of the Sam Rayburn House in Bonham providing general information of how to set about writing a policy. She warned that there was no cookie cutter policy, but emphasized that the document should reflect the institution. The mission statement is very important and once the policy and its contents were agreed upon it should be approved by the governing body. Policy is why; procedure is how. The next speaker, Jim McCrain, Collections Manager for the Dallas Museum of Natural History, went into greater detail of what needed to be included, especially in the procedures manual. He also noted that no policy or procedure manual is worth anything if it is not followed. The reason policy and procedures are written is to protect the objects so trustees and all levels of staff and volunteers should be familiar with them.

The first speaker of the afternoon, Catherine Hastedt, Curator of the J. Wayne Stark University Center Galleries in College Station gave various technical information on care of collections. Although this seemed more of a sidebar to the topic, she did reaffirm information provided in the environmental monitoring workshop. The big finish was Ellie Caston of the Baylor Museum Studies program who as usual brought us all back to reality with comments on what really happens "out there," a policy and procedures manual not withstanding. The many varied hand-outs and opportunities to share information made this an excellent workshop that I hope is repeated in other parts of the state.

1999 CMC Travel Stipend Application Guidelines

The Collection Managers Committee of the Texas Association of Museums (CMC of TAM) is sponsoring an annual meeting travel stipend made possible through the support of CMC by workshop attendees and members. This stipend will assist collection managers in attending the **Texas Association of Museums (TAM) Annual Meeting in Fort Worth, March 24-27, 1999.** The stipend award is not automatic, and may be withheld if there are no qualified applicants.

Applications for this stipend must be current voting members of the CMC, who reside in the United States. (CMC membership information may be obtained from Sally Baulch-Rhoden at 512.471.1604.) Eligible to apply are registrars, associate and assistant registrars, collection managers, and museum staff members whose work is registrarial in nature. Each award winner will receive money to defray the costs associated with attending the TAM annual meeting. In return, each recipient will be required to provide a report on one or two of the TAM sessions for the CMC Newsletter.

Selection of the stipend recipients will be made by the CMC Board on the basis of the applicants' demonstrated merit and financial need. Demonstrated merit includes, but is not limited to, such activities as participating in professional museum organizations at the state, regional, or national level: presenting sessions at meetings of professional organizations; and publishing articles in professional journals.

To apply for the stipend, complete the form on the reverse and submit along with the following:

- 1. Cover letter
- 2. Resume
- 3. A letter of recommendation from your immediate supervisor.

Applications must be received by **February 15, 1999**. Faxed application materials are acceptable, but be sure to mail original. Send application materials to:
