PAINTINGS: Framing, Storage, and Handling Perry Houston and Associates/FortressFAE Fort Worth, Texas

Helen Houp, Paintings Conservator with Perry Houston and Associates in Fort Worth, will lead us through a day filled with information about proper FRAMING, STORAGE and HANDLING of PAINTINGS. She will show us how to correctly unframe a painting, pad a rabbet, install a protective backing and hanging hardware. Additionally, she will review encapsulation techniques for labels now removed from the old backing, how to use raking light for condition reports, and how to document condition through photography. Also Rick Floyd, General Manager of the Fort Worth branch of FortressFAE (formerly Fine Arts Express), will give a tour of their facility, including the vault, and tell about their operations.

We all have file folders full of technical reports. Some stand the test of time. Some are proof of how much the profession has changed its techniques over the last few decades. The World Wide Web houses many new editions of the tried and true standards like:

• Conserve O Grams from the National Park Service are located at (http://www.cr.nps.gov/csd/publications/conserveogram/cons_toc.html)

Some new favorites of mine are:

- Preservation Fact Sheets from the Henry Ford Museum and Greenfield Village Conservation Department (http://www.hfmgv.org/histories/cis/pfs.html). All of the fact sheets are worded for the layperson. I've printed a few out and sent to people who have written to me for information on how to care for artifacts.
- The Archives of the Museum-L Discussion List

 (http://home.ease.lsoft.com/archives/museum-l.html) are searchable by topic (so for example you can find out if the list has recommendations on using computer databases).

For Disaster Preparedness, try:

 The Task Force on Emergency Response both outlines steps you can take if disaster hits as well as listing links to other disaster agencies. (http://www.heritagepresevation.org/PROGRAMS/taskfer.html).

Other professional committees also have presence like:

- The AAM Registrar's Committee Rights and Reproductions Information Network has a thoroughly researched (of course) site located at (http://www.panix.com/~squigle/rarin/01rcsite.html).
- You can search Conservation OnLine (CoOL) for guidelines, topics covered in their discussion list, or for links to specific people & disciplines (http://palimpsest.stanford.edu/).
- For very thorough archival information try the *Northeast Document Conservation Center* (http://www.nedcc.org/). Many of the topics discussed for the preservation of paper translates to specimen and objects preservation (and which of us doesn't have any paper in the building?).

Of course I'm not mentioning my favorite field related sites (like the searchable *Handbook of Texas OnLine*), but we all could probably fill a book with such sites.

Marking Workshop Review by Milly Walker

On October 4, 1999 a group of twenty participants gathered at the Washington-on-the-Brazos State Historical Park for a workshop on marking objects. Star of the Republic Museum sponsored the event. Speakers were Sally Baulch-Rhoden of Texas Memorial Museum, Lisa Rebori of the Houston Museum of Natural Sciences, and Milly Walker of Dr. Pepper Museum. Workshop Coordinator was Kandy Taylor-Hille of the Sebastapol State Historical Park. Each participant received a notebook of information including articles, resources, supplies and how-tos. They also received a kit containing supplies and sample materials for practice.

Milly Walker gave an overview of the problems and some solutions to marking general historical objects. Lisa Rebori then discussed the methods of marking natural history specimens. Sally Baulch-Rhoden followed with a discussion of problems and mislabeled items. Then participants opened their kits and began a hands-on workshop on barrier coats and actual marking.

The lunch break was participated in fully by all attendees! The box lunches were delicious. Attendees were treated to a tour of the Barrington Farm following lunch. This living history farm will provide an additional experience for park visitors when it is opened to the public in the spring of 2000.

After the lunch break, Sally Baulch-Rhoden gave a session on sewn and Japanese Tissue Labels. Lisa Rebori followed this with a discussion of transponders and bar codes. A general question and answer session wrapped up the workshop.

To close the day, Houston McGaugh and Sherry Humphries led a tour to the Star of the Republic Museum which is undergoing renovation and is currently closed to the public.

Labeling Recommendations For 1999

BARRIER COATS ON OBJECTS: (do not paint labels on most: baskets, leather/skin, plastic, wax, rubber, synthetic rubber, fragile objects like minerals and fossils, soluble composition material, unglazed ceramics)

Acryloid B72 (25% B72 in 75% Acetone)

Warning: May damage painted surfaces and plastic

TM

Soluvar

Warning: Will damage wax, waxed surfaces & plastic

Acryloid B67 (60% B67 in 40% Petroleum Benzene, aka Mineral Spirits)

Warning: Will damage wax, waxed surfaces & plastic

SEWING ON OBJECTS: (stable fabrics)

Cotton Twill Tape

Cotton thread (cotton/polyester for strong weaves)

Fine needle (#8 Quilting or #10 Crewel)

TAGS TIED TO OBJECTS:

Archival Acid-Free Lignin-Free Cardstock (cotton rag)

Tyvek (polypropylene olefin fiber)

ADHERED LABELS ON OBJECTS:

Japanese Tissue (laid paper with long fibers)

Paste: Methyl cellulose

Starch Paste (wheat is best)

DIRECT LABELING ON OBJECTS:

Most Paper:

Pencil (32, HB, F or H)

PC or Glossy Paper:

Stabilo All Pencil

LABELING PLASTICS AND RUBBERS:

If you have to mark on these substances, use a:

Wax Pencil

Stabilo All Pencil

Acrylic-based paint

Use pens with waterproof, pigment based ink. Test to check if ink is light fast.

2000 Travel Stipend Application Guidelines

The Collection Managers Committee of the Texas Association of Museums (CMC of TAM) is sponsoring an annual meeting travel stipend made possible through the support of CMC by workshop attendees and members. This stipend will assist collection managers in attending the **Texas Association of Museums (TAM) Annual Meeting in Austin, April 25-28, 2000.** The stipend award is not automatic, and may be withheld if there are no qualified applicants.

Applications for this stipend must be current voting members of the CMC, who reside in the United States. (CMC membership information may be obtained from Megan Bryant at 214.747.6660). Eligible to apply are registrars, associate and assistant registrars, collection managers, and museum staff members whose work is registrarial in nature. Each award winner will receive money to defray the costs associated with attending the TAM annual meeting. In return, each recipient will be required to provide a report on one or two of the TAM sessions for the CMC Newsletter.

Selection of the stipend recipients will be made by the CMC Board on the basis of the applicants' demonstrated merit and financial need. Demonstrated merit includes, but is not limited to, such activities as participating in professional museum organizations at the state, regional, or national level: presenting sessions at meetings of professional organizations; and publishing articles in professional journals.

To apply for the stipend, complete the form on the reverse and submit along with the following:

- 1. Cover letter
- 2. Resume
- 3. A letter of recommendation from your immediate supervisor.

Applications must be received by February 15, 2000. Faxed application materials are accepted, but be sure to mail original. Send application materials to:

TAM Pre-Conference Workshop on Legal Issues "Museum Law 101" April 25, 2000, 9:00 am - 4:30 pm Austin, Texas

In the light of the high levels of interest evidenced in issues involving the law at the 1999 TAM Annual Meeting, this workshop will seek to present fundamental information about the U.S. legal system and one of its most basic tools - the contract. These two sessions offered consecutively will provide attendees with a basic understanding of the legal framework. Afternoon sessions will delve into overviews of more specific areas of concern to museums: collections and deaccessioning, gifts, intellectual property and torts. The information presented in this full-day workshop is applicable for museums of all types and sizes, directors, financial officers, collection managers and registrars, seasoned staff as well as those just entering the museum profession.

Scheduled sessions include the following:

Title:

Workshop Introduction and Overview

Chair:

Courtney DeAngelis, Assistant Registrar, Amon Carter Museum, Fort Worth, Texas

The introductory presentations will be made in two consecutive lectures providing basic information and serving as the groundwork for the various more specific areas covered in the afternoon presentations:

The two morning sessions will be presented by Professor Brian F. Havel of DePaul University College of Law, Chicago, Illinois.

Title:

Introduction to the Legal System

This session will present a basic outline of how the U.S. legal system of civil courts functions, included will be a discussion of the State and Federal systems, and the life of a case in civil proceeding.

Title:

Introduction to Contracts

A contract is a binding promise or agreement, the basis of getting things done... In this introductory session attendees will learn what goes into a contract and the different types of contracts. Included will be a discussion of legal advice: when, where, and how to get it.

Title:

Collections and Deaccessioning

Speaker:

David Sokolow, University of Texas

Law School, Austin, Texas

This session will cover the basics of donations to museums and the legal implications of such donations. The legal issues of deaccessioning will also be discussed.

The last two sessions will be presented by Marilyn Phalen of Texas Tech University School of Law, Lubbock, Texas.

Title: Intellectual Property


This session will attempt to dispel some of the confusion museums face relating to intellectual property rights. Issues addressed will include: how to determine who holds the rights to materials in the museum's collections; identifying what the laws are and when they apply; the concepts of fair use, public domain and works for hire; the type of rights, compensation and duration to be considered when licensing use of copyrighted materials; and new considerations brought about by the Internet and rapid advances in technology.

and

Title: Torts and Personal Injury Liability

This session will address the duties and liabilities that arise from a museum's actions (or failure to act) not involving contracts. Such issues as legal duties, negligence, vicarious liability, and defenses will be discussed.
